



Total Number of Doses Number of People with 2 Doses in Number of People with 1 or More





The Federal Pharmacy Partnership for Long-term Care (LTC) Program is a partnership between CDC and CVS, Walgreens, and Managed Health Care Associates, Inc., to offer on-site COVID-19 vaccination services for residents of nursing homes and assisted living facilities. This program is being implemented in close coordination with jurisdictions, long-term care facilities, federal partners, including the Centers for Medicare and Medicaid Services, and professional organizations,


