

Data on doses of vaccine administered on the day of reporting will occur for the Long-term Care (LTC) program coincide with those received by CDC as of 6:00 am ET on the day of reporting. Updates will occur the following day when reporting coincides with a federal holiday.

The **Federal Pharmacy Partnership for Long-term Care (LTC) Program** is a partnership between CDC and CVS, Walgreens, and other partners. This program is being implemented in close coordination with jurisdictions, long-term care facilities, the Federal Pharmacy Association and Leading Age. Jurisdictions had the opportunity to launch the program as early as December 21 for Pfizer-BioNTech vaccine or December 28 for Moderna vaccine. The program provides COVID-19 vaccine to staff and residents in skilled nursing facilities. As of January 4, 2021, a total of 54 jurisdiction facilities started the program. Program start dates varied based on the jurisdiction. As of February 16, 2021, a total of 1,541 facilities have started the program. Program start dates varied based on the jurisdiction. As of February 16, 2021, LTC LTC doses represent 13,451 skilled nursing facilities (Part A) and 44,306 assisted living and 20,957 skilled nursing facilities (Part B).Pharmacy partners report to CDC on doses administered as part of the **Federal Pharmacy Partnership for Long-term Care (LTC) Program** within 72 hours of administration.States and territories not participating in the **Federal Pharmacy Partnership for Long-term Care (LTC) Program** are shown on the map in white. These states and territories are implementing their own vaccination plans to reach LTC staff and residents.

Definitions:

Total doses administered are cumulative counts of individual COVID-19 vaccine doses administered to residents and staff in long-term care facilities as reported to CDC by the **Federal Pharmacy Partnership for Long-term Care (LTC) Program**.

People receiving 1 or more doses represent the total number of people who have received at least one dose of vaccine. People receiving 2 doses represent the number of people who have also received a second dose of vaccine.

*The number of people receiving 1 or more doses and the number of people receiving 2 doses were determined based on information reported to CDC by pharmacy partners on dose number, administration date, recipient ID, and date of submission.

A dose number was determined for nearly all reported doses administered but, because there are some missing data for dose number, the sum of people receiving 1 or more doses and people receiving 2 doses will not exactly equal the total doses administered.

Staff and non-resident vaccinations could be categorized as being administered to LTC staff or residents. Overall numbers of doses administered, people receiving 1 or more doses, and people receiving 2 doses include all vaccinations through the program, including those for which staff/resident status was not reported.
