




Total Number of People Receiving One or More Doses Reported to CDC by State/Territory, Federal Pharmacy Partnership for LTC Program

Data on doses of vaccine administered through the Federal Pharmacy Partnership for Long-Term Care (LTC) Program include those received by CDC as of 6:00 am ET on the day of reporting. Updates will occur the following day when reporting coincides with a federal holiday.

The Federal Pharmacy Partnership for Long-term Care (LTC) Program is a partnership between CDC and CVS, Walgreens, and Managed Health Care Associates, Inc., to offer on-site COVID-19 vaccination services to residents and staff in long-term care facilities. This program is being implemented in close coordination with jurisdictions, long-term care facilities, federal partners, including the Centers for Medicare and Medicaid Services, and professional organizations, including the American Health Care Association and LeadingAge. BioNTech had the opportunity to launch the program as early as December 21 for Pfizer-BioNTech to staff and residents in skilled nursing facilities (Part A) and assisted living and other similar facilities (Part B). Launch dates for Part A and Part B varied across jurisdictions. As of January 4, 2021, a total of 54 jurisdictions have started the program. Program start dates varied based on the jurisdiction.
