[†]All patients' records from the outpatient and inpatient settings are screened (automated records review and chart review) for underlying medical conditions which increase the risk of severe COVID-19 illness using ICD-10 codes (<https://www.cdc.gov/coronavirus/2019-ncov/need-extra-precautions/people-with-medical-conditions.html>).

[§]A combination of ICD-10-CM COVID-19 codes and internal medical diagnostics codes were used to identify individuals with a history of COVID-19 illness. Patient records were also screened for positive lab tests for COVID-19 illness prior to receipt of vaccination. The new ICD-10-CM code came in effect April 1st, 2020.
