
#### **CDC Website Features PHEP Trailblazers, Pathfinders, and Champions**

As 2022 draws to a close, CDC extends its appreciation to PHEP recipients for participating in the recognition

of nearly 300 PHEP-funded public health preparedness professionals as part of CDC's commemoration of the PHEP 20th anniversary. A total of 294 PHEP-funded preparedness professionals are highlighted on the CDC website at <a href="PHEP Trailblazers">PHEP Trailblazers</a>, <a href="PHEP Trailblazers">Pathfinders</a>, and 193 PHEP Champions. The website also features <a href="mine trailblazers">nine trailblazers</a> and pathfinders and their preparedness contributions.

During 2022, CDC has recognized the state, local, and territorial public health preparedness workforce and their contributions to the PHEP program over the past two decades. The COVID-19 pandemic put immense pressure on public health preparedness professionals at the forefront of the response, prompting CDC to recognize and celebrate their accomplishments, not just during the pandemic response but in building the PHEP program. CDC invited PHEP directors to submit state and local trailblazers, pathfinders, and champions to represent their jurisdictions.

In April during the 2022 Preparedness Summit held in Atlanta, CDC recognized more than 200 PHEP-funded preparedness professionals initially submitted by the PHEP directors. ## **Emergency Response Activities**

#### **Updated HHS Mpox Vaccination Provider Agreement Now Available**

On December 9, CDC updated the Department of Health and Human Services (HHS) Mpox Vaccination Program Provider Agreement to align with CDC's Mpox Vaccine Interim Clinical Considerations. The HHS Mpox Vaccination Program Provider Agreement is a legally binding agreement between vaccine providers and HHS. The original provider agreement allowed subcutaneous administration only if intradermal administration is contraindicated, which restricted the ability of providers to offer the vaccine subcutaneously. CDC's Mpox Vaccine Interim Clinical Considerations guidance is more permissive than the original provider agreement and indicates that intradermal administration remains the preferred route of administration but should not be a barrier to vaccination.

The update to the provider agreement allows more flexibility for public health jurisdictions and healthcare providers to offer the intradermal or subcutaneous regimen based on balancing optimal vaccine use, patient acceptance, potential stigma from vaccine side effects, feasibility of administration, and available vaccine supply. HHS encourages providers to proactively offer <u>vaccine regimen options</u> to patients, especially to individuals who have questions or concerns about intradermal vaccine side effects such as hyperpigmentation, swelling, or keloid scarring.

#### **December 20 COCA Call Addresses Ebola Evaluation and Infection Prevention**

CDC will conduct a Clinician Outreach and Communication Activity (COCA) call from **2** p.m. to **3** p.m. EST on **Tuesday**, **December 20**. During the call, CDC subject matter experts will discuss signs and symptoms of Ebola, disease progression, importance of alternative diagnoses or treatments, and the utility of a CDC clinical consult. Presenters will also review specimen handling and testing biosafety and infection prevention and control recommendations.

Materials for the call will be available on the <u>COCA Call webpage</u> in the call materials section. The presentation slides will be available the day of the call, and the call recording will be posted a few hours after the live event ends.

# Interim Guidance for Clinicians to Prioritize Antiviral Treatment of Influenza with Reduced Oseltamivir Availability

On December 15, CDC issued a <u>health advisory</u> regarding high seasonal influenza activity across the United States. CDC estimates that in the 2022-2023 season to date there have been at least 13 million illnesses, 120.000 hospitalizations, and 7.300 deaths from influenza, based on



CDC's <u>Weekly U.S. Influenza Surveillance Report</u>. While the <u>Food and Drug Administration</u> (FDA) has not indicated shortages of oseltamivir (generic or Tamiflu) in any of its forms (capsules and oral suspension), CDC has received numerous anecdotal reports of availability issues for generic oseltamivir in some locations. This may continue to occur in some communities as influenza activity continues.

This Health Alert Network (HAN) Health Advisory provides clinicians and public health officials with guidance for prioritizing oseltamivir for treatment. It also offers information on other influenza antiviral drugs that are recommended for treating influenza in areas where oseltamivir is temporarily unavailable.

#### **ASTHO Releases 2023 Public Health Legislative Briefs**

The Association of State and Territorial Health Officials (ASTHO) has identified 10 public health policy issues to watch in 2023 and identified additional legislative trends in its 2023 Legislative Prospectus Series. The

legislative briefs provide an overview of 10 public health policy topics that range from data modernization and privacy to public health agency infrastructure and authority. The briefs anticipate trends in public health law for the next year and provide a short review for public health professionals and legislators alike. For the upcoming 2023 state legislative sessions, ASTHO expects some jurisdictions to address issues related to public health legal authority and the public health workforce. These issues include sustaining recent investments in public health workers, considering professional licensure requirements for public health workers, and determining the process for and scope of public health orders to control the spread of disease.
