

# **COVID-19 vaccine update:**

Bivalent booster authorizations extended to children ages 6 months and older

- December 8, 2022: FDA<sup>1</sup> granted emergency use authorization (EUA) for:
  - Use of Moderna bivalent COVID-19 vaccine booster in children ages 6 months-5 years
  - Use of Pfizer-BioNTech bivalent COVID-19 vaccine as a third primary series dose for children 6 months-4 years of age
- December 9, 2022: CDC<sup>2</sup> expanded the use of updated (bivalent) COVID-19 vaccines for children 6 months through 5 years


