This article in Public Health Reports offers recommendations to improve American Indian and Alaska Native (Al/AN) public health data equity across all governmental public health authorities. Al/AN public health leaders are working to strengthen public health infrastructure and capacity and advance Al/AN data and health equity. The public health community can positively contribute to Al/AN public health data and overall well-being by approaching the work with an understanding of Tribal sovereignty.
