Simple Principal Investigator (PI) Replacement

New APHIS/CDC administrative amendment

• If a PI needs to be removed, eFSAP is able to automatically assign the following to another unrestricted PI:

- all of their approved work objectives
- all of their personnel
- all of their strains and serotypes
- This new feature negates the need to submit Form 1 Section 7A/C technical amendments, as well as Section 4 and 7B administrative changes, if the removed Pl's work objectives, personnel, and strains/serotypes need to be retained
