# Sierra Leone – Western Area Global School Personnel Survey (GSPS)

FACT SHEET . . . . . . . . . . . .

The Sierra Leone-Western Area GSPS includes data on prevalence of cigarette and other tobacco use as well as information on attitudes on school policy toward tobacco use, access to teaching materials and training, and attitudes toward tobacco use. These factors are components Sierra Leone-Western Area could include in a comprehensive tobacco control program.

The Sierra Leone-Western Area GSPS was a school-based survey of school personnel from the schools that participated in the 2008 Sierra Leone-Western Area GYTS.

The GYTS was conducted in schools having students in JSS2, JSS3, SS1, and SS2. For the GYTS, a two-stage cluster sample design was used to produce representative data for all of Sierra Leone-Western Area. At the first stage, schools were selected with probability proportional to enrollment size. At the second stage, classes were randomly selected and all students in selected classes were eligible to participate. The school response rate was 100.0%. For the GSPS, 91.6% of the school personnel completed the survey, for a total of 914 teachers & administrators.

# **Prevalence of Tobacco Use among School Personnel**

36.0% ever smoked cigarettes (Admin = 50.3%, Teachers = 35.0%)

- 12.3% currently use any tobacco product (Admin = 6.8%, Teachers = 12.6%)
- 11.8% currently smoke cigarettes (Admin = 6.2%, Teachers = 12.2%)
- 1.8% currently use other tobacco products (Admin = 1.4%, Teachers = 1.8%)
- 9.9% smoked on school property in the past year (Admin = 14.9%, Teachers = 9.6%)

## **School Policies Prohibiting Tobacco Use**

98.4% agree schools should have policy prohibiting tobacco use among students

84.3% report school has policy prohibiting tobacco use among students

97.5% agree schools should have a policy prohibiting tobacco use among personnel

65.6% report school has a policy prohibiting tobacco use among personnel

90.2% report school enforces policies on tobacco use for students and personnel

# Access to Teaching Materials and Training

32.3% schools include tobacco use prevention in school curriculum

90.8% think teachers need specific training to help students avoid tobacco use

11.7% teachers have access to teaching materials on tobacco use

12.4% teachers had ever received training on youth tobacco use prevention

33.3% schools use non-classroom programs to teach youth tobacco use prevention

#### **Attitudes**

93.8% think smoking should be banned from public places

94.2% think smoke from others is harmful to them

91.6% think teacher tobacco use influences youth tobacco use

83.8% think tobacco product advertising should be completely banned

83.9% think the price of tobacco products should be increased

72.2% think the tobacco industry deliberately encourages youth to use tobacco

## **Highlights**

- 12.3% of school personnel currently use any tobacco product; 11.8% currently smoke cigarettes and 1.8% currently uses other tobacco products.
- Over four in five schools have a policy prohibiting tobacco use among students; Two-thirds of the schools have a policy for personnel; Nine in ten schools enforce their polices.
- One-third of the schools include tobacco use prevention in school curriculum.
- 11.7% of teachers have access to teaching materials on tobacco use.
- 12.4% of teachers have ever received training on youth tobacco use prevention.
