YELLOW FEVER VACCINATION CENTERS

SUPPLEMENT

United States Designated Yellow Fever Vaccination Centers

Yellow fever is endemic in many areas of Africa and Central and South America. Immunization against yellow fever is required for entry into many countries in South America and sub-Sahara Africa and is recommended for travel in the rest of the "endemic zone" (Figures 1 and 2). A valid International Certificate of Vaccination against Yellow Fever may be required for travel to certain other countries if the traveler arrives from or has traveled through any part of the endemic zone. Detailed information on vaccination requirements for international travel, by country, is included in Supplement to the Morbidity and Mortality Weekly Report, Vol. 19, No. 21, May 30, 1970, and is updated in subsequent issues under "International Notes—Quarantine Measures."

Travelers should be reminded that the Yellow Fever Certificate does not become valid until 10 days after primary immunization. Failure to allow for this interval prior to arrival in a country requiring a valid Certificate may result in delay or inconvenience to the traveler. Revaccination renders the Certificate immediately valid for 10 years from the date of revaccination.


The recommendation of the PHS Advisory Committee on Immunization Practices for Yellow Fever Vaccine (Supplement to the Morbidity and Mortality Weekly Report, Vol. 18, No. 43, Oct. 25, 1969) includes information on simultaneous administration of yellow fever and other live virus vaccines. When travel plans preclude allowing the recommended 1-month interval between administrations of live virus vaccines, yellow fever and other live virus vaccines should be given in different sites on the same day.

For purposes of international travel, yellow fever immunization must be given at an officially designated Yellow Fever Vaccination Center. The following is a listing of U.S. Designated Yellow Fever Vaccination Centers. Any subsequent changes will be published in the *Morbidity and Mortality Weekly Report* under "International Notes — Quarantine Measures."


