Country of usual residence is currently not reported by all jurisdictions or for all conditions. For further information on interpretation of these data, see Guide to Interpreting Provisional and Finalized NNDSS data
- † Previous 52 week maximum and cumulative YTD are determined from periods of time when the condition was reportable in the jurisdiction (i.e., may be less than 52 weeks of data or incomplete YTD data).
- § Prior to 2023, confirmed and probable cases for Candida auris, clinical were published. Beginning 2023, confirmed cases will be published for Candida auris, clinical and Candida auris, screening.
- ¶ All metrics are based on confirmed cases only.

Notes:

- These are **weekly** cases of selected infectious national notifiable diseases, from the National Notifiable Diseases Surveillance System (NNDSS). NNDSS data reported by the 50 states, New York City, the District of Columbia, and the U.S. territories are collated and published weekly in alphabetical order by condition. Cases reported by state health departments to CDC for weekly publication are subject to ongoing revision of information and delayed reporting. Therefore, numbers listed in later weeks may reflect changes made to these counts as additional information becomes available. Case counts in the tables are presented as published each week. See also Notifiable Infectious Disease Data Tables.
