What we do

Improve health department capacity and performance

- Consultation on policy and legal options that affect CDC health priorities

- Improvement of business interactions between health department grantees and CDC to reduce time and resources spent on process, allowing resources to be redirected to essential public health services
 - **Technical Assistance & Service Improvement Initiative for CDC Project Officers**
- Coordination of **Tribal Support** for CDC programs and policies that focus on American Indian/Alaskan Native communities, including implementation of the CDC Tribal Consultation Policy/Charter and coordination of the CDC's Federal Tribal Advisory Committee





Develop assessment and capacity building tools

- CDC's **Prevention Status Report** highlights the status of priority health concerns in all 50 states and the District of Columbia, identifies where improvements can be made, and advances evidence-based public health policy and practice
- CDC **Funding Profiles** tool includes searchable grant and cooperative agreement information

Engage state, tribal, local and territorial health officials with CDC

- **Biannual Orientations** and the **Health Official Packet** provide opportunities for new health officials to learn more about CDC and how the agency works to support their efforts at all levels in the public health system
- **Town Hall Teleconferences** held a week after the release of CDC's monthly Vital Signs report provide a venue for health officials to discuss strategies, lessons learned, and success stories, as well as build networks around these leading public health challenges
- Weekly **Did You Know?** e-mails promote timely news from across CDC to public health officials to inform public health programs and move data and recommendations into action
- **Have You Heard? Facts From The Field** complements **Did You Know?** and shares with CDC the concerns and challenges of public health agencies, as well as their successes and innovative programs
- The **STLT Gateway** website dedicated to health department staff provides a single place to find multiple CDC resources and also a virtual space to collaborate and interact
- **Public Health Communities of Practice** support electronic information exchanges where public health professionals can collaborate on priority issues
- **CDC's Primary Care and Public Health Initiative** fosters collaboration between primary care and public health through monthly teleconferences and the development of public health educational tools for delivery in residency training programs
