- * Case counts for reporting years 2024 and 2025 are provisional and subject to change. Cases are assigned to the reporting jurisdiction submitting the case to NNDSS, if the case's country of usual residence is the U.S., a U.S. territory, unknown, or null (i.e., country not reported); otherwise, the case is assigned to the 'Non-U.S. Residents' category. Country of usual residence is currently not reported by all jurisdictions or for all conditions. For further information on interpretation of these data, see Guide to Interpreting Provisional and Finalized NNDSS data.
- † Previous 52 week maximum and cumulative YTD are determined from periods of time when the condition was reportable in the jurisdiction (i.e., may be less than 52 weeks of data or incomplete YTD data).
- § Beginning in January 2025, the anthrax case definition includes anthrax caused by any *Bacillus* spp. that produces anthrax toxin, not just *B. anthracis* and *B. cereus*, to align with the approved CSTE position statement 24-ID-01. This column summarizes all sub-classifications of anthrax: cutaneous anthrax, ingestion anthrax, inhalation anthrax, injection anthrax, and welder's anthrax.

¶ Case count includes both probable and confirmed cases.

Notes:

- These are **weekly** cases of selected infectious national notifiable diseases, from the National Notifiable Diseases Surveillance System (NNDSS). NNDSS data reported by the 50 states, New York City, the District of Columbia, and the U.S. territories are collated and published weekly in alphabetical order by condition. Cases reported by state health departments to CDC for weekly publication are subject to ongoing revision of information and delayed reporting. Therefore, numbers listed in later weeks may reflect changes made to these counts as additional information becomes available. Case counts in the tables are presented as *published* each week. See also <u>Notifiable Infectious Disease Data Tables</u>.
