Policy Corner

Healthcare Reform

The Senate passed healthcare reform legislation at the close of 2009, signaling that healthcare reform is moving forward. The House and the Senate are now tasked with reconciling both healthcare reform bills to create final healthcare reform legislation that can be passed. While both bills include language on healthcare-associated infections, the House and Senate legislation differ on specific strategies to prevent HAIs.

WASHINGTON STATE

Washington state recently launched its healthcare-associated infection (HAI) Web site. The site allows the general public to see and compare HAI rates for hospitals across the state. To date, the site has exceeded 8,000 hits! The site features hospital infection rates based on NHSN data on central line bloodstream infections and ventilator-associated pneumonia.
