

2012-2013 Influenza Season Week 11 ending March 16, 2013

All data are preliminary and may change as more reports are received.

Synopsis: During week 11 (March 10 – 16, 2013), influenza activity remained elevated in the United States, but decreased in most areas.

- **Viral Surveillance:** Of 5,526 specimens tested and reported by collaborating laboratories, 899 (16.3%) were positive for influenza.
- **Pneumonia and Influenza Mortality:** The proportion of deaths attributed to pneumonia and influenza (P&I) was above the epidemic threshold.
- **Influenza-Associated Pediatric Deaths:** Six pediatric deaths were reported.
- **Influenza-Associated Hospitalizations:** A cumulative rate for the season of 40.6 laboratory-confirmed influenza-associated hospitalizations per 100,000 population was reported. Of reported hospitalizations, 51% were among adults 65 years and older.
- **Outpatient Illness Surveillance:** The proportion of outpatient visits for influenza-like illness (ILI) was 2.2%. This is at the national baseline of 2.2%. Three of 10 regions reported ILI above region-specific baseline levels. One state experienced high ILI activity; 5 states experienced moderate activity; 6 states and New York City experienced low activity; 38 states experienced minimal activity, and the District of Columbia had insufficient data.
- **Geographic Spread of Influenza:** Seven states reported widespread influenza activity; Puerto Rico and 8 states reported regional influenza activity; 26 states reported local influenza activity; 9 states reported sporadic influenza activity; Guam reported no influenza activity, and the U.S. Virgin Islands and the District of Columbia did not report.

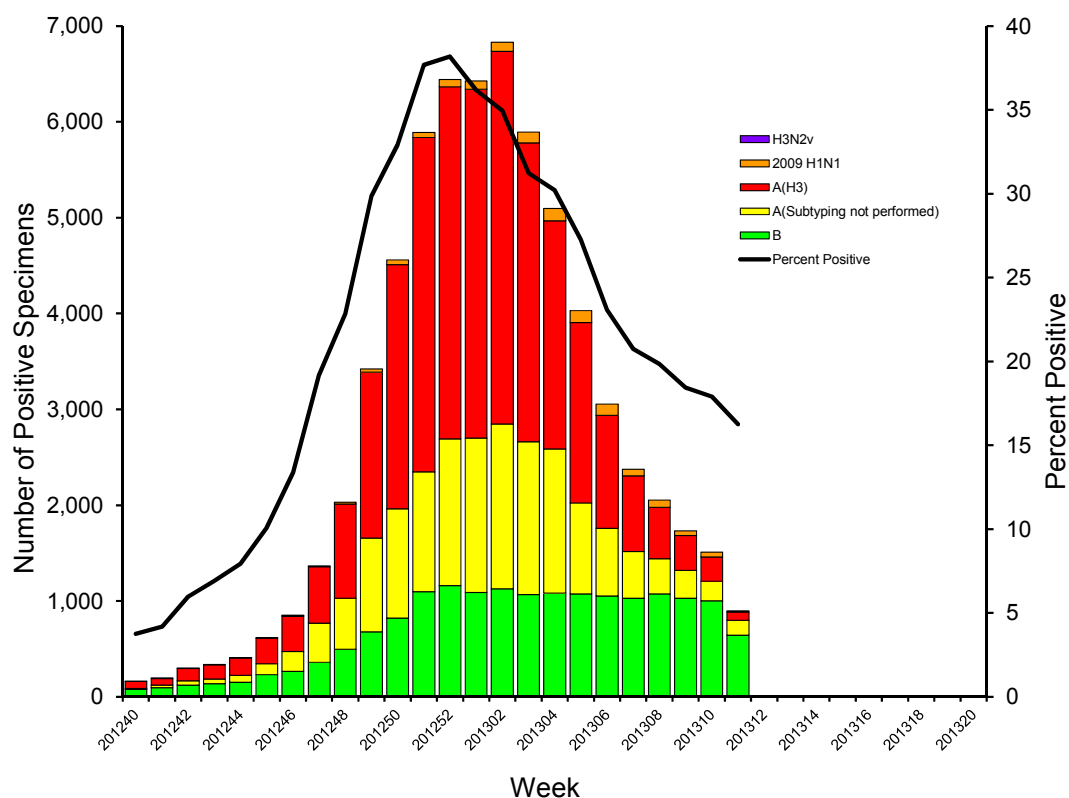

U.S. Virologic Surveillance: U.S. World Health Organization (WHO) and National Respiratory and Enteric Virus Surveillance System (NREVSS) collaborating laboratories located in all 50 states and Puerto Rico report to CDC the number of respiratory specimens tested for influenza and the number positive by influenza virus type and influenza A virus subtype.

Influenza-Positive Tests Reported to CDC by U.S. WHO/NREVSS Collaborating Laboratories, National Summary, 2012-13 Season



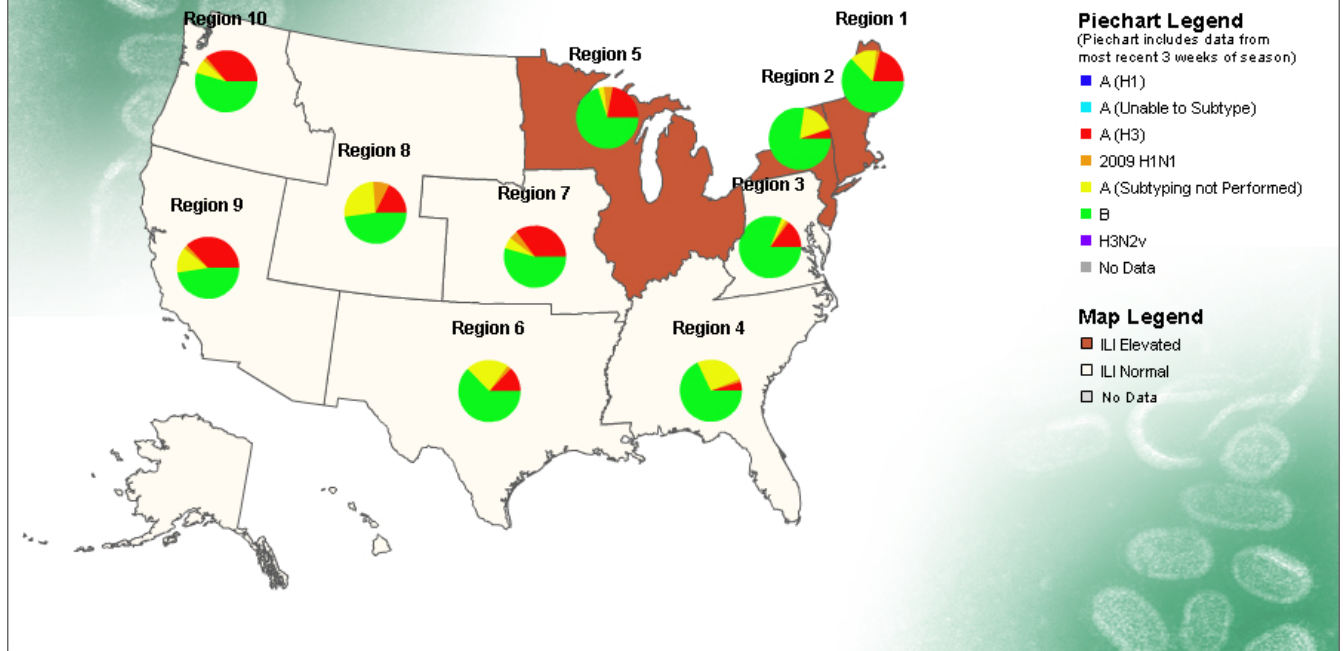
Since the start of the season, influenza A (H3N2) viruses have predominated nationally, however in recent weeks, the proportion of influenza B viruses has been increasing. During week 11, 72% of all influenza positive specimens reported were influenza B viruses and influenza B viruses were reported more frequently than influenza A viruses in 8 of 10 regions.

The image below shows the proportion of influenza-positive respiratory samples by type and subtype for the most recent three weeks in each region. Antigenic Characterization: CDC has antigenically characterized 1,695 influenza viruses [141 2009 H1N1 viruses, 1,012 influenza A (H3N2) viruses, and 542 influenza B viruses] collected by U.S. laboratories since October 1, 2012.

2009 H1N1 [141]

- 138 (97.9%) of the 141 2009 H1N1 viruses tested were characterized as A/California/7/2009-like, the influenza A (H1N1) component of the 2012-2013 influenza vaccine for the Northern Hemisphere.
- 3 (2.1%) of the 141 2009 H1N1 viruses tested showed reduced titers with antiserum produced against A/California/7/2009.

Influenza A (H3N2) [1,012]:

- 1,008 (99.6%) of the 1,012 H3N2 influenza viruses tested have been characterized as A/Victoria/361/2011-like, the influenza A (H3N2) component of the 2012-2013 Northern Hemisphere influenza vaccine.
- 4 (0.4%) of the 1,012 H3N2 viruses tested showed reduced titers with antiserum produced against A/Victoria/361/2011.

Influenza B (B/Yamagata/16/88 and B/Victoria/02/87 lineages) [542]:

- **Yamagata Lineage [383]:** 383 (70.7%) of the 542 influenza B viruses tested so far this season have been characterized as B/Wisconsin/1/2010-like, the influenza B component of the 2012-2013 Northern Hemisphere influenza vaccine.
- **Victoria Lineage [159]:** 159 (29.3%) of 542 influenza B viruses tested have been from the B/Victoria lineage of viruses.

Composition of the 2013-2014 Influenza Vaccine: The World Health Organization (WHO) has recommended vaccine viruses for the 2013-2014 Northern Hemisphere vaccines, and the Food and Drug Administration's Vaccines and Related Biological Products Advisory Committee (VRBPAC) has made recommendations for the composition of the 2013-2014 influenza vaccines to be used in the United States. Both agencies recommend that trivalent vaccines contain an A/California/7/2009-like (2009 H1N1) virus, an A(H3N2) virus antigenically like the cell-propagated, or cell-grown, virus A/Victoria/361/2011 (A/Texas/50/2012), and a B/Massachusetts/2/2012-like (B/Yamagata lineage) virus. It is recommended that quadrivalent vaccines containing an additional influenza B virus contain a B/Brisbane/60/2008-like (B/Victoria lineage) virus in addition to the viruses recommended for the trivalent vaccines. These recommendations were based on global influenza virus surveillance data related to epidemiology and antigenic characteristics, serological responses to 2012-2013 seasonal vaccines, and the availability of candidate strains and reagents.

Antiviral Resistance: Testing of 2009 H1N1, influenza A (H3N2), and influenza B virus isolates for resistance to neuraminidase inhibitors (oseltamivir and zanamivir) is performed at CDC using a functional assay. Additional 2009 influenza A (H1N1) clinical samples are tested for a single mutation in the neuraminidase of the virus known to confer oseltamivir resistance (H275Y). The data summarized below combine the results of both testing methods. These samples are routinely obtained for surveillance purposes rather than for diagnostic testing of patients suspected to be infected with antiviral-resistant virus.

High levels of resistance to the adamantanes (amantadine and rimantadine) persist among 2009 influenza A (H1N1) and A (H3N2) viruses (the adamantanes are not effective against influenza B viruses). As a result, data from adamantane resistance testing are not presented below.

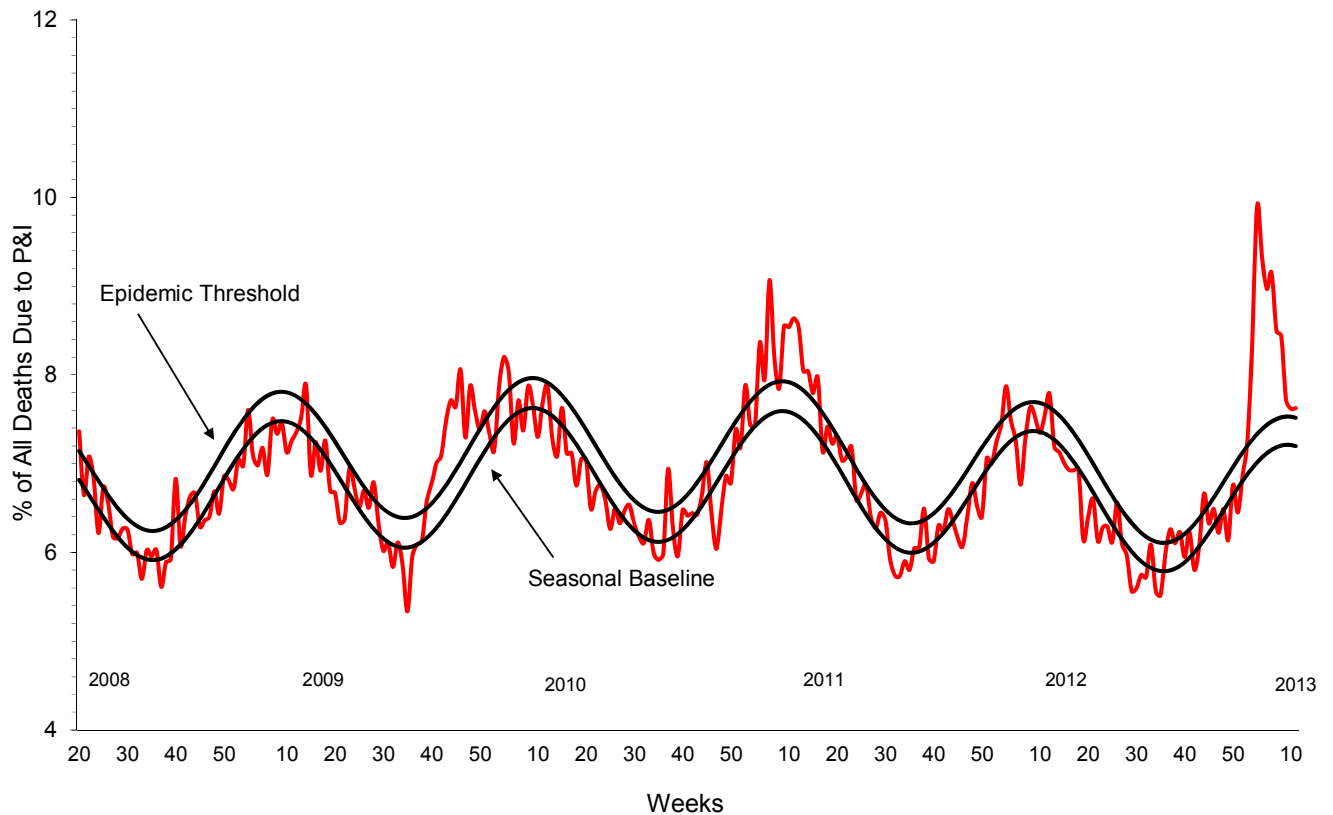
The majority of currently circulating influenza viruses are susceptible to the neuraminidase inhibitor antiviral medications, oseltamivir and zanamivir; however, rare sporadic cases of oseltamivir-resistant 2009 H1N1 and A (H3N2) viruses have been detected worldwide. Antiviral treatment with oseltamivir or zanamivir as early as possible is recommended for patients with confirmed or suspected influenza who have severe, complicated, or progressive illness; who require hospitalization; or who are at greater risk for serious influenza-related complications. Novel Influenza A Virus: No new human infections with novel influenza A viruses were reported to CDC during week 11.

A total of 312 infections with variant influenza viruses (308 H3N2v viruses, 3 H1N2v viruses, and 1 H1N1v virus) have been [reported](http://www.cdc.gov/flu/swineflu/h3n2v-cases.htm) from 11 states since July 2012. Pneumonia and Influenza (P&I) Mortality Surveillance: During week 11, 7.6% of all deaths reported through the 122 Cities Mortality Reporting System were due to P&I. This percentage was above the epidemic threshold of 7.5% for week 11.

Pneumonia and Influenza Mortality for 122 U.S. Cities Week ending March 16, 2013

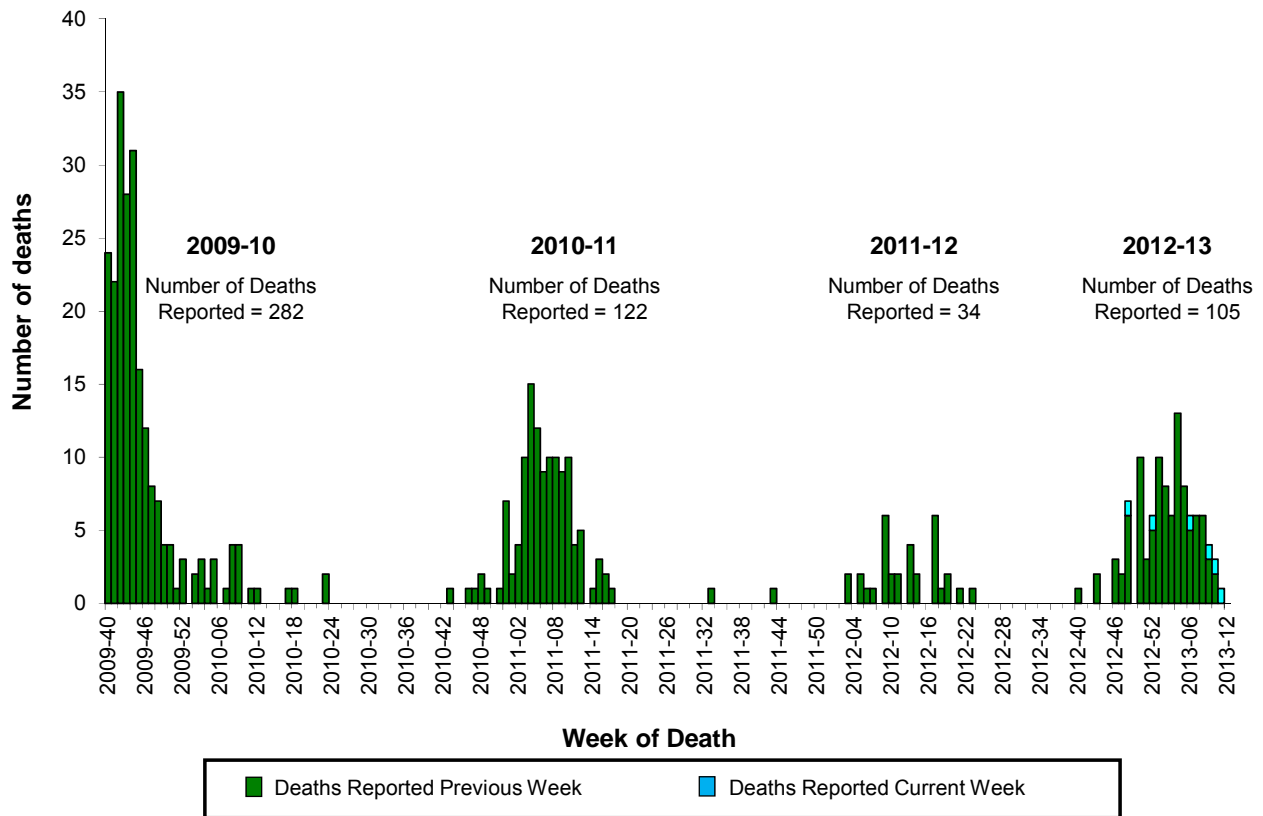


Influenza-Associated Pediatric Mortality: Six influenza-associated pediatric deaths were reported to CDC during week 11. One death was associated with a 2009 H1N1 virus and occurred during week 9 (week ending March 2, 2013) and five were associated with influenza B viruses and occurred during weeks 48, 52, 6, 10, and 11 (weeks ending December 1, December 29, 2012, February 9, March 9, and March 16, 2013).

A total of 105 influenza-associated pediatric deaths have been reported during the 2012-2013 season from Chicago [1], New York City [4] and 36 states (AL [1], AR [3], AZ [2], CA [3], CO [5], FL [8], HI [1], IA [1], IL [1], IN [4], KS [2], KY [1], LA [1], MA [3], MD [2], ME [1], MI [5], MN [3], MS [1], NE [1], NH [1], NJ [6], NM [2], NV [1], NY [6], OH [4], OK [1], PA [1], SC [3], SD [2], TN [2], TX [15], UT [3], VA [1], WA [1], and WI [2]).

Influenza-Associated Hospitalizations: The Influenza Hospitalization Surveillance Network (FluSurv-NET) conducts population-based surveillance for laboratory-confirmed influenza-related hospitalizations in children younger than 18 years of age (since the 2003-2004 influenza season) and adults (since the 2005-2006 influenza season).

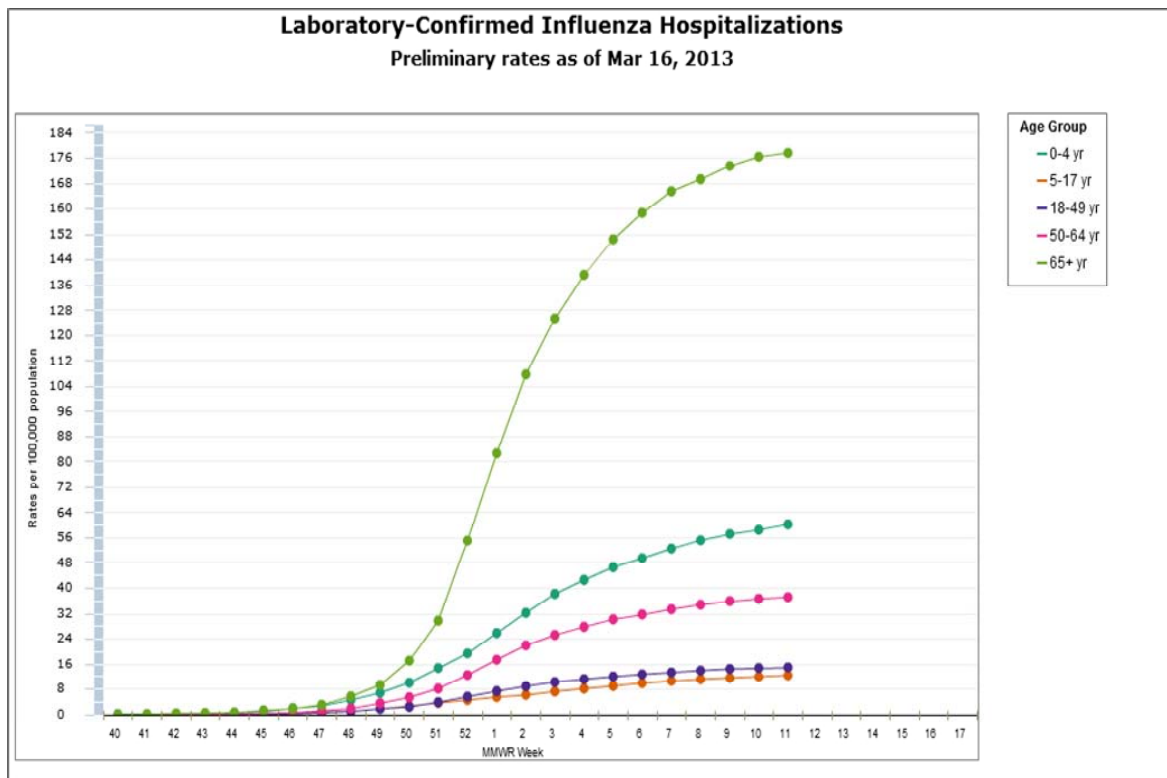
The FluSurv-NET covers more than 80 counties in the 10 Emerging Infections Program (EIP) states (CA, CO, CT, GA, MD, MN, NM, NY, OR, TN) and additional Influenza Hospitalization Surveillance Project (IHSP) states. The IHSP began during the 2009-2010 season to enhance surveillance

during the 2009 H1N1 pandemic. IHSP sites included IA, ID, MI, OK and SD during the 2009-2010 season; ID, MI, OH, OK, RI, and UT during the 2010-2011 season; MI, OH, RI, and UT during the 2011-2012 season; and IA, MI, OH, RI, and UT during the 2012-2013 season.

Data gathered are used to estimate age-specific hospitalization rates on a weekly basis, and describe characteristics of persons hospitalized with severe influenza illness. The rates provided are likely to be an underestimate as influenza-related hospitalizations can be missed, either because testing is not performed, or because cases may be attributed to other causes of pneumonia or other common influenza-related complications.

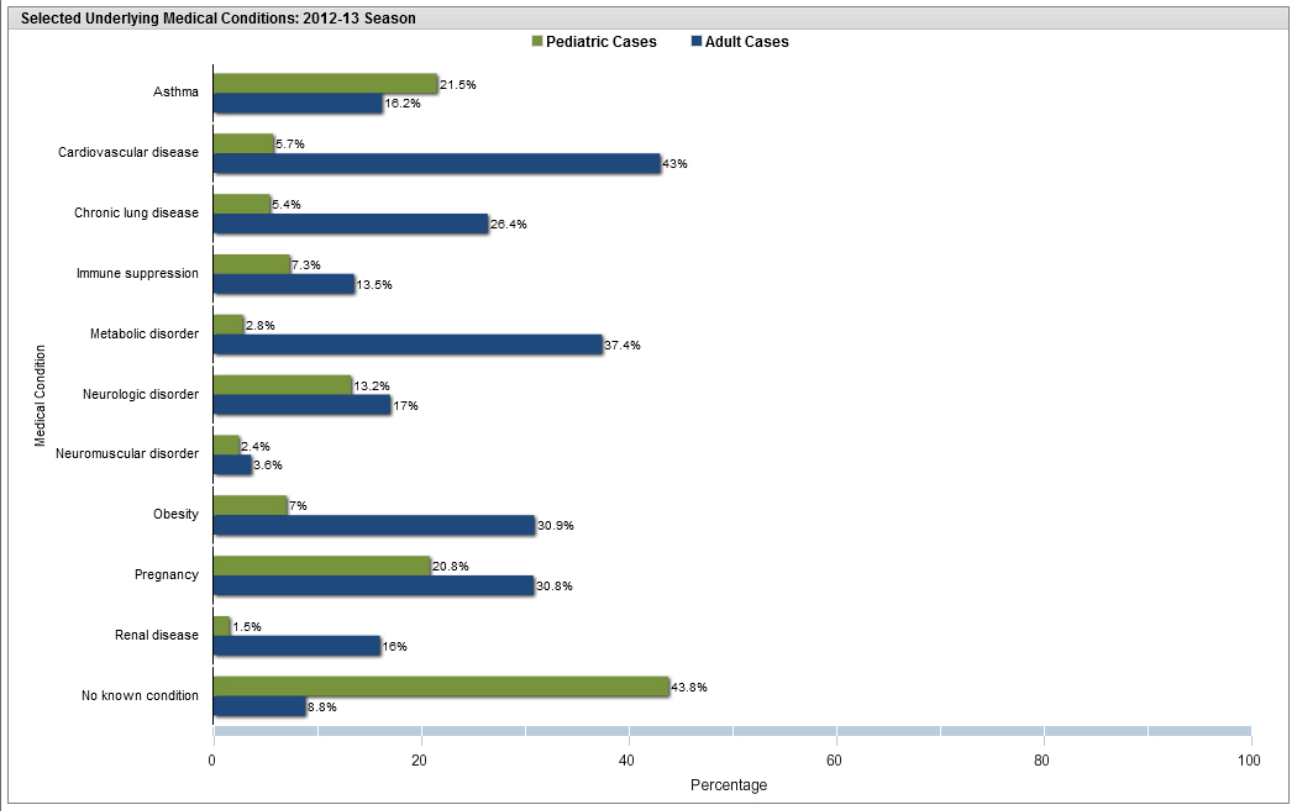
Between October 1, 2012 and March 16, 2013, 11,307 laboratory-confirmed influenza-associated hospitalizations were reported. This is a rate of 40.6 per 100,000 population. The most affected group is those ≥ 65 years, accounting for 51% of reported cases. Among all hospitalizations, 9,387 (83.0%) were associated with influenza A and 1,841 (16.3%) with influenza B. There was no virus type information for 40 (0.4%) hospitalizations. Among hospitalizations with influenza A subtype information, 3,022 (96.5%) were attributed to H3 and 96 (3.1%) were attributed to 2009 H1N1. The most commonly reported underlying medical conditions among hospitalized adults were cardiovascular disease, metabolic disorders, obesity, and chronic lung disease (excluding asthma). The most commonly reported underlying medical conditions in hospitalized children were asthma, neurologic disorders, and immune suppression. Approximately 44% of hospitalized children had no identified underlying medical conditions. Among 394 hospitalized women of childbearing age (15-44 years), 119 were pregnant, including 5 pregnancies among the 24 pediatric cases in this category.

Preliminary data as of Mar 16, 2013



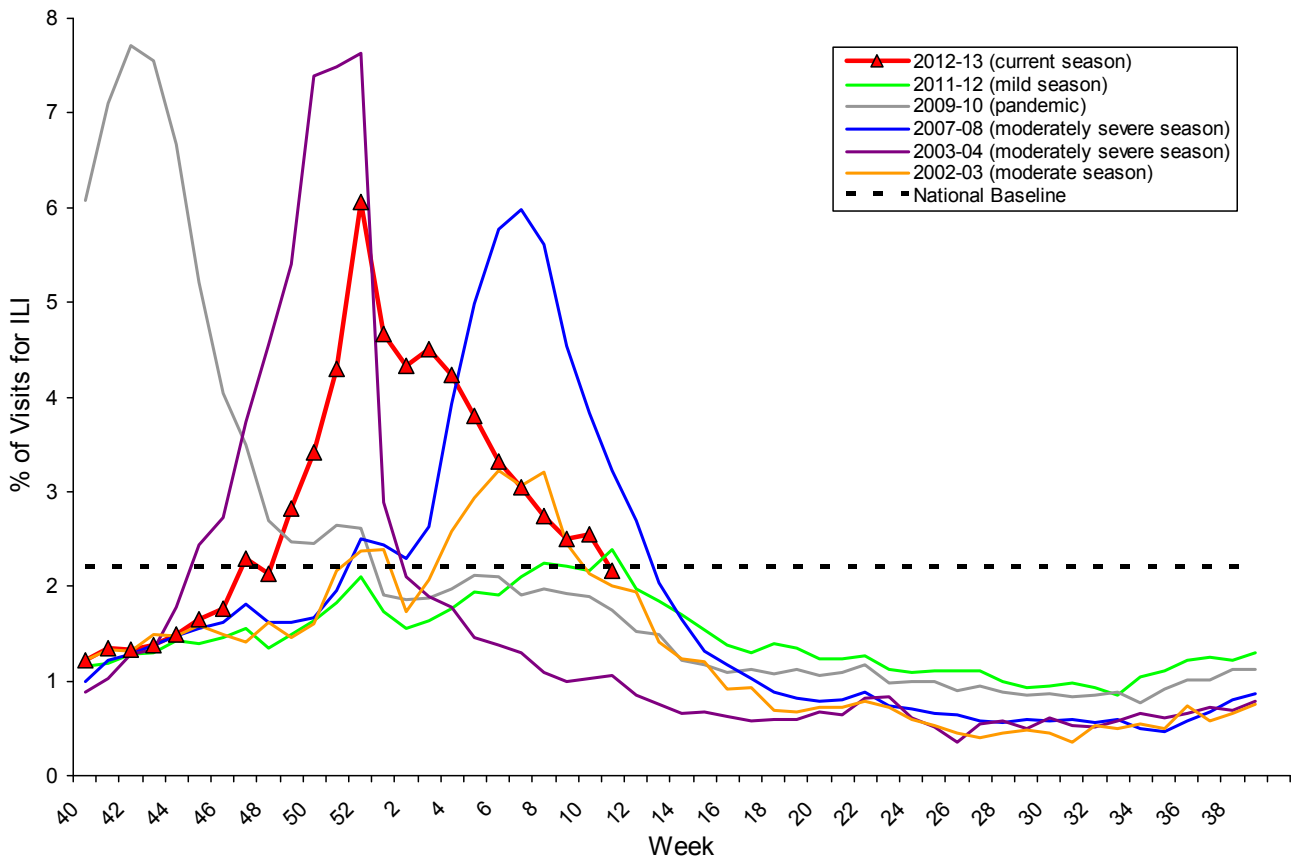
Asthma includes a medical diagnosis of asthma or reactive airway disease; Cardiovascular diseases include conditions such as coronary heart disease, cardiac valve disorders, congestive heart failure, and pulmonary hypertension (does not include isolated hypertension); Chronic lung diseases include conditions such as bronchiolitis obliterans, chronic aspiration pneumonia, and interstitial lung disease; Immune suppression includes conditions such as immunoglobulin deficiency, leukemia, lymphoma, HIV/AIDS, and individuals taking immunosuppressive medications; Metabolic disorders include conditions such as diabetes mellitus, thyroid dysfunction, adrenal insufficiency, and liver disease; Neurologic diseases include conditions such as seizure disorders, cerebral palsy, and cognitive dysfunction; Neuromuscular diseases include conditions such as multiple sclerosis and muscular dystrophy; Obesity was assigned if indicated in patient's medical chart or if body mass index (BMI) >30 kg/m²; Pregnancy percentage calculated using number of female cases aged between 15 and 44 years of age as the denominator; Renal diseases include conditions such as acute or chronic renal failure, nephrotic syndrome, glomerulonephritis, and impaired creatinine clearance; No known condition indicates that the case did not have any known underlying medical condition indicated in medical chart at the time of hospitalization.

Only includes cases for which data collection has been completed through the medical chart review stage.

Outpatient Illness Surveillance: Nationwide during week 11, 2.2% of patient visits reported through the U.S. Outpatient Influenza-like Illness Surveillance Network (ILINet) were due to influenza-like illness (ILI). This percentage is at the national baseline of 2.2%.

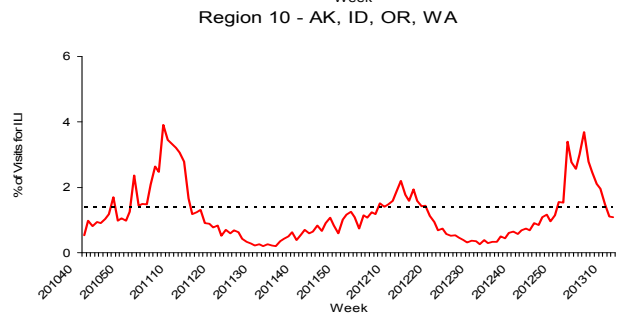
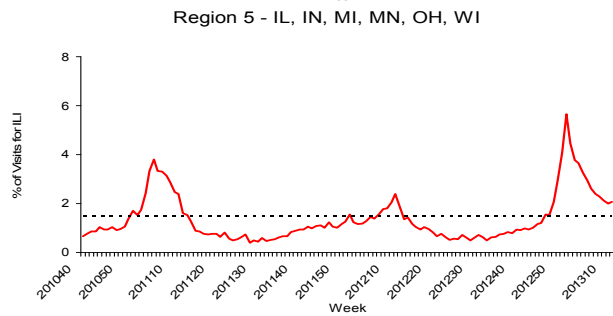
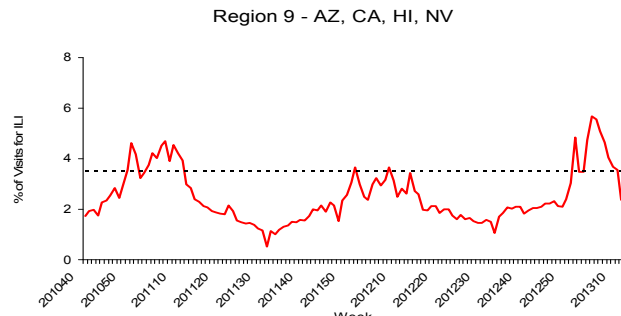
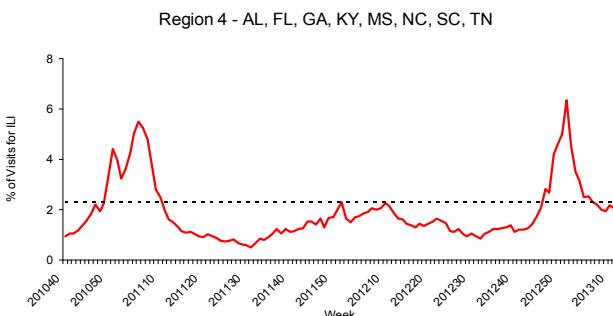
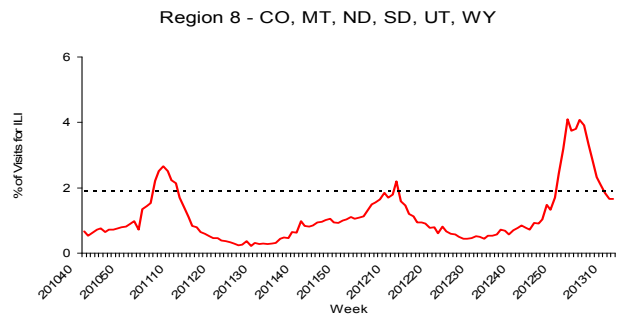
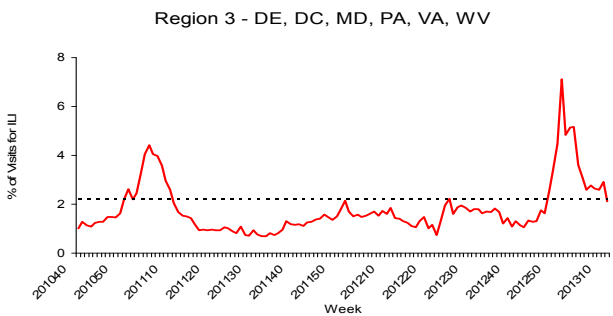
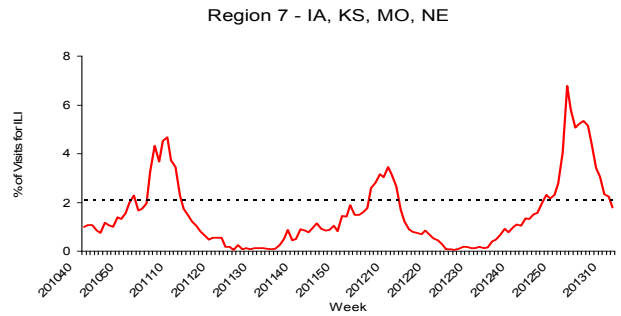
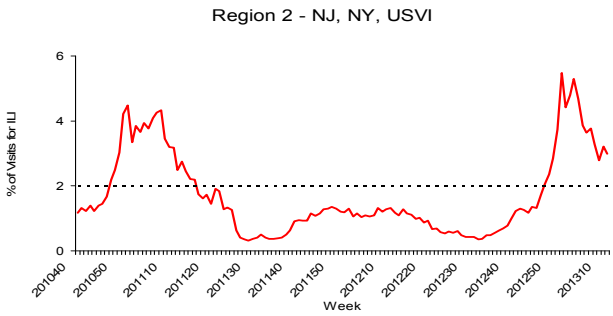
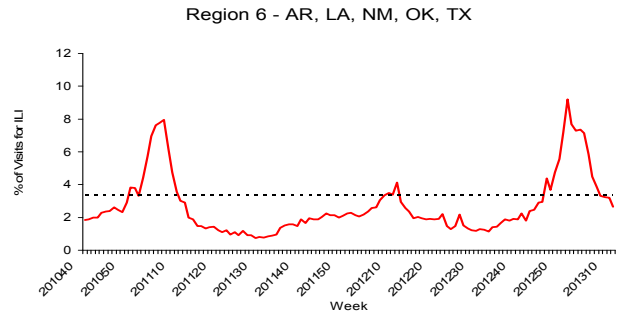
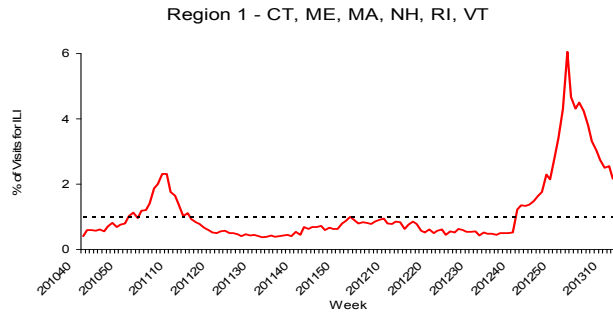

On a regional level, the percentage of outpatient visits for ILI ranged from 1.1% to 3.0% during week 11. Three of 10 regions (1, 2, and 5) reported a proportion of outpatient visits for ILI above their region-specific baseline levels.

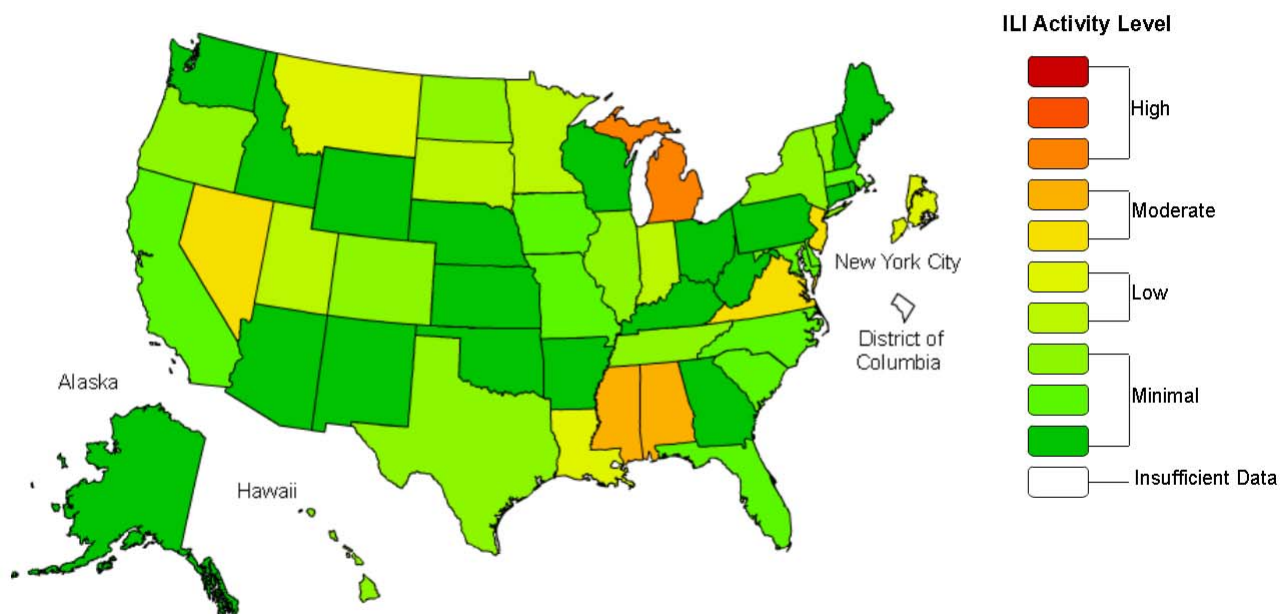

ILINet Activity Indicator Map: Data collected in ILINet are used to produce a measure of ILI activity* by state. Activity levels are based on the percent of outpatient visits in a state due to ILI and are compared to the average percent of ILI visits that occur during spring and fall weeks with little or no influenza virus circulation. Activity levels range from minimal, which would correspond to ILI activity from outpatient clinics being below the average, to high, which would correspond to ILI activity from outpatient clinics being much higher than average.

During week 11, the following ILI activity levels were experienced:

- One state (Michigan) experienced high ILI activity.
- Five states experienced moderate ILI activity (Alabama, Mississippi, Nevada, New Jersey, and Virginia).
- Six states and New York City experienced low ILI activity (Indiana, Louisiana, Minnesota, Montana, South Dakota, and Utah).
- Thirty-eight states experienced minimal ILI activity (Alaska, Arizona, Arkansas, California, Colorado, Connecticut, Delaware, Florida, Georgia, Hawaii, Idaho, Illinois, Iowa, Kansas, Kentucky, Maine, Maryland, Massachusetts, Missouri, Nebraska, New Hampshire, New Mexico, New York, North Carolina, North Dakota, Ohio, Oklahoma, Oregon, Pennsylvania, Rhode Island, South Carolina, Tennessee, Texas, Vermont, Washington, West Virginia, Wisconsin, and Wyoming).
- Data were insufficient to calculate an ILI activity level for the District of Columbia.

*This map uses the proportion of outpatient visits to health care providers for influenza-like illness to measure the ILI activity level within a state. It does not, however, measure the extent of geographic spread of flu within a state. Therefore, outbreaks occurring in a single city could cause the state to display high activity levels.

Data collected in ILINet may disproportionately represent certain populations within a state, and therefore, may not accurately depict the full picture of influenza activity for the whole state.

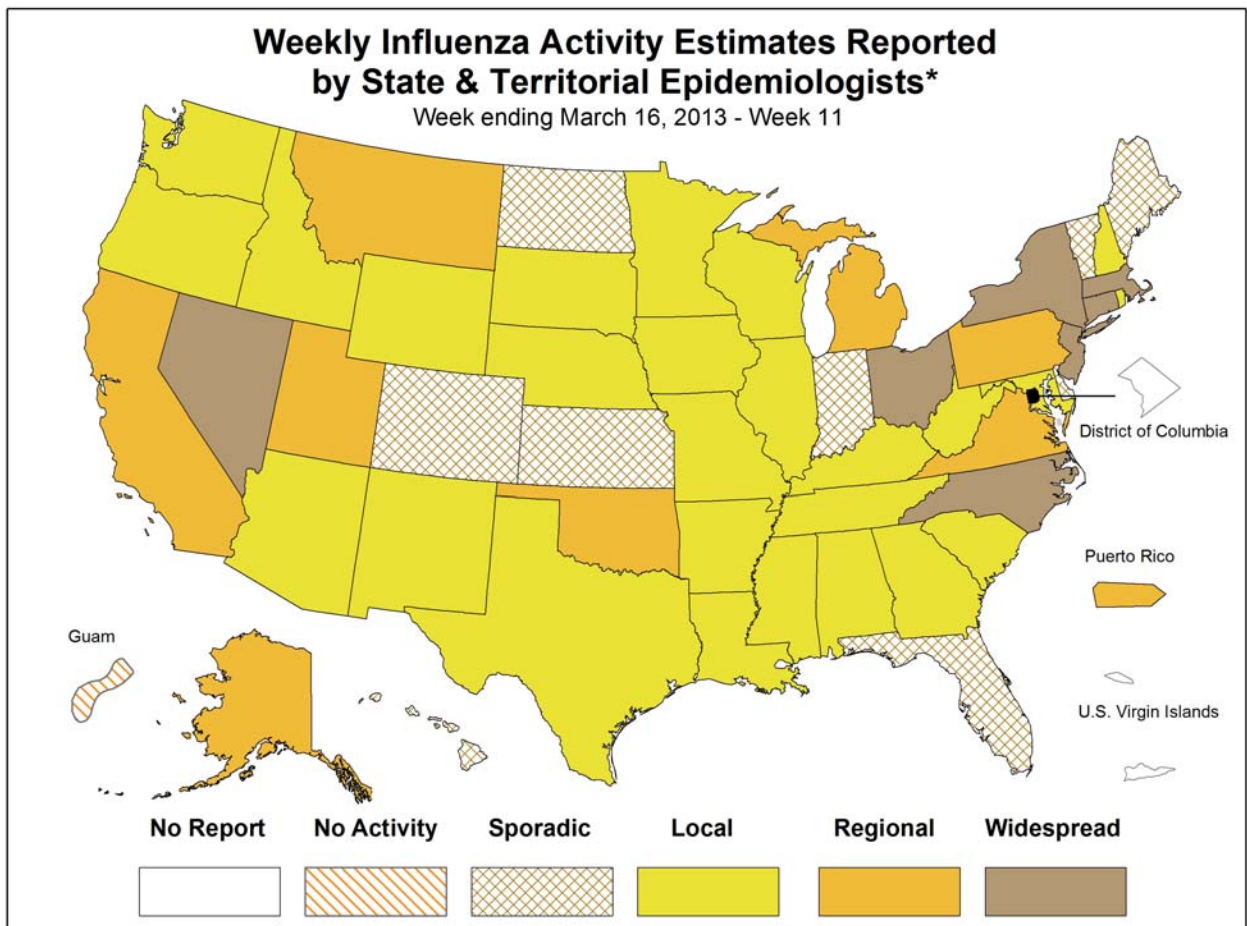
Data displayed in this map are based on data collected in ILINet, whereas the State and Territorial flu activity map is based on reports from state and territorial epidemiologists. The data presented in this map is preliminary and may change as more data is received.

Differences in the data presented here by CDC and independently by some state health departments likely represent differing levels of data completeness with data presented by the state likely being the more complete.

Geographic Spread of Influenza as Assessed by State and Territorial Epidemiologists: The influenza activity reported by state and territorial epidemiologists indicates geographic spread of influenza viruses, but does not measure the severity of influenza activity.

During week 11, the following influenza activity was reported:

- Widespread influenza activity was reported by 7 states (Connecticut, Massachusetts, Nevada, New Jersey, New York, North Carolina, and Ohio).
- Puerto Rico and 8 states reported regional influenza activity (Alaska, California, Michigan, Montana, Oklahoma, Pennsylvania, Utah, and Virginia).
- Twenty-six states reported local influenza activity (Alabama, Arizona, Arkansas, Georgia, Idaho, Illinois, Iowa, Kentucky, Louisiana, Maryland, Minnesota, Mississippi, Missouri, Nebraska, New Hampshire, New Mexico, Oregon, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Washington, West Virginia, Wisconsin, and Wyoming).
- Nine states reported sporadic influenza activity (Colorado, Delaware, Florida, Hawaii, Indiana, Kansas, Maine, North Dakota, and Vermont).
- Guam reported no influenza activity.
- The U.S. Virgin Islands and the District of Columbia did not report.
