Software for New Arboviral Message is in Production:

The updated Data Message Brokering and ArboNet software to handle the new Arboviral v1.3 Message Mapping Guide (MMG) went into production on 7/15/16 and is processing the Arboviral v1.2 messages and generating data for the *Morbidity and Mortality Weekly Report*.

The first Arboviral v1.3 messages are expected to move into production in early August, after jurisdiction onboarding.

The NMI technical assistance team will contact jurisdictions to evaluate their readiness for implementation of the new message and to offer technical assistance, prioritizing jurisdictions in areas with the mosquito vectors, those currently sending v1.2, and NEDSS Base System (NBS) states.



MESSAGE MAPPING GUIDE DEVELOPMENT UPDATES

Priority MMGs Update: Final versions of the Generic v2, Hepatitis, and Arboviral v1.3 Message Mapping Guides (MMGs) and their associated artifacts have been posted to the NNDSS HL7 Case Notification Resource Center at https://wwwn.cdc.gov/nndss/case-notification/.

Pilot test-ready versions of the STD, Congenital Syphilis, Mumps, and Pertussis MMGs also are available on the resource center.



Varicella MMG Update: The 30-day external comment period for the draft Varicella MMG closed on 6/8/16. CDC is making updates to the draft MMG that were identified during the review period and finalizing a compilation of responses to feedback received from seven jurisdictions.

New MMGs Identified for Development in 2016: CDC posted draft MMGs for Malaria, Babesiosis, and Measles to the NNDSS HL7 Case Notification Resource Center at https://wwwn.cdc.gov/nndss/case-notification/ for 30-day external reviews. The review period for Malaria closed on 7/20/16, and the review period for Babesiosis closed on 7/27/16; CDC is reviewing the feedback received. The review period for Measles is from 7/5/2016 to 8/15/2016.

In addition, CDC is preparing draft MMGs for Rubella and Congenital Rubella Syndrome and proposed data element lists for Cyclosporiasis and Trichinellosis, which will form the basis of future draft MMGs.

CDC also is identifying the next set of new priorities for MMG development.

MESSAGE VALIDATION, PROCESSING, AND PROVISIONING SYSTEM UPDATES

MVPS Generic and Hepatitis Implementation Timeline To Change: Recent internal quality control reviews and testing of MVPS have identified several needed refinements to the system before it goes into production for Generic v2 and Hepatitis.

The pertinent NMI teams are holding daily meetings to review and prioritize these issues, resolve priority ones, and determine their impact upon the NMI timeline. These issues



will delay the planned summer implementation of MVPS, and the NMI team will provide the adjusted NMI timeline as soon as possible.

To respect participants' time, the second round of MVPS User Acceptance Testing (UAT) also will be postponed until the identified system refinements are completed.

MVPS Continues Internal Functional Testing and Implementation of System Enhancements: The MVPS team continues to perform extensive internal testing and identify and schedule defects to be resolved.

The team has resolved several issues found in the MVPS onboarding environment, including issues accessing MVPS through CDC Secure Access Management Services (SAMS) previously experienced by jurisdiction testers during UAT.

The team has implemented additional security enhancements, including row-level security, into MVPS.

Jurisdictions Encouraged to Check SAMS Access: In anticipation of MVPS being ready to accept data from jurisdictions for Generic v2 and Hepatitis, the NMI team is encouraging all non-pilot jurisdictions to complete the SAMS proofing process and confirm their access with the MVPS support team.
