# **Update on Zika Virus Case Notification Implementation:**

The NNDSS HL7 Case Notification Resource Center at <a href="https://wwwn.cdc.gov/nndss/case-notification/">https://wwwn.cdc.gov/nndss/case-notification/</a> now displays the updated Arboviral v1.3 Message Mapping Guide (MMG) and associated onboarding test scenarios and test cases.

CDC distributed a letter to state epidemiologists

(https://wwwn.cdc.gov/nndss/document/2016 NNDSS State Epi Letter cleared Sept 21 2016 CSTE ZIKV FINAL.pdf) on 9/21/16 that provided instructions for implementing CSTE Position Statement 16-ID-01.

The updated CDC data systems are prepared to receive arboviral case notifications using the four new Zika event codes, and the NNDSS team is reaching out to jurisdictions to discuss onboarding.

The weekly NNDSS Table 1 statistics will include confirmed and probable non-congenital cases of Zika virus disease, but not information on infections or on congenital disease.

# MESSAGE MAPPING GUIDE DEVELOPMENT UPDATES

#### **Priority MMGs Update:**

Final versions of the Generic v2, Hepatitis, and Arboviral v1.3 MMGs and their

associated artifacts have been posted to the NNDSS HL7 Case Notification Resource Center at <a href="https://wwwn.cdc.gov/nndss/case-notification/">https://wwwn.cdc.gov/nndss/case-notification/</a>.

Pilot test-ready versions of the STD, Congenital Syphilis, Mumps, and Pertussis MMGs also are available on the resource center.

#### Varicella MMG Update:

CDC updated the draft MMG with changes that were identified during the recent external review period. The MMG development team also completed a compilation of responses to the feedback received from seven jurisdictions during the external review.

# **Comment Period for Rubella and Congenital Rubella Syndrome MMGs:**

CDC will soon post draft MMGs for Rubella and Congenital Rubella Syndrome to the NNDSS HL7 Case Notification Resource Center at <a href="https://wwwn.cdc.gov/nndss/case-notification/">https://wwwn.cdc.gov/nndss/case-notification/</a>. CSTE will host a webinar to review these MMGs on 10/13/16 from 3:00–4:00 PM.

# MESSAGE VALIDATION, PROCESSING, AND PROVISIONING SYSTEM UPDATES

# MVPS Continues Internal Functional Testing and Implementation of System Enhancements:

The Message Validation, Processing, and Provisioning System (MVPS) team continues to perform quality and functional testing to identify and schedule any potential defects to be resolved.

The following MVPS updates were recently completed:

- Unnecessary internal server error messages experienced while viewing select messages on the dashboard have been removed.
- Additional updates to Hepatitis error/warning messages were completed.
- Vaccine data elements are processing correctly.
- The Message Evaluation and Testing Service (METS) received various cosmetic updates related to text alignment and web browser compatibility.

The MVPS team will continue to make development updates to the system in preparation for a successful launch expected later this year.


# **Jurisdictions Encouraged to Check SAMS Access:**

# TECHNICAL ASSISTANCE UPDATES

**MMG** Training Provided at the Project SHINE Fellowship Orientation: On 9/28/16, the NMI team presented the course "From Initiation to Implementation: Notifiable Disease Message Mapping Guide Essentials" at the Project Strengthening Health Systems through Interprofessional Education (SHINE) Fellowship Orientation for new informatics fellows.

- Through a lecture and hands-on activity, the course provided fellows with an
  overview of the new HL7 MMGs and guided them through the process to
  complete a gap analysis. These skills and resources will help the state-based
  fellows to assist their jurisdictions with implementing the new HL7-based case notification messages.
- The SHINE fellowships seek to increase public health informatics capacity within state and local health





departments. The fellowship programs are managed through a collaborative partnership among CSTE, CDC, and the National Association of County and City Health Officials.
