



## 2016-2017 Influenza Season Week 15 ending April 15, 2017

All data are preliminary and may change as more reports are received.

### Synopsis:

During week 15 (April 9-15, 2017), influenza activity decreased in the United States.

- **Viral Surveillance:** The most frequently identified influenza virus type reported by public health laboratories during week 15 was influenza B. The percentage of respiratory specimens testing positive for influenza in clinical laboratories decreased.
- **Pneumonia and Influenza Mortality:** The proportion of deaths attributed to pneumonia and influenza (P&I) was below the system-specific epidemic threshold in the National Center for Health Statistics (NCHS) Mortality Surveillance System.
- **Influenza-associated Pediatric Deaths:** Five influenza-associated pediatric deaths were reported.
- **Influenza-associated Hospitalizations:** A cumulative rate for the season of 60.9 laboratory-confirmed influenza-associated hospitalizations per 100,000 population was reported.
- **Outpatient Illness Surveillance:** The proportion of outpatient visits for influenza-like illness (ILI) was 2.0%, which is below the national baseline of 2.2%. Three of ten regions reported ILI at or above their region-specific baseline levels. Two states experienced moderate ILI activity; New York City and three states experienced low ILI activity; Puerto Rico and 45 states experienced minimal ILI activity; and the District of Columbia had insufficient data.
- **Geographic Spread of Influenza:** The geographic spread of influenza in 10 states was reported as widespread; Guam, Puerto Rico, and 15 states reported regional activity; the District of Columbia and 19 states reported local activity; six states reported sporadic activity; and the U.S. Virgin Islands reported no activity.

## U.S. Virologic Surveillance:

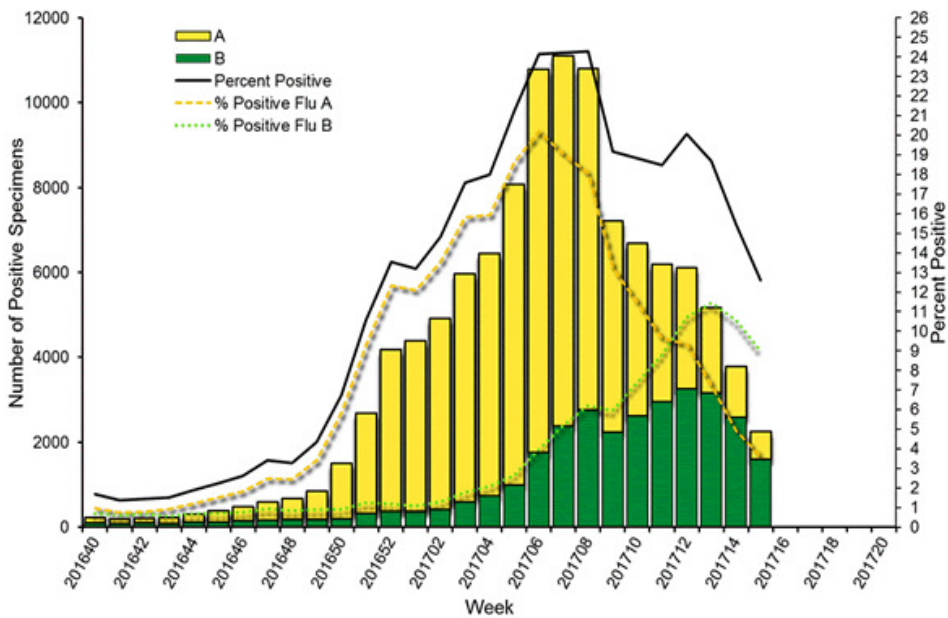
WHO and NREVSS collaborating laboratories, which include both public health and clinical laboratories located in all 50 states, Puerto Rico, and the District of Columbia, report to CDC the total number of respiratory specimens tested for influenza and the number positive for influenza by virus type. In addition, public health laboratories also report the influenza A subtype (H1 or H3) and influenza B lineage information for the viruses they test and the age or age group of the persons from whom the specimens were collected.

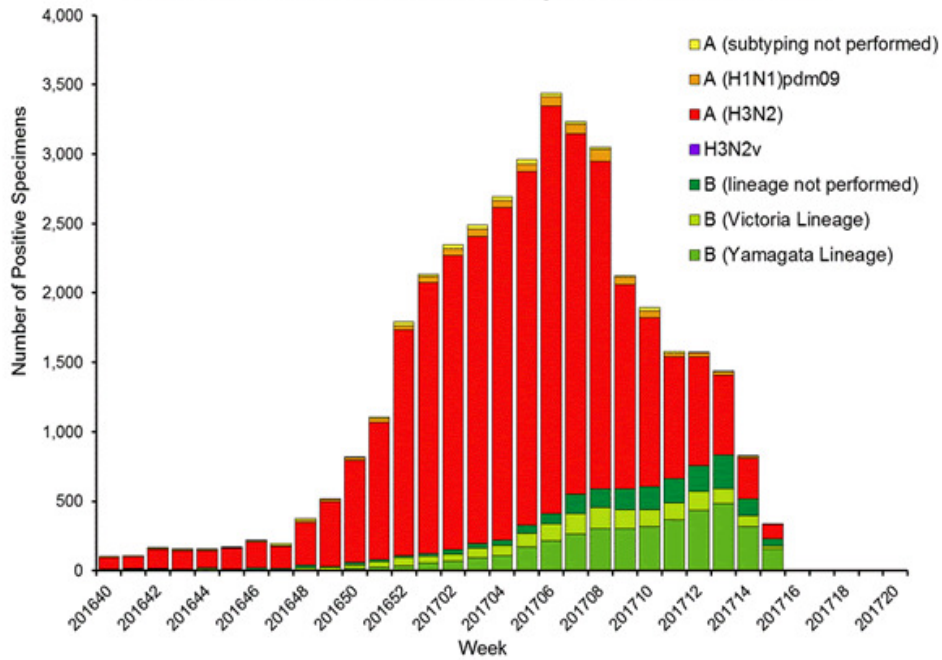

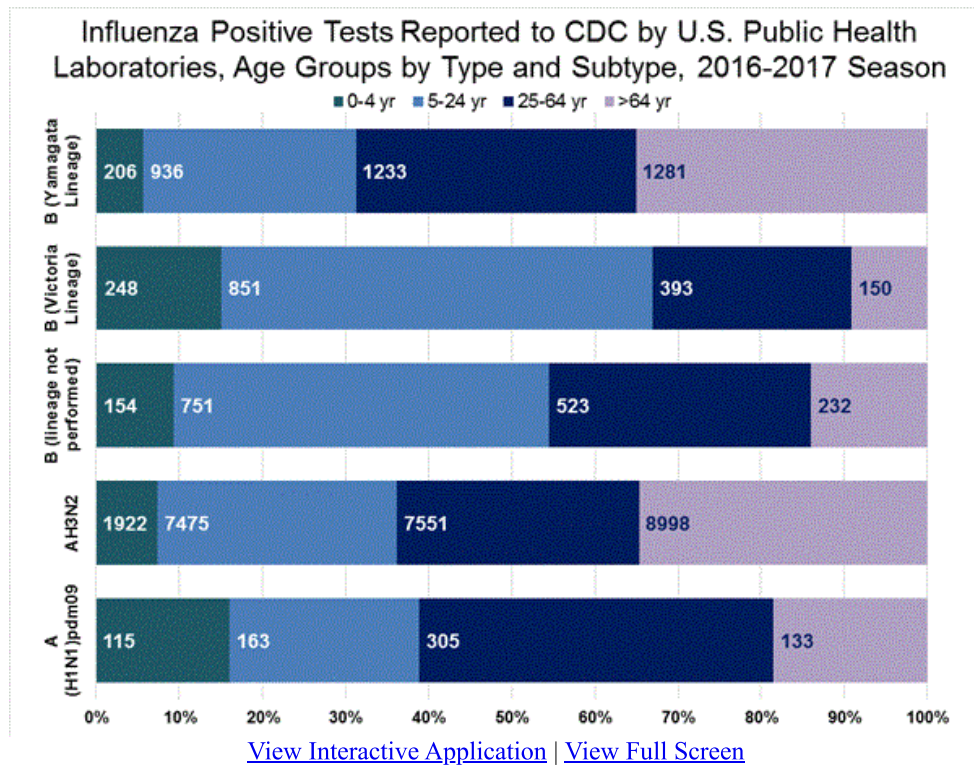

## Influenza Virus Characterization:

CDC characterizes influenza viruses through one or more tests including [genomic sequencing](#), [hemagglutination inhibition \(HI\)](#) and/or neutralization assays. These data are used to compare how similar currently circulating influenza viruses are to the reference viruses used for developing influenza vaccines, and to monitor for changes in circulating influenza viruses. Historically, HI data have been used most commonly to assess the similarity between reference viruses and circulating viruses to suggest how well the vaccine may work until such a time as [vaccine effectiveness estimates](#) are available.

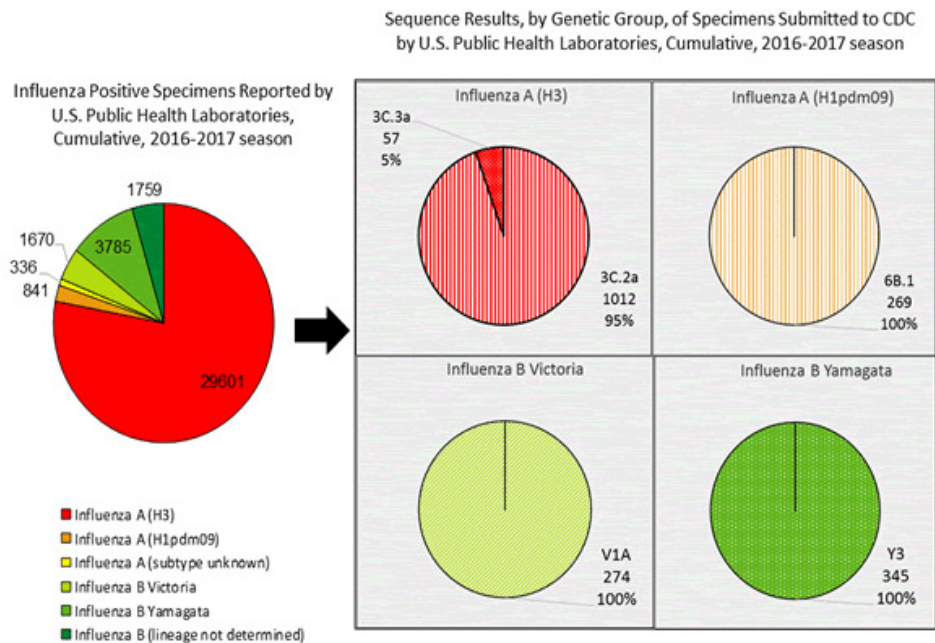
For nearly all virus positive surveillance samples received at CDC, next-generation sequencing is performed to ascertain genomic data of circulating influenza viruses. Viruses can be classified into genetic groups/clades based on analysis of their HA gene segments using phylogenetics and key amino acid changes ([Klimov Vaccine 2012](#)).

A proportion of influenza A (H3N2) viruses don't yield sufficient hemagglutination titers for antigenic characterization using the hemagglutination inhibition test. Therefore, CDC selects a subset of influenza A (H3N2) viruses to test using a focus reduction assay for supplementary antigenic characterization.

## Genetic Characterization

During the 2016-2017 season, 37,992 influenza positive specimens have been collected and reported by public health laboratories in the United States (Figure, left). CDC genetically characterized 1,957 influenza viruses [269 influenza A (H1N1)pdm09, 1,069 influenza A (H3N2), and 619 influenza B viruses] collected by U.S. laboratories. The HA gene segment of all influenza A (H1N1)pdm09 viruses analyzed belonged to genetic group 6B.1. Influenza A (H3N2) virus HA gene segments analyzed belonged to genetic groups 3C.2a or 3C.3a. Genetic group 3C.2a includes a newly emerging subgroup known as 3C.2a1. The HA of influenza B/Victoria-lineage viruses all belonged to genetic group V1A. The HA of influenza B/Yamagata-lineage viruses analyzed all belonged to genetic group Y3.

The majority of U.S. viruses submitted for characterization come from state and local public health laboratories. Due to [Right Size Roadmap](#) considerations, specimen submission guidance issued to the laboratories request that, if available, 2 influenza A (H1N1), 2 A influenza (H3N2), and 2 influenza B viruses be submitted every other week. Because of this, the number of each virus type/subtype characterized should be approximately equal. In the figure below, the results of tests performed by public health labs are presented on the left and sequence results by genetic group of specimens submitted to CDC are presented on the right.

## Antigenic Characterization

CDC has antigenically characterized 1,444 influenza viruses [253 influenza A (H1N1)pdm09, 631 influenza A (H3N2), and 560 influenza B viruses] collected by U.S. laboratories since October 1, 2016.

### Influenza A Virus [882]

- **A (H1N1)pdm09 [253]:** 251 of 253 (99.2%) influenza A (H1N1)pdm09 viruses were antigenically characterized using ferret post-infection antisera as A/California/7/2009-like, the influenza A (H1N1) component of the 2016-2017 Northern Hemisphere vaccine.
- **A (H3N2) [631]:** 609 of 631 (96.5%) influenza A (H3N2) viruses were antigenically characterized as A/Hong Kong/4801/2014-like, a virus that belongs in genetic group 3C.2a and is the influenza A (H3N2) component of the 2016-2017 Northern Hemisphere vaccine, by HI testing or neutralization testing. Among the viruses which reacted poorly with ferret antisera raised against A/Hong Kong/4801/2014-like viruses, 18 out of 22 (81.8%) are more closely related to A/Switzerland/9715293/2013, a virus belonging to genetic group 3C.3a.

### Influenza B Virus [560]

- **Victoria Lineage [248]:** 228 of 248 (91.9%) B/Victoria-lineage viruses were antigenically characterized using ferret post-infection antisera as B/Brisbane/60/2008-like, which is included as an influenza B component of the 2016-2017 Northern Hemisphere trivalent and quadrivalent influenza vaccines.
- **Yamagata Lineage [312]:** All 312 (100%) B/Yamagata-lineage viruses were antigenically characterized using ferret post-infection antisera as B/Phuket/3073/2013-like, which is included as an influenza B component of the 2016-2017 Northern Hemisphere quadrivalent influenza vaccines.

## 2017-2018 Influenza Season – U.S. Influenza Vaccine Composition:

The World Health Organization (WHO) has recommended the Northern Hemisphere 2017-2018 influenza vaccine composition, and the Food and Drug Administration's Vaccines and Related Biological Products Advisory Committee (VRBPAC) subsequently made the influenza vaccine composition recommendation for the United States. Both agencies recommend that trivalent vaccines contain an A/Michigan/45/2015 (H1N1)pdm09-like virus, an A/Hong Kong/4801/2014 (H3N2)-like virus, and a B/Brisbane/60/2008-like (B/Victoria lineage) virus. It is recommended that quadrivalent vaccines, which have two influenza B viruses, contain the viruses recommended for the

trivalent vaccines, as well as a B/Phuket/3073/2013-like (B/Yamagata lineage) virus. This is the same recommendation made for the 2017 Southern Hemisphere vaccines, but it does represent an update to the influenza A (H1N1) component recommended for 2016-2017 Northern Hemisphere influenza vaccines. These vaccine recommendations were based on several factors, including global influenza virologic and epidemiologic surveillance, genetic characterization, antigenic characterization, antiviral resistance, and the candidate vaccine viruses that are available for production.

## Antiviral Resistance:

Testing of influenza A (H1N1)pdm09, influenza A (H3N2), and influenza B virus isolates for resistance to neuraminidase inhibitors (oseltamivir, zanamivir, and peramivir) is performed at CDC using a functional assay. Additional influenza A (H1N1)pdm09 and influenza A (H3N2) viruses from clinical samples are tested for mutations known to confer oseltamivir resistance. The data summarized below combine the results of both testing methods. These samples are routinely obtained for surveillance purposes rather than for diagnostic testing of patients suspected to be infected with antiviral-resistant virus.

High levels of resistance to the adamantanes (amantadine and rimantadine) persist among influenza A (H1N1)pdm09 and influenza A (H3N2) viruses (the adamantanes are not effective against influenza B viruses). Therefore, data from adamantane resistance testing are not presented below.

The majority of recently circulating influenza viruses are susceptible to the neuraminidase inhibitor antiviral medications, oseltamivir, zanamivir, and peramivir; however, rare sporadic instances of oseltamivir-resistant and peramivir-resistant influenza A (H1N1)pdm09 viruses and oseltamivir-resistant influenza A (H3N2) viruses have been detected worldwide. Antiviral treatment as early as possible is recommended for patients with confirmed or suspected influenza who have severe, complicated, or progressive illness; who require hospitalization; or who are at [high risk](#) for serious influenza-related complications. ## [Pneumonia and Influenza \(P&I\) Mortality Surveillance:](#)

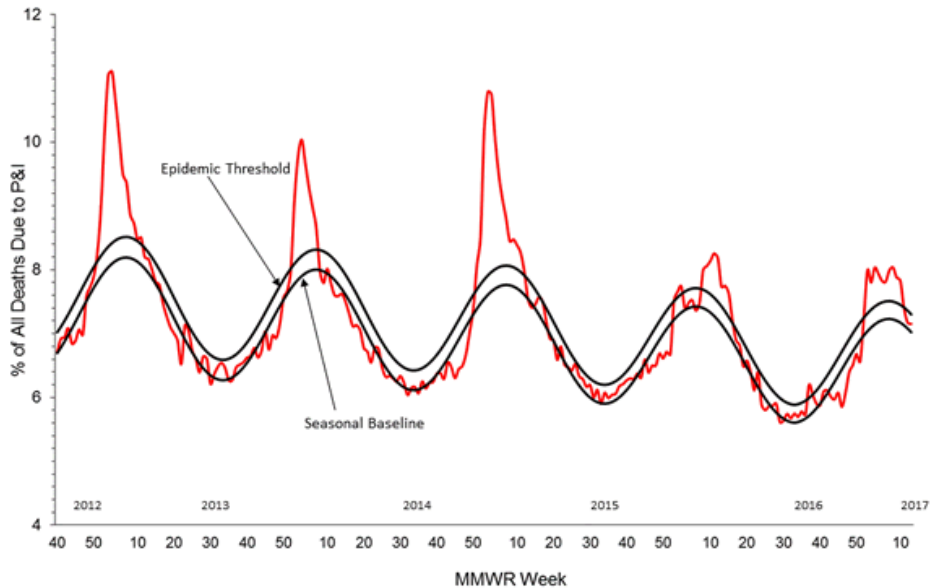
Based on National Center for Health Statistics (NCHS) mortality surveillance data available on April 20, 2017, 7.2% of the deaths occurring during the week ending April 1, 2017 (week 13) were due to P&I.; This percentage is below the epidemic threshold of 7.3% for week 13.

Background: Weekly mortality surveillance data include a combination of machine coded and manually coded causes of death collected from death certificates. There is a backlog of data requiring manual coding within NCHS mortality surveillance data. The percentages of deaths due to P&I; are higher among manually coded records than more rapidly available machine coded records and may result in initially reported P&I; percentages that are lower than percentages calculated from final data. Efforts continue to reduce and monitor the number of records awaiting manual coding.

Beginning in the week ending October 8, 2016 (week 40), CDC retired the 122 Cities Mortality Reporting System and uses only the NCHS Mortality Surveillance System.

Data through the week ending April 1, 2017, as of April 20, 2017



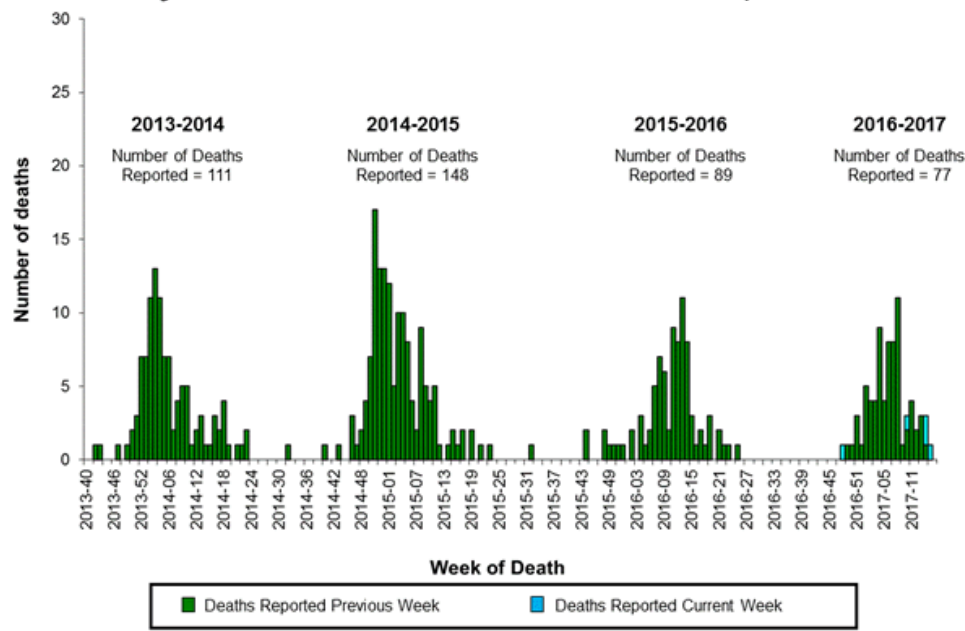

## **Influenza-Associated Pediatric Mortality:**

Five influenza-associated pediatric deaths were reported to CDC during week 15. Four deaths were associated with an influenza A (H3) virus and occurred during weeks 10, 14 and 15 (the weeks ending March 11, April 8, and April 15, 2017, respectively). One death was associated with an influenza B virus and occurred during week 48 (the week ending December 3, 2016). A total of 77 influenza-associated pediatric deaths have been reported for the 2016-2017 season.

## Influenza-Associated Hospitalizations:

The Influenza Hospitalization Surveillance Network (FluSurv-NET) conducts population-based surveillance for laboratory-confirmed influenza-related hospitalizations in children younger than 18 years of age (since the 2003-2004 influenza season) and adults (since the 2005-2006 influenza season).

The FluSurv-NET covers more than 70 counties in the 10 Emerging Infections Program (EIP) states (CA, CO, CT, GA, MD, MN, NM, NY, OR, and TN) and additional Influenza Hospitalization Surveillance Project (IHSP) states. The IHSP began during the 2009-2010 season to enhance surveillance during the 2009 H1N1 pandemic. IHSP sites included IA, ID, MI, OK and SD during the 2009-2010 season; ID, MI, OH, OK, RI, and UT during the 2010-2011 season; MI, OH, RI, and UT during the 2011-2012 season; IA, MI, OH, RI, and UT during the 2012-2013 season; and MI, OH, and UT during the 2013-2014, 2014-2015, 2015-2016, and 2016-2017 seasons.

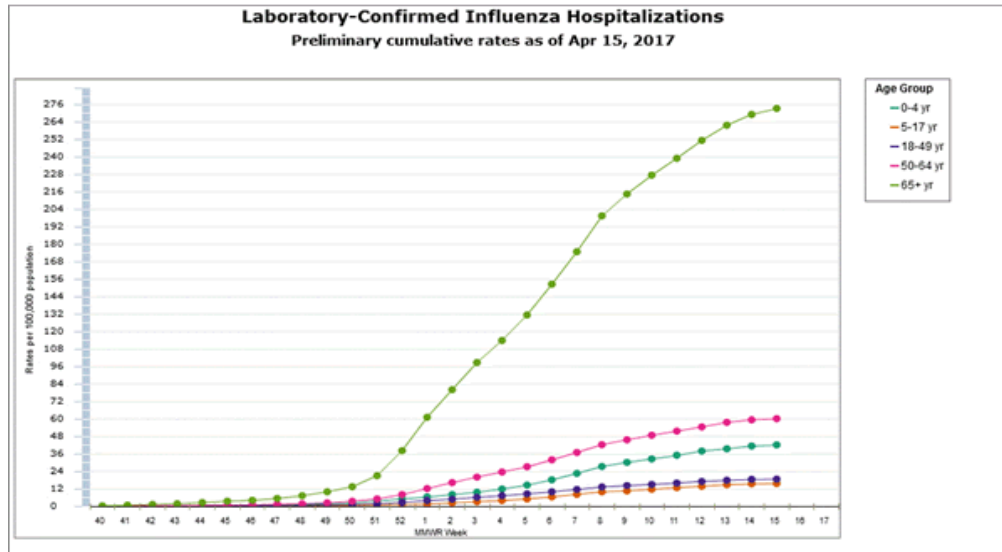
Data gathered are used to estimate age-specific hospitalization rates on a weekly basis, and describe characteristics of persons hospitalized with severe influenza illness. The rates provided are likely to be an underestimate as influenza-related hospitalizations can be missed, either because testing is not performed, or because cases may be attributed to other causes of pneumonia or other common influenza-related complications.

Between October 1, 2016 and April 15, 2017, 17,055 laboratory-confirmed influenza-associated hospitalizations were reported. The overall hospitalization rate was 60.9 per 100,000 population. The highest rate of hospitalization was among adults aged  $\geq 65$  years (273.4 per 100,000 population), followed by adults aged 50-64 (60.2 per 100,000 population) and children aged 0-4 years (42.1 per 100,000 population). Among 17,055 hospitalizations, 13,793 (80.9%) were associated with influenza A virus, 3,161 (18.5%) with influenza B virus, 51 (0.3%) with influenza A virus and influenza B virus co-infection, and 47 (0.2%) with influenza virus for which the type was not determined. Among those with influenza A subtype information, 4,816 (97.9%) were A(H3N2) and 101 (2.1%) were A(H1N1)pdm09 virus.

Clinical findings are preliminary and based on 3,454 (20.3%) cases with complete medical chart abstraction. Among 3,219 hospitalized adults with complete medical chart abstraction, 3,040 (94.4%) had at least one reported underlying medical condition; the most commonly reported were cardiovascular disease, metabolic disorders, obesity and chronic lung disease. Among 235 hospitalized children with complete medical chart abstraction, 117 (49.8%) had at least one underlying medical condition; the most commonly reported were asthma, neurologic disorder, chronic lung disease, and obesity. Among the 207 hospitalized women of childbearing age (15-44 years), 53 (25.6%) were pregnant.

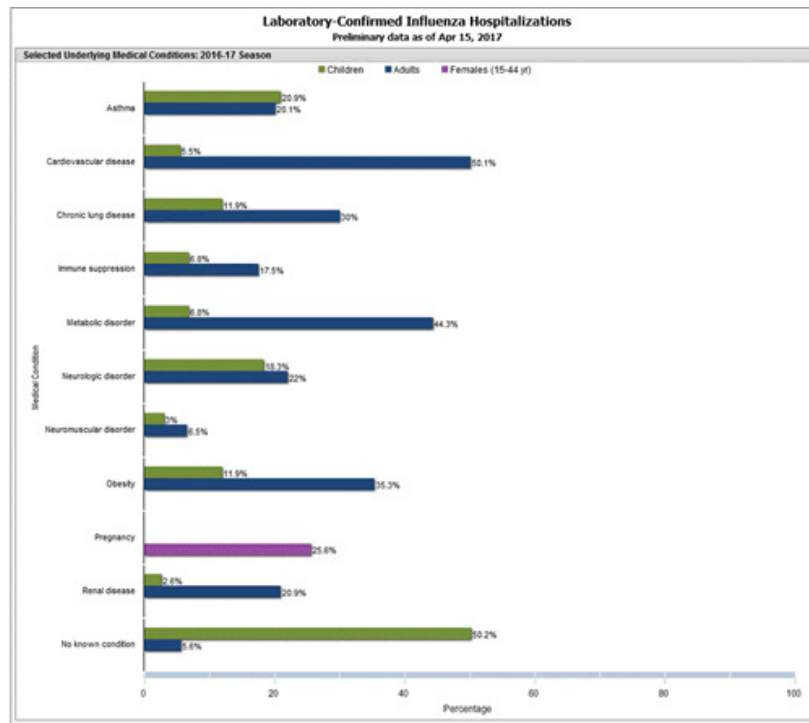

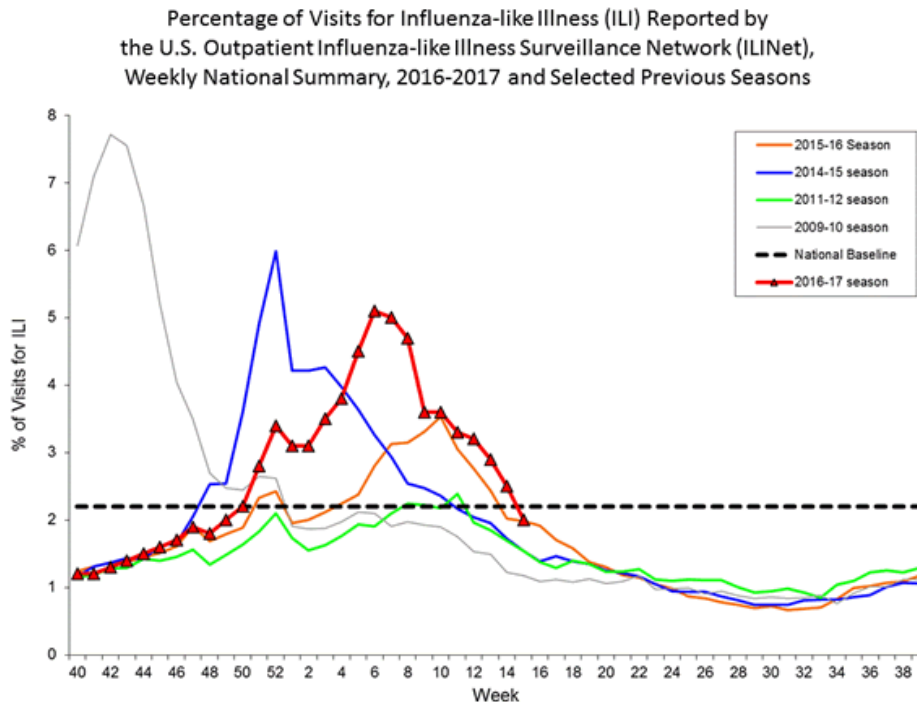
FluSurv-NET data are preliminary and displayed as they become available. Therefore, figures are based on varying denominators as some variables represent information that may require more time to be collected. Data are refreshed and updated weekly. Asthma includes a medical diagnosis of asthma or reactive airway disease; Cardiovascular diseases include conditions such as coronary heart disease, cardiac valve disorders, congestive heart failure, and pulmonary hypertension; does not include isolated hypertension; Chronic lung diseases include conditions such as chronic obstructive pulmonary disease, bronchiolitis obliterans, chronic aspiration pneumonia, and interstitial lung disease; Immune suppression includes conditions such as immunoglobulin deficiency, leukemia, lymphoma, HIV/AIDS, and individuals taking immunosuppressive medications; Metabolic disorders include conditions such as diabetes mellitus; Neurologic diseases include conditions such as seizure disorders, cerebral palsy, and cognitive dysfunction; Neuromuscular diseases include conditions such as multiple sclerosis and muscular dystrophy; Obesity was assigned if indicated in patient's medical chart or if body mass index (BMI) >30 kg/m<sup>2</sup>; Pregnancy percentage calculated using number of female cases aged between 15 and 44 years of age as the denominator; Renal diseases include conditions such as acute or chronic renal failure, nephrotic syndrome, glomerulonephritis, and impaired creatinine clearance; No known condition indicates that the case did not have any known high risk medical condition indicated in medical chart at the time of hospitalization.

## Outpatient Illness Surveillance:

Nationwide during week 15, 2.0% of patient visits reported through the U.S. Outpatient Influenza-like Illness Surveillance Network (ILINet) were due to influenza-like illness (ILI). This percentage is below the national baseline of 2.2%. (*ILI is defined as fever (temperature of 100.4°F [37.8°C] or greater) and cough and/or sore throat.*)

On a regional level, the percentage of outpatient visits for ILI ranged from 0.7% to 3.2% during week 15. Three regions (Regions 1, 2, and 4) reported a proportion of outpatient visits for ILI at or above their region-specific baseline levels.

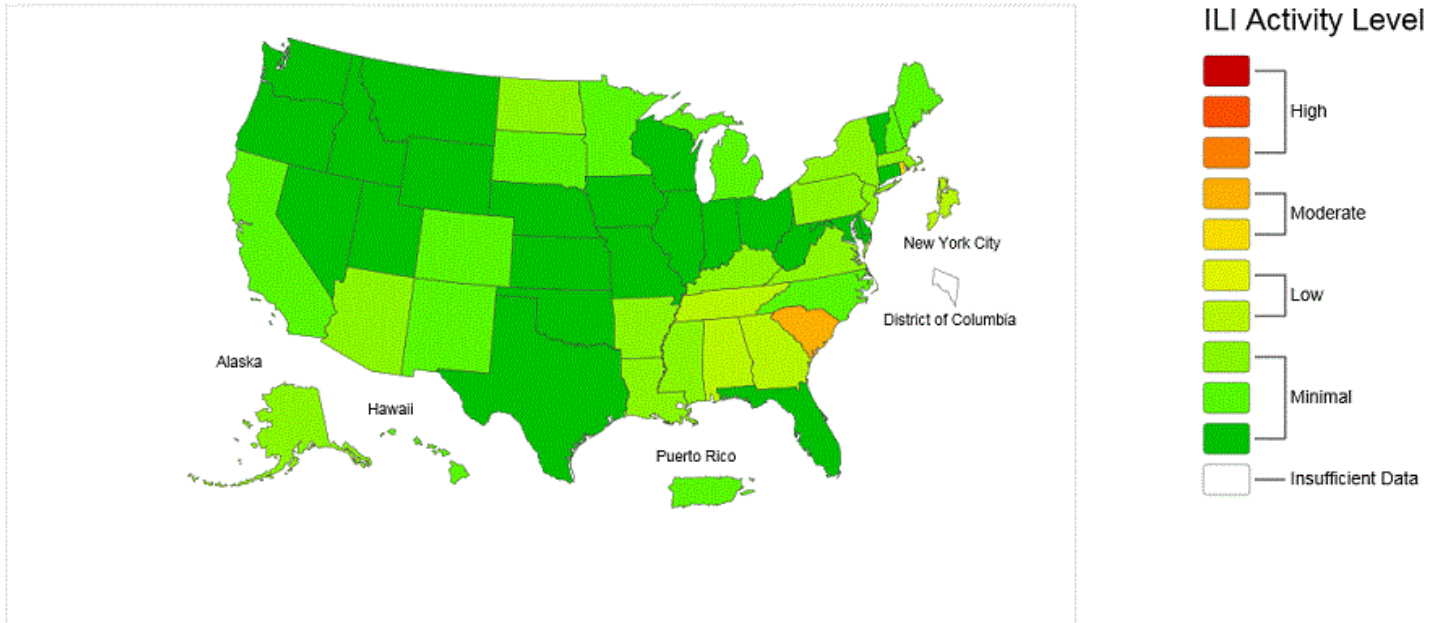
## ILINet State Activity Indicator Map:

Data collected in ILINet are used to produce a measure of ILI activity\* by state. Activity levels are based on the percent of outpatient visits in a state due to ILI and are compared to the average percent of ILI visits that occur during weeks with little or no influenza virus circulation. Activity levels range from minimal, which would correspond to ILI activity from outpatient clinics being below, or only slightly above, the average, to high, which would correspond to ILI activity from outpatient clinics being much higher than average.

During week 15, the following ILI activity levels were experienced:

- Two states (Rhode Island and South Carolina) experienced moderate ILI activity.
- New York City and three states (Alabama, Georgia, and Tennessee) experienced low ILI activity.
- Puerto Rico and 45 states (Alaska, Arizona, Arkansas, California, Colorado, Connecticut, Delaware, Florida, Hawaii, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Massachusetts, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Carolina, North Dakota, Ohio, Oklahoma, Oregon, Pennsylvania, South Dakota, Texas, Utah, Vermont, Virginia, Washington, West Virginia, Wisconsin, and Wyoming) experienced minimal ILI activity.
- Data were insufficient to calculate an ILI activity level from the District of Columbia.

\*This map uses the proportion of outpatient visits to health care providers for ILI to measure the ILI activity level within a state. It does not, however, measure the extent of geographic spread of flu within a state. Therefore, outbreaks occurring in a single city could cause the state to display high activity levels.

**Data collected in ILINet may disproportionately represent certain populations within a state, and therefore, may not accurately depict the full picture of influenza activity for the whole state.**

Data displayed in this map are based on data collected in ILINet, whereas the State and Territorial flu activity map is based on reports from state and territorial epidemiologists. The data presented in this map are preliminary and may change as more data are received.

Differences in the data presented here by CDC and independently by some state health departments likely represent differing levels of data completeness with data presented by the state likely being the more complete.

### [Geographic Spread of Influenza as Assessed by State and Territorial Epidemiologists](#)

The influenza activity reported by state and territorial epidemiologists indicates geographic spread of influenza viruses, but does not measure the severity of influenza activity.

During week 15, the following influenza activity was reported:

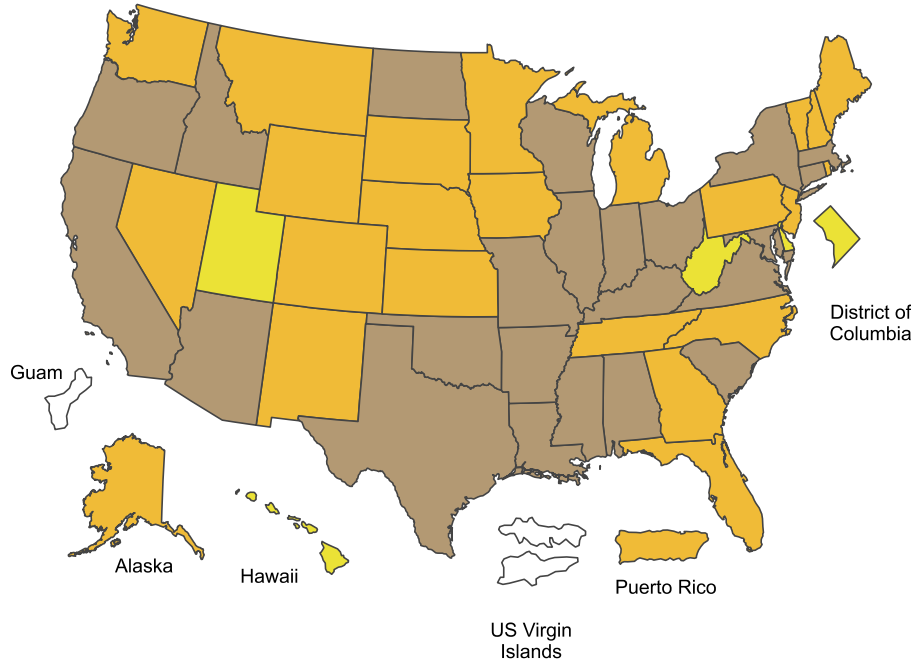
- Widespread influenza activity was reported by 10 states (Alaska, Connecticut, Delaware, Maine, Massachusetts, New Hampshire, New York, North Carolina, Ohio, and Rhode Island).
- Regional influenza activity was reported by Guam, Puerto Rico, and 15 states (Arizona, Florida, Iowa, Kentucky, Michigan, Minnesota, Missouri, Nevada, New Jersey, North Dakota, Oklahoma, Pennsylvania, South Carolina, Texas, and Vermont).
- Local influenza activity was reported by the District of Columbia and 19 states (Arkansas, California, Georgia, Idaho, Kansas, Louisiana, Maryland, Mississippi, Montana, Nebraska, New Mexico, Oregon, South Dakota, Tennessee, Virginia, Washington, West Virginia, Wisconsin, and Wyoming).
- Sporadic activity was reported by six states (Alabama, Colorado, Hawaii, Illinois, Indiana, and Utah).
- No influenza activity was reported by the U.S. Virgin Islands.
