

NMI Overall Updates

Update on Publication Location of 2016 NNDSS Data

- In response to a CDC-wide workgroup composed of the CDC Excellence in Science Committee, Surveillance Science Advisory Group, and the *Morbidity and Mortality Weekly Report (MMWR)* and as part of NMI, the *MMWR Summary of Notifiable Infectious Diseases and Conditions for 2015* data will be the last report published in its current format in *MMWR*.
- Beginning with 2016 data, the introductory information that does not change from year-to-year will be integrated into the NNDSS website. Links to tables 1–7 and links to surveillance reports about NNDSS data that are published by CDC programs will be available on the NNDSS Data and Statistics page at <https://wwwn.cdc.gov/nndss/data-and-statistics.html>. Data tables 1–7 also will be available in HTML, text, and PDF on the CDC Wide-ranging Online Data for Epidemiologic Research (WONDER) platform.
- As indicated in the 2016 production calendar, there will be no changes made to the 2016 data after 6/30/17, when state epidemiologists have signed off on the data to be published. Therefore, it is extremely important that CDC programs continuously work with state partners to finalize the data prior to this date.

Message Validation, Processing, and Provisioning System (MVPS) Updates

- The MVPS team implemented MVPS Release 2.3 on 4/14/17.
 - The team updated condition codes in MVPS based on the latest NNDSS 2017 event code list.
 - Stricter validation rules were added to MVPS for the “Date First Electronically Submitted” and “Date of Electronic Case Notification to CDC” data elements.
 - Various Message Evaluation and Testing Service (METS) user interface updates were made (e.g., METS font was modified to have a fixed-width for improved readability).

- The NMI team encourages all non-pilot jurisdictions to complete the Secure Access Management Services (SAMS) proofing process and confirm their access with the MVPS support team. HL7 Case Notification Messages in Production

Arboviral v1.3

- States now in production for Arboviral v1.3 include Florida, New York, South Dakota, Tennessee, Texas, and Wisconsin. Idaho is engaged in onboarding.
- CDC is resolving some issues affecting Arboviral v1.3 onboarding and expects to fully re-open onboarding to states soon.



Generic v2

- States now in production for Generic v2 include Florida, Michigan, Minnesota, New York, and Oregon.
- States in the onboarding process for Generic v2 include Alaska, Mississippi, and New Hampshire. California is expected to begin the onboarding process soon.

Hepatitis

- States now in production for Hepatitis include Florida, Idaho, Michigan, Minnesota, and Oregon. California is expected to begin the onboarding process soon.

Babesiosis (Stage 1—Draft)

- CDC is reviewing and addressing comments from the external review of the draft guide.

- CDC will post the guide for comment, and a CSTE-hosted webinar will be used to introduce the draft MMG and solicit feedback from all jurisdictions.
