## Provisional Data as of July 5, 2017

Zika virus disease is a nationally notifiable condition. Cases are reported to CDC by state, territorial, and local health departments using standard case definitions. This webpage contains provisional data reported to ArboNET for **January 1**, **2017** – **July 5**, **2017**.

### **US States**

- 148 symptomatic Zika virus disease cases reported\*
  - 147 cases in travelers returning from affected areas
  - 0 cases acquired through presumed local mosquito-borne transmission
  - 1 case acquired through sexual transmission

#### **US Territories**


- 515 symptomatic Zika virus disease cases reported\*
  - 0 cases in travelers returning from affected areas
  - 515 cases acquired through presumed local mosquito-borne transmission
  - 0 cases acquired through other routes†

\*Excludes congenital disease cases. †Sexually transmitted cases are not reported for US territories because with local transmission of Zika virus it is not possible to determine whether infection occurred due to mosquito-borne or sexual transmission.

#### **Footnotes**

†Presumptive viremic blood donors are people who reported no symptoms at the time of donating blood, but whose blood tested positive when screened for the presence of Zika virus RNA by the blood collection agency. Some presumptive viremic blood donors develop symptoms after their donation or may have had symptoms in the past. These individuals may be reported as both Zika virus disease cases and presumptive viremic blood donors.
