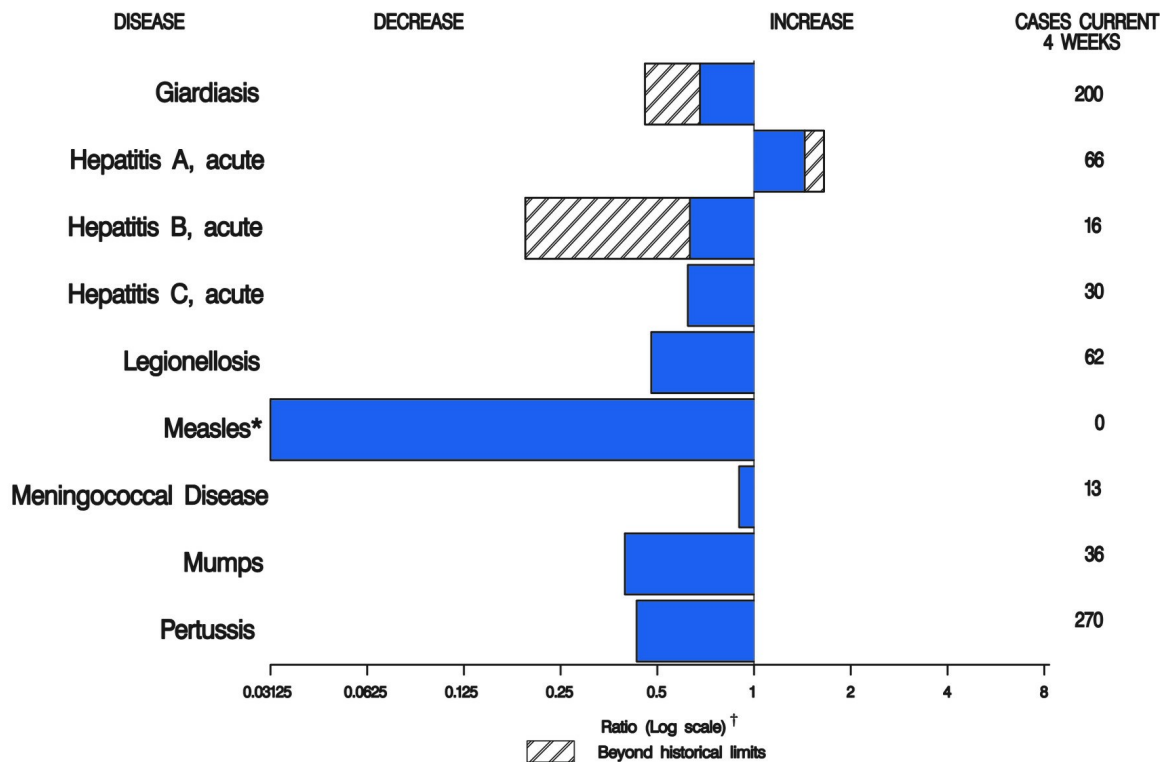


National Notifiable Infectious Diseases: Weekly Tables

FIGURE I. Selected notifiable disease reports, United States, comparison of provisional 4-week totals January 13, 2018, with historical data



The figure above is a bar chart showing selected notifiable disease reports for the United States with comparison of provisional 4-week totals through January 13, 2018, with historical data. Reports of acute hepatitis A increased beyond historical limits. Reports of giardiasis, acute hepatitis B, acute hepatitis C, legionellosis, measles, meningococcal disease, mumps and pertussis decreased with giardiasis and acute hepatitis B decreasing beyond historical limits.

* No measles cases were reported for the current 4-week period yielding a ratio for week 2 of zero (0).

† Ratio of current 4-week total to mean of 15 4-week totals (from previous, comparable, and subsequent 4-week periods for the past 5 years). The point where the hatched area begins is based on the mean and two standard deviations of these 4-week totals.

Notes:

- These are **weekly** cases of selected infectious national notifiable diseases, from the National Notifiable Diseases Surveillance System (NNDSS). NNDSS data reported by the 50 states, New York City, the District of Columbia, and the U.S. territories are collated and published weekly as numbered tables. Cases reported by state health departments to CDC for weekly publication are subject to ongoing revision of information and delayed reporting. Therefore, numbers listed in later weeks may reflect changes made to these counts as additional information becomes available. Case counts in the tables are presented as *published* each week.
