EXTINGUISHING THE TOBACCO EPIDEMIC in

SOUTH DAKOTA

THE PROBLEM

Cigarette smoking remains the leading cause of preventable death and disability in the United States, despite a significant decline in the number of people who smoke. Over 16 million Americans have at least one disease caused by smoking. This amounts to \$170 billion in direct medical costs that could be saved every year if we could prevent youth from starting to smoke and help every person who smokes to quit.

PUBLIC HEALTH RESPONSE TO TOBACCO USE IN SOUTH DAKOTA

There is no safe level of exposure to secondhand smoke. It causes stroke, lung cancer, and coronary heart disease in adults. South Dakota has a comprehensive smoke-free law that prohibits smoking in all indoor areas of workplaces, restaurants, and bars that has been in effect since 2010. Since that law was adopted, South Dakota has continued to inform efforts that protect residents from exposure to secondhand smoke. Upon request, the state provides research, data and analysis, and scientific consultation to communities, multiunit housing operators, hospitals, businesses, and colleges and universities that want to protect residents from secondhand smoke. Currently, 7 colleges or universities in the state have smoke-free or tobacco-free campus policies, including 4 smoke-free campuses for the University of South Dakota and 13 tobacco-free campuses for Oglala Lakota College, which serves the Pine Ridge Indian Reservation. Tobacco-free environments mean that no tobacco product is used at any time, whereas smoke-free environments prohibit the use of combusted tobacco products only.

CDC's ROLE IN ADVANCING STATE TOBACCO CONTROL PROGRAMS

South Dakota is one of 50 states plus DC that receives funding and technical support from the Centers for Disease Control and Prevention to support comprehensive tobacco control efforts and quitlines. The Office on Smoking and Health (OSH) is the lead federal agency for comprehensive tobacco prevention and control. For decades, OSH has led public health efforts to prevent young people from using tobacco and to help all tobacco users to quit.

1-800-QUIT-NOW

Despite significant progress, tobacco use remains the leading preventable cause of death and disease in the US. The good news is that 7 out of 10 smokers want to quit smoking. That is why since 2012 CDC has been educating the public about the consequences of smoking and exposure to secondhand smoke and encouraging smokers to quit through a federally funded, national tobacco education campaign, *Tips From Former Smokers*. The campaign features former smokers suffering from the real consequences of smoking.

The *Tips* campaign connects smokers with resources to help them quit, including a quitline number (1-800-QUIT-NOW) which routes callers to their state quitline. The South Dakota quitline provides free cessation services, including counseling and medication. These services are effective in improving health outcomes and reducing healthcare costs.

Incoming calls to the South Dakota state quitline increased by an average **228%** during the 2016 Tips campaign. The Campaign generated a total of **525** calls to the South Dakota state quitline from January 25th to June 12th, 2016.

SOUTH DAKOTA TOBACCO PREVENTION & CONTROL PROGRAMS REDUCE HEALTHCARE COSTS

Tobacco prevention and control activities are a public health "best buy." Evidence-based, statewide tobacco control programs that are comprehensive, sustained, and accountable have been shown to reduce the number of people who smoke, as well as tobacco-related diseases and deaths. For every dollar spent on tobacco prevention, states can reduce tobacco-related health care expenditures and hospitalizations by up to \$55. The longer and more states invest, the larger the reductions in youth and adult smoking. A comprehensive statewide tobacco control program includes efforts to:

Prevent initiation of tobacco use especially among youth and young adults

Promote cessation and assist tobacco users to quit
