Purpose and Description of Cancer Mortality Among American Indians and Alaska Natives: Regional Differences, 1999–2003

This monograph reports regional cancer mortality rates among American Indians and Alaska Natives (Al/ANs) within areas served by the U.S. Department of Health and Human Services (DHHS), Indian Health Service (IHS). These areas are comprised of certain counties found within 35 states. Al/ANs residing in these counties represent about 56% of the total Al/AN bridged single-race population in the United States. We present the cancer mortality rates for 1999–2003 for the principal cancer types and compare them with the general U.S. population rates during the same period. We also present the estimated IHS service population for each region. The purpose of this publication is to provide detailed information on the impact of cancer among Al/ANs, with a focus on the regional variability of cancer mortality for this population.

This publication was made possible by the partnership between the IHS Division of Epidemiology and Disease Prevention and the Centers for Disease Control and Prevention (CDC) Division of Cancer Prevention and Control, utilizing resources available from the National Cancer Institute, National Institutes of Health, and CDC's National Center for Health Statistics.

Overview of the Indian Health Service

IHS is responsible for providing health services to members of federally recognized AI/AN tribes on the basis of laws passed by the U.S. Congress pursuant to its authority to regulate commerce with the Indian nations as explicitly specified in the *U.S. Constitution* and in other pertinent authorities. On August 5, 1954, the Indian health program became a primary responsibility of the U.S. Public Health Service (USPHS) under the Transfer Act (Public Law 83-568). This act provides that all functions, responsibilities, authorities, and duties relating to the maintenance and operation of the hospital and health facilities for AI/ANs and the conservation of Indian health shall be administered by the Surgeon General of USPHS.¹

The IHS mission, in partnership with AI/AN people, is to raise their physical, mental, social, and spiritual health to the highest level possible. The IHS goal is to ensure that comprehensive, culturally acceptable personal and public health services are available and accessible to all AI/AN people. To carry out this goal, IHS acts as the principal federal health advocate for Indian people.²

IHS has implemented its responsibility by developing and operating a health service delivery system designed to provide a broad-spectrum program of preventive, curative, rehabilitative, and environmental services. This system integrates health services delivered directly through IHS facilities and staff with those purchased by IHS through contractual arrangements, taking into account other health resources to which Al/ANs have access. Tribes are also actively involved in program implementation.

Two key laws enacted to improve the health status of AI/ANs are described as follows:

- The 1975 Indian Self-Determination and Education Assistance Act, Public Law 93-638, as amended, builds on IHS programs in their communities and provides funding for improvement of tribal capability to contract under the act.³ Under this act, tribes can chose to continue to receive health services provided directly by IHS or they can opt to take control of their own health-care services by managing IHS funding directly. They can also selectively manage certain components of their health services and leave others to IHS. Approximately half of the IHS budget is transferred directly to tribes under self-governance arrangements, and more tribes are expected to do so in the future. As these tribes move to self-governance for health services, they are going to rely increasingly on regional health profiles to guide them in strategic planning for optimal use of these resources.
- The 1976 Indian Health Care Improvement Act, Public Law 94-437, as amended, was intended to elevate the health status of AI/ANs to a level equal to that of the general population through a program of authorized higher resource levels in the IHS budget. Appropriated resources were used to expand health services, build and renovate medical facilities, and set up the construction of safe drinking water and sanitary disposal facilities. It also established programs designed to increase the number of AI/AN health professionals and to improve health-care access for AI/AN people living in urban areas.

Indian Health Service Structure

The IHS health services delivery system is managed through local administrative units. A service unit is the basic health organization for a geographic area served by IHS, just as a county or city health department is the basic health organization in a state health department. These are defined areas, usually centered around a single federal reservation within the continental United States, or a population concentration in Alaska. A limited number of service units cover multiple small reservations; certain large reservations are divided into multiple service units. All of IHS service units are grouped into the following 12 larger cultural-demographic management jurisdictions known as IHS Area offices:⁵

As of January 2007, the Area offices consisted of 164 IHS and tribally managed service units. IHS operated 33 hospitals, 52 health centers, 38 health stations, and two school health centers. Al tribes and AN corporations operated 15 hospitals, 220 health centers, 116 health stations, 162 Alaska village clinics, and nine school health centers.⁶

Cancer Mortality Among Al/ANs: Regional Differences, 1999–2003

INTRODUCTION

IHS has strived to improve the health of Al/ANs in the United States for >50 years. The results have been marked decreases in infectious disease mortality and infant and maternal mortality. Since 1973, life expectancy at birth for Al/ANs nationally has increased by >9 years and is now at 74.5 years. However, this is still approximately 2.4 years less than that for the U.S. general population. With these improvements in health status and increased life span, chronic diseases have begun to impact heavily on the Al/AN community. Malignant neoplasms are the second leading cause of death for Al/ANs throughout the country. In Alaska, cancer is the leading cause of death among ANs. Although the majority of detailed cancer surveillance, including cancer mortality, has focused on Al/AN populations in the Southwest and Alaska 10-18, selected authors have examined cancer trends nationally.

In 1997, Cobb and Paisano examined cancer mortality trends for 1989–1993 for Al/AN populations residing in counties on or near Indian reservations. They reported that the Al/AN population had overall lower cancer mortality when examined nationally, yet displayed marked regional variation when examined at the IHS Area level. Garguillo et al. reported trends in mortality for four major cancers (lung/bronchus, colorectal, prostate, and breast) by sex and race/ethnicity for 1990–1998. They determined that cancer mortality among Al/AN either increased for a given cancer and sex while decreasing in other major racial/ethnic groups (most common), or Al/AN experienced proportionally greater increases or proportionally smaller decreases in cancer mortality (prostate). Because they did not attempt to adjust for the known racial misclassification for Al/ANs in state vital records, the rates are probably underestimates. Consequently, the disparities would likely be greater if racial misclassification were accounted for. Espey et al. compared 1990–1995 with 1996–2001 data and determined that there was an increase in cancer mortality during the latter period for Al/ANs, whereas cancer mortality had decreased in the United States for all races combined. Especial positions are reported to the united States for all races combined.

Initial IHS cancer mortality monographs ^{24, 27} reported cancer mortality data for the 12 IHS administrative Areas (IHS Areas). ⁵ The tables and charts in the most recent IHS cancer mortality monograph depicted broader geographic regions instead of IHS Areas. ²⁰ In this monograph, mortality rates are again reported by geographic region, with the addition of a sixth region (Southern Plains).

These studies and publications revealed certain key points. First, U.S. Al/AN mortality rates differ substantially from U.S. rates for all races combined. Second, marked regional differences exist in rates of cancer mortality and incidence among Al/ANs in the United States. Third, recent trends in Al/AN cancer mortality are substantially different and typically less favorable, compared with other major racial/ethnic groups. Most of these studies used different methodologies and different study periods, making comparisons difficult. This report provides data regarding cancer mortality among Al/ANs

and, by using similar methods, allows comparison with data collected during previous periods.

METHODS AND SOURCES OF DATA

Denominators — IHS Service Population and United States All-races Population All mortality rates and population estimates for this monograph were calculated using SEER*Stat (Surveillance Epidemiology and End Results), Version 6.3.5 (available at http://seer.cancer.gov/seerstat/).²⁸ CDC's National Center for Health Statistics (NCHS) provides the underlying mortality data for SEER*Stat databases. The IHS service population counts used in this monograph are based on U.S. Census Bureau intercensal county population estimates, updated in February 2006, after adjustments based on the 2000 census were made under an interagency agreement between the National Institutes of Health (NIH)/National Cancer Institute (NCI) and the U.S. Census Bureau. During the decennial census, the U.S. Census Bureau enumerates those persons who identify themselves as AI/AN. The intercensal estimates are developed by using a cohort-component method whereby each component of population change — births, deaths, domestic migration, and international migration — is estimated separately for each birth cohort by sex, race, and Hispanic origin.²⁹ The IHS service population is estimated by including only Al/ANs who reside in counties in which IHS has clinical facilities or that are in or adjacent to federally recognized Indian lands (IHS service areas). These counties are referred to by IHS as contract health service delivery areas (CHSDA). The IHS service population refers to the AI/AN population residing in CHSDA counties — regardless if they use IHS services.


County-level population estimates from the U.S. Census Bureau that were modified by NCI were used as denominators in the rate calculations.³⁰ The 2000 census allowed respondents to identify themselves as multiracial. Because of this, NCHS and the U.S. Census Bureau developed bridging methods for single-race estimates to describe long-term trends in disease.³¹ This bridging method has a substantial impact on AI/AN bridged population counts. For the United States as a whole, the bridged AI/AN population count is 12.0% higher than the single-race count.

During 1999–2003, the average annual IHS service population was 1,694,439 persons, whereas the average for the entire Al/AN bridged single-race population in the United States was estimated at 3,007,510 persons (Table 1, columns 2 and 3). Of the six regions chosen for this monograph, the Southwest region has the largest IHS service population (approximately 520,437 persons), distributed in five states and including four IHS Areas (Figure 1). Next is the Pacific Coast region (369,217 persons), representing five states and two IHS Areas. The Southern Plains region, representing three states and two IHS Areas, has 327,262 persons. The Northern Plains region, representing 11 states and three IHS Areas, has 265,912 persons. Alaska (108,462 persons) represents one state and one IHS Area, and the East region, representing 25 states and Washington, DC, and one IHS Area, has 103,149 persons. This distribution is represented in Table 1. Of note is that the population included in these regions does not reflect the concentration of Al/ANs in the United States. Rather, it is becoming a

standard method for analyzing and presenting Al/AN-specific data (see Change to Regional Analyses on page 7 of this monograph). There are several precedents for using regional analyses when analyzing Al/AN populations data. ^{19-23, 32, 33}

To remain consistent with past versions of the monograph, the United States all-race population rate was used as a reference group for comparison to the regional Al/AN rates. This reference group included all race/ethnic groups, including Al/AN, and included all fifty states and Washington, D.C. Although not presented in this report, the authors also compared regional Al/AN rates to rates among Non-Hispanic whites. Tables showing these comparisons can be found at the IHS Division of Epidemiology and Disease Prevention website (http://www.ihs.gov/medicalprograms/epi/index.cfm? module=health_issues&option=cancer&cat=sub_4). Not all states in the United States contain IHS service areas. In the 35 states that do, only a subset of counties are service/CHSDA counties. Figure 1 displays the states and CHSDA counties within each of the six regions used in this analysis. On the basis of the intercensal population estimates, approximately 56% of all Al/ANs in the United States reside within the geographic boundaries of the IHS service areas.

Numerator — Mortality Data

Al/AN vital event statistics are derived from data furnished by NCHS, who obtains birth and death records for all U.S. residents from the state health departments, on the basis of information reported on official state birth and death certificates. The records received from NCHS by IHS do not contain names, addresses, tribal identity, or medical record identification numbers. Each record includes the single underlying cause of death and is determined according to standard criteria and data listed on the death certificate. The records also contain county of residence, which allows selection of deaths of residents in counties located within IHS service areas. These investigators examined only those Al/AN deaths for 1999–2003 in which the underlying cause of death was cancer, as determined by *International Classification of Diseases*, 10th Revision (ICD-10) codes in the range of C00–C97 (Table 2).

The Al/AN vital events data in this publication pertain only to those Al/ANs residing at the time of their death in the counties that constitute the IHS service areas. By limiting the analysis to the Al/AN populations of IHS service counties where more awareness of Al/AN racial/ethnic identity exists, racial misclassification is minimized.³⁴

Because the Al/AN population is considerably younger than the U.S. all races population (Figures 2 and 3), and for reasons of comparability with recent analyses and publications, mortality rates presented in this report have been age-adjusted by the direct method, using the 2000 U.S. population as the age standard. An adjusted rate that was computed on the basis of a limited number of deaths should be interpreted with caution, because the adjusted rate might differ from the underlying rate. Cell suppressions were not applied in the case of small numbers, due to the desire of Al/AN populations to present these data, which have typically been suppressed in the past.




Change to Regional Analyses

The first two monographs presenting cancer mortality data for AI/AN used the IHS areas as the geographic unit of analysis. 24, 27 Although convenient and of interest for programmatic purposes, this approach posed problems. First, certain area rates were not stable because of a relatively limited number of cases. Second, certain counties were split between two or more IHS Areas; therefore, cases were arbitrarily assigned to one IHS Area or the other on the basis of their percentage coverage of that county. Lastly, use of IHS Area boundaries could imply tribal affiliation, to which tribal leaders and members might object. Despite the breakout of rates by IHS Area, the distinct patterns were often more regionally specific than IHS Area-specific. On the basis of these considerations, the ensuing monograph used broader regions of the country as the geographic unit of analysis, as opposed to IHS administrative areas. As in the previous reports, the analysis was restricted to CHSDA/service counties to mitigate the effects of misclassification. Since then an additional region has been proposed and this monograph includes this new region in calculating cancer mortality rates among Al/ANs. The new "Southern Plains" region was proposed as a result of feedback from several tribes in both eastern and southern plains states, stating that the cancer mortality rates of the original "East" region were not representative of the rates that they saw among their own populations. This regional approach addresses certain limitations of the IHS Area analysis and offers more stable rates on which to base programmatic decisions. It also offers a more standard approach by using state and county boundaries that are more consistent with census data and with analyses used by other entities. An additional method used to control for fluctuation in rates that occur when a relatively limited population and number of deaths exist is the aggregation of data throughout a 5-year period.

Analysis

Data were examined for all cancer deaths combined as well as for leading cancer sites and sites. Average annual age-adjusted mortality rates were calculated by using the estimated 1999–2003 population for each Region (Table 1, column 2). To compute 95% confidence intervals (CIs) for each rate, we used the method described by Fay and Feuer. We also calculated mortality rate ratios (MRRs) and 95% CIs, using the Breslow and Day method, to compare the relative difference in age-adjusted mortality rates with the U.S. general (USG) population for the same period. We also calculated mortality rates with the U.S. general (USG) population for the same period.

RESULTS

During 1999–2003, the average annual age-adjusted cancer mortality rate among Al/AN for all cancers for both sexes combined was 161.9/100,000 population for all regions combined. This rate was significantly lower than the rate for U.S. all races of 195.7/100,000 population (MRR, 0.83; CI, 0.81–0.85). Males had greater cancer mortality (191.2/100,000 population) than females (141.9/100,000 population), but both groups had significantly lower mortality when compared with the USG population (MRR, 0.78; CI 0.76–0.81 for males and MRR, 0.86; CI 0.84–0.89 for females).

Marked variation occurred among regions; the Southwest, East, Pacific Coast, and Southern Plains all had rates below the USG population (MRRs, 0.67, 0.71, 0.72 and 0.79, respectively). Alaska and the Northern Plains had higher rates (MRR, 1.24 and 1.30, respectively) for all cancers, both sexes combined. For all regions combined, MRRs for 12 leading causes of cancer death are illustrated in Figures 4–6. Tables of MMRs for specific cancer sites (by sex and region) are accessible at the IHS Division of Epidemiology and Disease Prevention website (http://www.ihs.gov/medicalprograms/epi/index.cfm?module=health_issues&option=cancer&cat=sub_4).

Lung cancer was the leading cause of cancer mortality in the United States as well as for the IHS service population overall (Table 16). Among Al/AN populations, for all regions combined, lung cancer was followed by colorectal cancer, miscellaneous malignant cancer, and breast and prostate cancers. Lung cancer was the leading cause of cancer death in all regions except the Southwest, where the leading category of cancer death for female and both sexes combined was miscellaneous malignant cancer. When we examined cancer mortality rates by specific cancer site and by sex, substantial variations among the regions were evident. Detailed results for 12 cancer sites are displayed in Figures 7–37 and Tables 3–15. For each region, the five leading causes of cancer mortality are listed in Table 16.

DISCUSSION

The data presented here demonstrate that the cancer mortality burden among Al/ANs throughout the United States is different from that of the USG population. In general, Al/ANs in the Southwest, East, Southern Plains, and Pacific Coast regions had lower cancer mortality rates than those in the northern part of the country. However, within any geographic region, mortality rates for specific cancers were not all lower or higher than the U.S. rates. For each specific type of cancer and for each sex, varying rankings by region were identified.

The variability in lung and bronchus cancer mortality observed among Al/ANs across regions (highest in Northern Plains, lowest in Southwest) is likely a consequence of the variability in tobacco use. Smoking prevalence among Al/AN adults is approximately 20% in the Southwest but is approximately 44% in both the northern plains and Alaska regions. Regional variability in cancer mortality for other cancers is more difficult to explain and might be linked to differences in diet, prevalence of obesity and alcoholism, or access to care or later stage diagnoses.

Limitations are well-recognized in using death certificate data to examine cause-specific mortality. These include racial misclassification, errors in listing the decedent's residence at time of death, and errors in reporting the precise cause of death. Studies have reported that racial misclassification of Al/ANs on death certificates is a problem in certain regions of the country. Additionally, data indicate that Al/ANs die more often than whites of what is termed "signs, symptoms, and ill-defined conditions". These two latter problems lead to underestimations of the overall cancer mortality rates as well as underestimations of mortality for specific types of cancer. Our analysis provides evidence that miscellaneous malignant cancers are the leading cause of cancer

mortality among the Al/AN population of the Southwest (for females and both sexes combined).

An additional limitation is that certain rates published in this monograph are based on only a limited number of cases. These have been included because AI/AN communities have expressed the need to no longer suppress these data; however, such rates should be interpreted with caution. The results of tests of statistical significance are noted for all comparisons with U.S. all-race rates in Tables 3–15.

All rates in this report were age-adjusted using the 2000 U.S. standard population to make them more comparable with current publications. Rates from previous IHS cancer mortality reports were based on the 1970 U.S. standard population. Changing to the 2000 U.S. standard population affects the magnitude of the rates. Cancer mortality rates based on the 2000 U.S. population may be higher than those calculated using the U.S. 1970 population since the 2000 U.S. population has an older age distribution, and cancer is more prevalent in older persons.

Although we used recently published census estimates, the degree to which errors might have occurred in the accurate counting of Al/ANs is not known precisely. However, evidence indicates that any errors would likely result in undercounting. Errors in using population figures that might be lower than the true numbers might lead to overestimation of the true cancer mortality rates for regions of the country where this was a problem.

Despite these limitations and changes, the findings included here clearly demonstrate that Al/ANs across the country experience different cancer mortality patterns both between regions and in comparison with U.S. all-race rates, and that Al/ANs in the Southwest have markedly different cancer mortality patterns from other Al/ANs in the United States.

To better understand the extent of cancer mortality among AI/ANs in the United States, further collaboration between CDC, IHS, and state vital records offices should be promoted and expanded. A study is underway that links IHS patient registration data with vital records data from approximately 25 states to identify AI/AN persons who have been misclassified as non-Native. Such collaborations can provide improved data for developing preventive programs and intervention strategies that should be targeted appropriately for specific populations. Improved cancer mortality data can illuminate the extent of the problem and help provide direction to decision makers regarding where to apply limited resources for the most beneficial impact.
































































