### **ACIP Hepatitis WG Terms of Reference**

- Update ACIP recommendations for hepatitis B vaccine
  - In October 2016, ACIP approved new hepatitis B vaccination recommendations
    - Currently in CDC clearance and will be published as a comprehensive summary of previously published recommendations from ACIP and CDC for the prevention of HBV infection in the United States

# **Today's session**

- Introduction: revaccination for unprotected infants born to hepatitis B surface antigen (HBsAg)-positive mothers who do not respond to the initial hepatitis B vaccination series
- Cost analysis: single-dose revaccination for infants born to HBsAg-positive mothers
- Vote
  - To request an ACIP vote (including a VFC vote) for approval of permissive language for single-dose revaccination followed by postvaccination serologic testing (and completion of the 2nd series followed by post-vaccination serologic testing, if necessary) for infants born to HBsAg-positive mothers
