
#### **NIS-Teen Overview**

- Annual survey implemented in 2006
- Uses National Immunization Survey (NIS) methodology
  - Random digit dial telephone survey (landline and cell phones)
  - National sample of parents of adolescents aged 13-17 years
  - Questionnaire mailed to providers to obtain vaccination history
  - Data weighted to adjust for non-response and phoneless households
- Estimates based on provider-reported vaccination histories
- Definition of adequate provider data (APD) revised in 2014
  - Retrospectively applied to 2013 NIS-Teen data to assess potential impact on estimates

### Key APD Assessment Findings


- 2014 NIS-Teen estimates using revised APD definition not comparable to those previously published
- Changes in coverage between 2013 and 2014 NIS-Teen best measured by comparing estimates that used revised APD definition

#### 2014 NIS-Teen Results

- Sample size:
  - National sample: 20,827 adolescents from 50 states and DC
    - 54% (11,243) from landline, 46% (9,584) from cell phone sampling frames
  - Puerto Rico: 230 adolescents (not included in national estimates)
- CASRO response rates\* increased vs. 2013:
  - Landline: 60.3% (+9.2 percentage points)
  - Cell phone: 31.2% (+7.9 percentage points)
- Adequate provider data:
  - Landline: 57.1%
  - Cell phone: 52.3%

## Estimated HPV Vaccination Coverage among Adolescents Aged 13-17 Years, NIS-Teen, United States, 2006-2014





### HPV Vaccination Coverage among Adolescents Aged 13-17 Years by Poverty Status, NIS-Teen, United States, 2014





#### HPV Vaccination Coverage among Adolescents Aged 13-17 Years by Race/Ethnicity, NIS-Teen, United States, 2014









### Summary (1)

- National HPV vaccination coverage increased in 2014
  - Modest increases among females, larger increases among males
  - Remains lower than Tdap and MenACWY vaccination coverage, suggesting persistent missed opportunities for HPV vaccination
  - Impact of recent interventions aimed at improving HPV vaccination at 11-12 years was not yet measurable in 2014 NIS-Teen
- HPV vaccination coverage is higher among:
  - Adolescents living below the poverty level
  - Hispanic and Non-Hispanic Black adolescents
- Considerable variation in HPV vaccination coverage by state and local area

### Summary (2)

- Continue to face challenges in improving HPV vaccination delivery to younger adolescents
  - In 2013, only 47% of females in most recent birth cohort initiated HPV vaccine series by 13<sup>th</sup> birthday
  - In 2014, coverage with ≥ HPV vaccine doses was low among adolescents aged 13-15 years
- Seven public health jurisdictions achieved improvement in HPV vaccination coverage among females
  - Five jurisdictions benefited from activities implemented using 2013 federal funding
  - Strategies used can inform activities in other jurisdictions
