□ Lower infant death rates and longer life expectancy as well as rising rates of venereal disease and higher medical costs are shown in a report on health in the United States in 1975 submitted to the Congress and the President by the Secretary of Health, Education, and Welfare (HEW).

□ Rates of infant deaths in the nation declined from 29.2 per 1,000 live births in 1950 to an estimated 16.5 in 1974. Over the same period, life expectancy at birth increased by nearly 4 years. The death rate for heart disease, the nation's major killer, is decreasing.

☐ The report, "Health, United States, 1975," includes data on health care costs and financing, health resources and utilization, and health status. The data are from four HEW components— Health Resources Administration, Social Security Administration, Center for Disease Control, and Alcohol, Drug Abuse, and Mental Health Administration—as well as from other Federal and non-Federal sources.

Over the past 10 years, the report shows, many of the striking differentials in the use of health services by people at different income levels have been substantially reduced. In 1964, 28 percent of the poor had not seen a physician within 2 years, in contrast with 17 percent in 1974. For those who were not poor, the respective proportions were 18 and 13 percent. ☐ But health care still takes a disproportionate share of the income of the poor. In families with incomes under \$2,000, a group with a high proportion of elderly persons who have high health expenses, about 13 percent of the family income is spent for health care. In families with incomes of \$7,500 or more, less than 4 percent of the income is used for health care.

☐ The report also shows a marked and continuing decline in the resident population of State and county mental hospitals—the result of a shift in treatment to outpatient facilities. In 1955 only 23 percent of the treatment episodes in mental health facilities were in outpatient facilities. In 1973, 65 percent of the episodes were outpatient.

☐ Health care has been taking an increasing share of the nation's total production of goods and services. By 1975 national health expenditures totaled approximately \$118 billion or 8.3 percent of the gross national product. In 1950 the expenditures were \$12.6 billion and less than 5 percent of the GNP. The change is due primarily to inflation and to increased use of services, including new and costly techniques of care.

□ Sources of payment of costs have shifted markedly. In 1950 more than two-thirds of personal health care costs were paid directly by the patient; in 1974 the patient's share was one-third of the total.

☐ The nation's supply of physicians has been growing far more rapidly than the population. Overall, the number of persons per physician decreased from 653 to 562 between 1965 and 1973, through increases in the number of medical school graduates and the licensing of foreign-trained physicians. ☐ The geographic distribution physicians is uneven. There States with more than 1,000 j sons for each practicing physic and States with just over • There are approximately 500 j sons for each non-Federal ph cian in the largest metropoli areas and more than 2,000 in sn nonmetropolitan counties. The tribution is even more dispar for medical specialists. Denti nurses, and other health pro sionals are also concentrated urban areas.

White House Conference on the Handicapped

■ A White House Conference on Handicapped Individuals, which is designed to assess the problems those persons face, make the nation more aware of those problems, and which, it is hoped, will generate legislative and administrative action, is scheduled for December 1976.

Conferences in each of the States and Territories will precede the national conference and set the agenda for it. Both the State and national meetings are authorized by Public Law 93-615, which provides \$25,000 for each State and Territory in the conference and approximately \$2 million for the national conference. Administrative responsibility for the national conference rests with the Department of Health, Education, and Welfare and with a national planning and advisory council.

In announcing the White House conference, President Ford pointed out that there are more than 7 million children and 28 million adults in America with physical or mental handicaps. The President urged all Americans to support and participate actively in "this great human endeavor" which will "focus attention on the needs of our handicapped citizens."

Public Law 93-615 also required the appointment of a council-whose members have already been named by HEW Secretary David Mathewsto help plan and conduct the White House conference and to serve in an advisory capacity in formulating issue papers. Chairing the 28-member council is Dr. Henry Viscardi, Jr., a handicapped man who has had 25 years of experience in rehabilitation. The executive director, Jack F. Smith, former assistant dean of the Educational Extension, National Technical Institute for the Deaf, Rochester Institute of Technology, is also handicapped. Other council members include educators, rehabilitation specialists, medical personnel, social workers, Government officials, families of handicapped persons, and handicapped "consumers." At least half of the delegates to the White House conference will be handicapped, and handicapped persons will participate in every phase of the meetina.

Graduate Summer Session in Epidemiology at University of Minnesota. The Eleventh Graduate Summer Session in Epidemiology will be held at the University of Minnesota in Minneapolis from June 20 to July 10, 1976.

The session, designed primarily for medical school teachers, will offer, in addition to two basic courses in the fundamentals of epidemiology and biostatistics, several other courses previously offered and two new courses on the epidemiology of nutrition and nutritional abnormalities and the epidemiology of occupational hazards.

Tuition for the session is \$400, and special rates for food and dormitory lodging have been arranged. Further information is available from Dr. Leonard M. International Conference on Scabies and Pediculosis. An International Conference on Scabies and Pediculosis will be held May 22-23, 1976, at the University of Minnesota's medical school in Minneapolis.

The conference was developed under the auspices of the National Program for Dermatology, American Academy of Dermatology. It is partially supported by the National Institutes of Health and cosponsored by the Center for Disease Control, American Medical Association, and the universities of Minnesota, Pennsylvania, and California at San Francisco.

The meeting will bring together current scientific and clinical information for physicians and other health care professionals concerned with the identification, treatment, and control of these parasitic conditions that are reaching epidemic proportions in many places. PUBLIC HEALTH REPORTS, published by the Health Resources Administration, welcomes from any source contributions of value to public health, health and medical care, and community medicine.

We are particularly interested in publishing scientific papers concerned with the delivery of health services and with the many facets of health care, as well as technical reports documenting studies and research efforts. We also seek papers on new programs, new projects, and new ideas, even when they are experimental in nature. We want to record the current happenings in the health field.

Our readers are practicing public health officials, community health practitioners, faculty and students in colleges where the health disciplines are taught, and workers in research institutions, hospitals, and community health organizations.

Tearsheets. In lieu of reprints, senior authors are provided with 50 to 100 sets of tearsheets after publication. Associate authors receive a smaller number.

Manuscript form. Authors will facilitate review if they submit four copies of their manuscripts. All copy should be typed double-spaced and each page should end with a completed paragraph. Each chart and table should be placed on a separate sheet of paper. References should follow the style used by PUBLIC HEALTH REPORTS. Footnotes should be worked into the text.

Authors are expected to recognize scientific contributions by those who have assisted them only if such contributions warrant mention in the text or in the paragraph identifying the authors. It is not the policy of PUBLIC HEALTH REPORTS to publish acknowledgements. More detailed instructions for potential contributors will be supplied on request.

Manuscript review. Most manuscripts submitted for publication are reviewed by technical experts, and authors are given the benefit of their comments before type is set. Authors also receive edited typescripts and galley proofs for approval. Authors are responsible for the accuracy and validity of all material, including tables, charts, and references.

PUBLIC HEALTH REPORTS publishes a synopsis, in lieu of a summary, of most technical reports. Authors are requested to submit with appropriate papers a synopsis of approximately 250 words. The staff will supply on request information on the preparation of synopses.

Secondary publication and indexing. Secondary publication of articles in PUBLIC HEALTH REPORTS is provided in various abstracting journals (Abstracts for Social Workers, Current Literature in Family Planning). Articles are also indexed in the annual Cumulated Index Medicus and monthly Index Medicus (National Library of Medicine), Engineering Index, Hospital Literature Index (American Hospital Association), Cumulative Index to Nursing Literature, American Statistics Index, and Medical Socioeconomic Research Sources (MEDSOC), as well as in the Institute for Scientific Information's Current Contents (Social and Behavioral Sciences, Life Sciences, and Physical & Chemical Sciences), Social Sciences Citation Index, and Science Citation Index.
