# A Cross-Country System Reports on Drug Abuse

☐ The Drug Abuse Warning Network (DAWN), a data-collecting system sponsored jointly by the National Institute on Drug Abuse in DHEW's Alcohol, Drug Abuse, and Mental Health Administration and the Justice Department's Drug Enforcement Administration, is the largest national drug abuse indicator system in the world. An article on pages 395–402 explains how DAWN works.

On this page, I would like to report on some of the findings of Project DAWN III, the third report to be made since the network was established in 1972. Like its predecessors, DAWN III delineates patterns of drug abuse in 29 major population centers, using data furnished by hospital emergency rooms, inpatient units, medical examiner reports on causes of deaths, and crisis centers. "Mentions" of any and all drugs involved in a particular drug crisis episode are the data on which patterns of use are based.

☐ In the first 2 years of DAWN reporting, April 1972 to April 1974, the drug most frequently mentioned was the tranquilizer diazepam (Valium), the drug most commonly prescribed by American physicians. In April 1975, an apparent increase in drinking brought alcohol near the top of the DAWN list—a cause for even greater concern when one considers that in the DAWN system, alcohol is not reported when it is the sole cause of discomfort, alarm, or death, but only when it has been used along with another drug.

After Valium and alcohol-incombination came heroin, marijuana, and aspirin. Also among the 10 most frequently mentioned drugs were LSD, secobarbital, and methadone, the synthetic narcotic often given in controlled doses to addicts who have withdrawn from heroin. Nearly half the drug-related deaths reported by medical examiners were caused by barbiturates (19 percent) or opiates, chiefly heroin (28 percent).

The majority of drug abusers in the study were in their teens or twenties. Whites were mentioned 76 percent of the time, and blacks 21 percent. More deaths of males than females were reported in medical examiner reports and, in the crisis centers, male contacts outnumbered female contacts, while the reverse was true in hospital emergency rooms.


☐ Whatever its limitations or duplications, the DAWN study is provocative and important for those of us concerned with drug abuse and alcohol abuse. It has already affected Federal drug enforcement priorities. It also suggests trends and developing problems, thus serving as a guide for the allocation of treatment resources and preparations to meet future needs.

☐ And the study illustrates and reinforces once again the close ties and interdependence that exist among the three components of the Alcohol, Drug Abuse, and Mental Health Administration—the National Institute on Alcohol Abuse and Alcoholism, the National Institute on Drug Abuse, and the National Institute of Mental Health.





### Audiovisual Training Package on Relating to Older People

■ A tool for changing attitudes about the treatment of older Americans has just become available to hospitals and nursing homes through the cooperative efforts of the Veterans Administration, the Public Health Service, and the American Hospital Association.

"This Way To Reality" is a complete audiovisual training package for teaching the ways of relating to older people that have proved effective at VA hospitals and nursing homes. Introduced by a team headed by Dr. James C. Folsom at the Topeka VA hospital, the treatment technique is credited with reversing and preventing the major part of the senility that results from psychological effects rather than from brain deterioration.

Although the audiovisuals in the package are designed for training hospital and nursing home staff in reality orientation, they could have wide application for informing families and community groups in plain English about "adding life to years." In the foreword to the series, Dr. Donald W. Hammersley, deputy medical director of the American Psychiatric Association, says: "Reality orientation has relevance and potential application wherever you find older people, or the not too old, suffering from confusion and faulty memory. It is one basic building block of care that the staff of any organized care setting should be able to apply."

The training package, which consists of color slides and cassettes, with a coordinated booklet, is available from the National Audiovisual Center, GSA, Washington, D.C., 20409, at \$112.

#### Twelve Fellowships Available for Health Care Projects

■ Twelve 6-month fellowships of \$9,000 each for problem-solving projects directed toward improving the organization and delivery of health care will be awarded in 1977 by the Hospital Research and Educational Trust, an affiliate of the American Hospital Association. Two of the fellowships are supported by a memorial fund established in honor of Edwin L. Crosby, who headed both the trust and the association from 1954 until his death in 1972. Ten are supported by a grant from the W. K. Kellogg Foundation.

Among the criteria for selection of recipients will be the quality, timeliness, and potential usefulness of the proposed project and the background and potential of the candidate as an administrator of a health care insti-

tution or related organization or as a teacher or investigator with a primary interest in the improvement of health care management. Part or all of the award may be allocated to a stipend for a fellow or to project costs for such activities as data collection and travel

The deadline for receipt of applications is December 15, 1976. Awards will be announced March 15, 1977. Fellows may begin their projects as early as April 1, 1977, and must begin them no later than September 30, 1977.

Independent study program for mental health administrators. The first independent study program in the country for mental health administrators has been established under the program in hospital and health care administration of the University of Minnesota. It will give practicing mental health administrators an alternative to full-time oncampus study. A residential oncampus session lasting 2 weeks will introduce each of three 1-year courses; a 1-week oncampus session will conclude each course. In addition, the courses will include monthly student-preceptor dialogs. regional workshops, and monthly unit lessons.

Graduate credits (15 credits each for the first 2 years and 25 credits for the 3d year) can be applied towards a master's degree in hopsital and health care administration. Seminar on design of waste treatment operations and processes. A seminar on "Process Design in Water Quality Engineering: New Concepts and Developments" is to be held in Nashville, Tenn., November 8–12, 1976. Its purpose is to provide participants with the most up-to-date procedures for the design of the unit operations and the processes currently used in waste treatment schemes. These procedures are to be presented in sufficient detail so that they can be put into practice immediately in producing or reviewing actual designs.

The seminar is sponsored by the Environmental and Water Resources Engineering Program and Environmental Engineering Continuing Education at Vanderbilt University. The registration fee is \$350, which includes all preprinted material.
