#### ANALYSIS OF MINE FIRES FOR ALL U.S. METAL/NONMETAL MINING CATEGORIES, 1990–2001

#### ABSTRACT

This report analyzes mine fires for all U.S. underground and surface metal/nonmetal mining categories during 1990–2001 by state and six successive 2-year time periods. Injury risk rates are derived, and ignition source, methods of detection and suppression, and other variables are examined. Fires involving contractors are also included in the analysis. The data were derived from Mine Safety and Health Administration (MSHA) mine fire accident publications and verbal communications with mine personnel. The analysis will provide the National Institute for Occupational Safety and Health, MSHA, and the mining industry with a better understanding of the causes and hazards associated with mine fires and an increased awareness aimed at preventing and reducing fire hazards. It will also form a basis for future fire research programs.

#### INTRODUCTION

Mine fires pose a constant danger to the safety of miners and to their livelihood. Underground mine fires pose an added hazard because of the confined environment with remote exits. Enactment of safety regulations [30 CFR<sup>2</sup> 56, 57] for underground and surface metal/nonmetal operations has greatly improved the safety of miners. However, mine fires and fire injuries remain serious hazards for all underground and surface mines.

This report analyzes mine fires and fire injuries for all U.S. metal/nonmetal mining categories, including sand and gravel and stone operations, during 1990–2001. Fires involving contractors are also included in the analysis. A similar analysis of fire incidents in metal/nonmetal mines during 1950–1984 was done by the former U.S. Bureau of Mines (USBM) [Butani and Pomroy 1987]. Detailed analyses of mobile equipment fires for all underground and surface coal and metal/nonmetal mining categories during 1990–1999 have recently been reported by NIOSH [De Rosa 2004].

Injury risk rate (Irr) values for the 12-year time period (1990–2001) and for six successive 2-year time periods within the 12-year period are derived. Irr values for individual states for the 12-year period are also derived. Other variables by state and time period include employees' working hours and lost workdays. The number of fire fatalities is reported by time period. Variables such as ignition source, method of detection and suppression, equipment involved, location, and burning material are reported by six 2-year time periods only. Further-

more, the number of fire injuries per number of fires causing injuries and total fires has been analyzed by year, ignition source, equipment involved, and location. For comparison purposes, the major fire and fire injury findings for all metal/nonmetal mining categories have been reported.

The data in this report were derived from "Injury Experience" publications [MSHA 1991a,b,c,d; 1992a,b,c,d; 1993a,b,c,d; 1994a,b,c,d; 1995a,b,c,d; 1996a,b,c,d; 1997a,b,c,d; 1998a,b,c,d; 1999a,b,c,d; 2000a,b,c,d; 2001a,b,c,d; 2002a,b,c,d], "Fire Accident Reports" [MSHA 1993e; 1994e; 1995e; 1996e; 1997e,f; 2000e], MSHA "Fire Accident Abstracts" internal publications, and verbal communications with mine personnel. Mining companies are required by 30 CFR 50 to report to MSHA all fires that result in injuries and fires that are not extinguished within 30 min of discovery. A small number of fires lasting <30 min without injuries reported in the "Fire Accident Abstracts" have been included in this report. Also included in this report are fires caused by explosions and explosives.

The analysis in this report will provide the National Institute for Occupational Safety and Health (NIOSH), the Mine Safety and Health Administration (MSHA), and the mining industry with a better understanding of the causes and hazards of mine fires and fire injuries and an increased awareness aimed at preventing and reducing fire hazards. It will also form a basis for developing future fire research programs.

#### **METHODOLOGIES**

For all metal/nonmetal mining categories, data on mine fires during 1990–2001 have been reported as actual numbers and calculated values.

1. For each mining category, actual numbers include the total number of fires, fire injuries, employees' working hours, and lost workdays for a 12-year period (1990–2001) and for six successive 2-year periods within the 12-year period. These numbers have also been reported by state for the 12-year time period. The actual number of fire fatalities has been reported by time period. Furthermore, actual numbers of fires for the six 2-year periods have been reported by ignition source, method of detection and suppression, equipment involved, location, and burning material. Actual numbers of fire injuries per number of fires causing injuries and total fires have been reported by year, ignition source, equipment involved, and location.

2. For each mining category, the calculated values include the injury risk rates during the 12-year period and the six 2-year periods. The injury risk rate (Irr) values were calculated according to the MSHA formula (incidence rate (IR) = number

of fire injuries × 200,000 working hours divided by the total employees' working hours) [MSHA 1991a,b,c,d; 1992a,b,c,d; 1993a,b,c,d; 1994a,b,c,d; 1995a,b,c,d; 1996a,b,c,d; 1997a,b,c,d; 1998a,b,c,d; 1999a,b,c,d; 2000a,b,c,d; 2001a,b,c,d; 2002a,b,c,d]. Also, injury risk rate values for individual states (12-year period) were calculated according to this same formula.

For comparison purposes, only the injury risk rate values for 12-year and 2-year time periods and the injury risk rate values for individual states (12-year time period) with the highest number of fire injuries have been considered. The fatality risk rate values have not been calculated because of the small number of fatalities that occurred during the 12-year period.

- 3. Calculations of Irr values are as follows:
- a. Injury risk rate (Irr) value: Number of fire injuries × 200,000 working hours divided by total employees' working hours. The Irr value is the average risk rate value for the number of fire injuries per 200,000 working hours for a given time period.
- b. Total employees' working hour (Ewhr) value during 1990–2001: Sum of 12 yearly Ewhr values for all of the

#### FIRE DATA ANALYSIS FOR ALL METAL/NONMETAL MINING CATEGORIES

#### UNDERGROUND METAL/NONMETAL AND STONE **MINE FIRES**

Table 1 and figure 1 show the number of fires and fire injuries that occurred in underground metal/nonmetal and stone mines by state during 1990–2001. Table 1 also shows the injury risk rates, employees' working hours, and lost workdays. Overall, 65 fires occurred in 20 states; these include 2 fires and no injuries for contractors. Six of the fires caused nine injuries. The yearly average was 5.4 fires and 0.75 injury. Forty-one fires with 2 injuries occurred in metal mines, 14 fires with 7 injuries occurred in nonmetal mines, and 10 fires with no injuries occurred in stone mines. The underground mine fires required 25 mine rescue team interventions and 30 mine/section evacuations. The Ewhr value was  $260 \times 10^6$  hr (Irr = 0.007), and the LWD value was 83.

Idaho had the most fires (eight fires and no injuries), followed by Louisiana (seven fires and two injuries), Michigan (six fires and six injuries), and Missouri (six fires and no injuries). Of these states, Michigan had the highest injury risk rate value (Irr = 0.146).




Figure 2.—Number of fires, fire injuries, risk rates, and employees' working hours for underground metal/nonmetal and stone mines by time period, 1990–2001.

Table 2, partly illustrated in figure 2, shows the number of fires, fire injuries, risk rates, employees' working hours, and lost workdays by time period. The number of fires during the six time periods show an increase during the fourth period followed by a sharp decrease during the fifth period and a sharp increase in the last period. The number of fire injuries show an increase followed by a decrease during most of the periods, accompanied by a decline in employees' working hours during most of the periods; an increase is seen during the third and fourth periods. The Irr values follow patterns similar to those shown by the injury values.




Figure 3.—Major variables for underground metal/nonmetal and stone mine fires, 1990–2001. (FE = portable fire extinguisher)

Tables 3-8 show the number of fires by ignition source, method of detection and suppression, equipment involved, location, and burning material by time period. Figure 3 shows the major variables related to fires for 1990-2001. Table 9 shows the number of fire injuries per number of fires causing injuries and total fires by year, ignition source, equipment involved, and location.

#### **Ignition Source**

Table 3 shows the number of fires by ignition source for each time period. The sources that caused most of the underground metal/nonmetal and stone mine fires were hydraulic fluid/fuel sprayed onto equipment hot surfaces (16 fires or 25%), flame cutting/welding spark/slag/flame (13 fires or 20%), and electrical short/arcing (12 fires or 19%).

all of the states involved and not involved in fires within the 2-year period.

- d. The lost workday (LWD) values were reported by state and time period.
- e. A lost workday value of 6,000, assigned by MSHA to each fatality or permanent total disability, was reported.

Thirteen of the 16 mobile equipment hydraulic fluid/fuel fires became large fires because of the continuous flow of fluids from the pumps due to engine shutoff failure, lack of an emergency line drainage system, or lack of effective and rapid local firefighting response capabilities. In at least two instances during these fires, the cab was suddenly engulfed in flames, probably due to the ignition of flammable vapors and mists that penetrated the cab. Of note is that the hydraulic fluid fires subsequently involved the fuel system. Other ignition sources included engine/motor mechanical malfunctions, spontaneous combustion (involving timber)/hot material, conveyor belt/equipment friction, heat source (mostly involving heaters), overheated oil, and explosion/ignition of explosives. Fires caused by the spontaneous combustion/hot material and electrical short/arcing ignition sources were usually detected long after they had started due to lack of combustion gas/smoke detection systems.

During the first period, the largest number of fires were caused by hydraulic fluid/fuel sprayed onto equipment hot surfaces, flame cutting/welding spark/slag/flame, and electrical short/arcing sources. During the second period, the largest number of fires were caused by flame cutting/welding spark/slag/flame and electrical short/arcing sources. During the third period, the largest number of fires were caused by conveyor belt/equipment friction. During the fourth period, the largest number of fires were caused by hydraulic fluid/fuel sprayed onto equipment hot surfaces. During the fifth period, the largest number of fires were caused by hydraulic fluid/fuel sprayed onto equipment hot surfaces and flame cutting/welding spark/slag/flame. During the sixth period, the largest number of fires were caused by hydraulic fluid/fuel.

#### Method of Detection

Table 4 shows the number of fires by method of detection for each time period. The most frequent methods were miners who saw smoke long after the fire had started, operators who saw the fires when they started as flames/flash fires, and miners who saw smoke shortly after the fires had started. Other methods of detection were welders who saw sparks, miners who heard an explosion or smelled smoke, and operators who experienced an equipment power loss. One fire was detected by carbon monoxide gas sampling, and two fires were undetected.

During the first period, the largest number of fires were detected by operators as flames/flash fires. During the second period, the largest number of fires were detected by welders as sparks. During the third, fifth, and sixth periods, the largest number of fires were detected by miners as smoke long after the fires had started. During the fourth period, the largest number of fires were detected visually as flames and sparks.



#### **Suppression Method**

Table 5 shows the number of fires by suppression method for each time period. Usually more than one agent was used to fight a fire. The most common methods were portable fire extinguishers with dry chemical powder, foam, and water, followed by water or portable fire extinguishers alone. Other suppression methods included machine fire suppression systems with dry chemical powder, foam, and water and manual techniques with or without portable fire extinguishers (welders' method to extinguish clothing and oxyfuel/grease fires). Four of the 16 pieces of mobile equipment involved in hydraulic fluid/fuel fires had machine fire suppression systems. Dual activations (two activations) of machine fire suppression and engine shutoff systems succeeded in temporarily abating the fires; however, the flames reignited, fueled by the flow of pressurized fluids entrapped in the lines. On one occasion the fire suppression system failed to activate, and in another instance the system was activated late.

Portable fire extinguishers, used upon discovery of the fires, were successful in extinguishing small fires involving oxyfuel/

grease, oil, refueling fuel, and electrical wires, cables and batteries. Mine rescue teams (required 25 times), upon mine/ section evacuation (performed 30 times), fought the fires (including 12 mobile equipment fires) with dry chemical powder and water; in one instance, foam was also used. However, seven fires destroyed or heavily damaged equipment (including four pieces of mobile equipment) because of failure of firefighting methods, late fire detection, undetected fires, or fire size. Other factors that determined the success of fire suppression efforts were the time lapse between detection and application of extinguishing agents and effective and rapid local firefighting response capabilities.

During the first period, the largest number of fires were suppressed with portable fire extinguishers or water alone. During the second and sixth periods, the largest number of fires were suppressed with portable fire extinguishers together with dry chemical powder, foam, and water. During the third and fifth periods, the largest number of fires were suppressed with water alone and portable fire extinguishers with dry chemical powder, foam, and water. During the fourth period, the largest number of fires were suppressed with portable fire extinguishers alone.

#### **Equipment Involved**

Table 6 shows the number of fires by equipment involved for each time period. The equipment most often involved was mobile equipment (golf and ore carts, locomotives, shuttle cars, loaders, power scalers, scoops, tractors, trolleys, trucks, and drills), followed by oxyfuel torches (at times electrical arc welding equipment was used). Other equipment included beltlines, electrical systems, batteries, chargers, heaters, cutting saws, explosive boxes, and air compressors. Six fires did not involve equipment. During all of the periods, the largest number of fires involved mobile equipment.

#### Location

Table 7 shows the number of fires by location for each time period. The most common locations were mobile equipment working areas (haulage, loading, mucking, transportation and drilling areas, decline slopes), followed by flame cutting/ welding areas (at shops, mainways, boreholes, shafts, stations, slusher bucket and chute areas, and maintenance areas), and mine face, section, crosscut, and drift areas. Other fire locations were battery and pipeline areas, motor barns, belt entries, shops, refuse and maintenance areas, decline slopes, chute and crusher areas, panel and tunnel areas, and goblines and abandoned areas.

During the first, second, fourth, and sixth periods, the largest number of fires occurred at mobile equipment working areas. During the third period, the largest number of fires occurred at belt entries. During the fifth period, the largest number of fires occurred at flame cutting/welding areas.

#### **Burning Materials**

Table 8 shows the number of fires by burning material for each time period. The materials most often involved were hydraulic fluid/fuel, electrical cord, cables, wires, batteries, oxyfuel/clothing/grease, and materials such as rubber tires and hoses, hydraulic fluid, shop, refuse, wood, chute liner, and shaft material. Other burning materials included belt material, refueling fuel, flammable liquids, oil, grease, refuse, timber, pipelines, chute liners, equipment mechanical components, detonated explosives, and shops and their content.

During the first period, the largest number of fires involved electrical cord, cables, wires, and batteries. During the second period, the largest number of fires involved oxyfuel, clothing/ grease, and other materials and electrical cord, cables, wires, and batteries. During the third period, the largest number of fires involved belt materials. During the fourth period, the largest number of fires involved hydraulic fluid/fuel. During the fifth period, the largest number of fires involved hydraulic fluid/fuel and oxyfuel. During the sixth period, the largest number of fires involved hydraulic fluid/fuel and electrical materials.

#### **Fire Injuries**

Table 9 shows the number of fire injuries per number of fires causing injuries and total fires by year, ignition source,

equipment involved, and location during 1990–2001. Overall, there were nine injuries caused by six fires. The greatest number of fire injuries occurred in 1997 (four injuries caused by one fire). The ignition sources that caused the fire injuries were hydraulic fluid/fuel sprayed onto equipment hot surfaces, flame cutting/welding spark/slag/flame, and overheated oil. The equipment involved in fire injuries included mobile equipment, oxyfuel torches, and air compressors. The locations where the fire injuries occurred were mobile equipment working areas, flame cutting/welding areas, and mining areas.

#### SURFACE OF UNDERGROUND METAL/NONMETAL AND STONE MINE FIRES




Figure 4.—Number of fires and fire injuries for surface of underground metal/nonmetal and stone mines by state, 1990–2001.

Table 10 and figure 4 show the number of fires and fire injuries occurring at the surface of underground metal/nonmetal and stone mines by state during 1990–2001. Table 10 also shows the injury risk rates, employees' working hours, and lost workdays.

A total of 12 fires occurred in 11 states; 5 of the fires caused 5 injuries. The yearly average was one fire and 0.42 injury. Five fires with two injuries occurred at metal mines, five fires with two injuries occurred at nonmetal mines, and two fires with one injury occurred at stone mines. None of the fires involved contractors. The Ewhr value was  $58 \times 10^6$  hr (Irr = 0.017), and the LWD value was 75.

Nevada had the most fires (two fires and no injuries). Ohio, New Mexico, Missouri, South Dakota, and Idaho each had one fire with one injury. Of these states, Missouri had the highest injury risk rate value (Irr = 0.25).




Figure 5.—Number of fires, fire injuries, risk rates, and employees' working hours for surface of underground metal/nonmetal and stone mines by time period, 1990–2001.

Table 11, partly illustrated in figure 5, shows the number of fires, fire injuries, risk rates, employees' working hours, and lost workdays by time period. The number of fires decreased during most of the six time periods. The number of fire injuries and employees' working hours decreased during all of the periods. The Irr values follow patterns similar to those shown by the injury values.




Figure 6.—Major variables for surface of underground metal/nonmetal and stone mine fires, 1990–2001. (FE = portable fire extinguisher)

Tables 12–17 show the number of fires by ignition source, method of detection and suppression, equipment involved, location, and burning material by time period. Figure 6 shows the major variables related to fires for 1990–2001. Table 18 shows the number of fire injuries per number of fires causing injuries and total fires by year, ignition source, equipment involved, and location.

#### **Ignition Source**

Table 12 shows the number of fires and fire injuries by ignition source for each time period. The leading source was flame cutting/welding spark/slag/flame (seven fires or 58%), followed by electrical short/arcing and heat source (one fire for each ignition). The ignition sources for three fires were unknown.

During the first through third periods, the fires were caused by the flame cutting/welding spark/slag/flame source. During the fifth period, the fire was caused by a heat source. During the sixth period, the fires were caused by flame cutting/welding spark/slag/flame and electrical short/arcing sources. No fires occurred during the fourth period.

#### Method of Detection

Table 13 shows the number of fires by method of detection for each time period. The most frequent method was welders who saw sparks. This was followed by miners who saw smoke long after the fires had started and miners who saw smoke shortly after the fires had started. Three fires were undetected.

During the first period, the largest number of fires were detected by welders as sparks. During subsequent periods, the fires were detected by welders as sparks (second period), by miners as smoke shortly or long after the fires had started and by welders as sparks (third period), by miners as smoke (fifth period), and by welders and miners as sparks and as smoke (sixth period).

#### **Suppression Method**

Table 14 shows the number of fires by suppression method for each time period. The most common method was water alone, followed by manual techniques with or without portable fire extinguishers and portable fire extinguishers alone. In three instances the fires destroyed or heavily damaged facilities because of failure of firefighting methods, undetected fire, or fire size.

During the first period, the largest number of fires were suppressed manually with or without portable fire extinguishers. During subsequent periods, the fires were extinguished with portable fire extinguishers alone (second period), water alone (third and fifth periods), and portable fire extinguishers or water alone (sixth period).

#### **Equipment Involved**

Table 15 shows the number of fires by equipment involved for each time period. The equipment most often involved was oxyfuel torches (at times electrical arc welding equipment was used), followed by facilities (considered equipment in this report), a heater, and a ventilation fan.

During the first and third periods, the largest number of fires involved oxyfuel torches. During the other periods, the fires involved oxyfuel torches and facilities (second period), facilities and a heater (fifth period), and an oxyfuel torch and a ventilation fan (sixth period).

#### Location

Table 16 shows the number of fires by location for each time period. The most common locations were flame cutting/welding areas (at shops, junction boxes, facilities, handrails, head frames, walkways, and maintenance areas), followed by facilities, garages, trailers and storage areas, and a ventilation fan housing.

During the first and third periods, the largest number of fires occurred at the flame cutting/welding areas. During the other periods, the fires occurred at flame cutting/welding areas and at facility, garage, trailer, and storage areas (second period), facilities (fifth period), and flame cutting/welding areas and fan housing (sixth period).

#### **Burning Materials**

Table 17 shows the number of fires by burning material for each time period. The materials most often involved were oxyfuel/clothing/grease and other materials (including electrical junction boxes, handrails, rubber tires, flammable liquids, and equipment mechanical components). Other burning materials involved facilities and their contents, and wood.

During the first and third periods, the largest number of fires involved oxyfuel, clothing, grease, and other materials. During the other periods, the fires involved oxyfuel and facilities and their contents (second period), wood and facilities (fifth period), and oxyfuel and wood (sixth period).

#### **Fire Injuries**

Table 18 shows the number of fire injuries per number of fires causing injuries and total fires by year, ignition source, equipment involved, and location during 1990–2001. In 1990, 1991, 1993, 1994, and 2000, there was one injury caused by one fire for each year. The cause of these fires was the flame cutting/welding spark/slag/flame ignition source.

#### SURFACE METAL/NONMETAL MINE FIRES

Table 19 and figure 7 show the number of fires and fire injuries for surface metal/nonmetal mines by state during 1990–2001. Table 19 also shows the injury risk rates, employees' working hours, and lost workdays. A total of 79 fires occurred in 16 states during 1990–2001 for these mines.

Forty-five of the fires caused 44 injuries and 2 fatalities (including 9 fires and 7 injuries involving contractors). The yearly average was 6.6 fires and 3.7 injuries. Sixty-five fires with 31 injuries and 2 fatalities occurred at metal mines, and 14 fires with 13 injuries occurred at nonmetal mines. The Ewhr value was  $546 \times 10^6$  hr (Irr = 0.016), and the LWD value was 13,134.

Nevada and Arizona had the most fires (19 fires, 10 injuries, and 1 fatality; and 19 fires and 11 injuries, respectively). They were followed by Minnesota (11 fires, 4 injuries, and 1 fatality) and Alaska (6 fires and 4 injuries). Of these states, Alaska had the highest injury risk rate value (Irr = 0.079).




Figure 8.—Number of fires, fire injuries, risk rates, and employees' working hours for surface metal/nonmetal mines by time period, 1990–2001.

Table 20, partly illustrated in figure 8, shows the number of fires, fire injuries, fire fatalities, risk rates, employees' working hours, and lost workdays by time period. The number of fires increased during the second period, then decreased during most of the remaining periods. The number of fire injuries decreased during most of the periods (a small increase is seen during the last period), accompanied by a decline in employees' working hours during most of the periods (a small increase is seen during the third and fourth periods). The Irr values follow patterns similar to those shown by the number of fire injuries.




Figure 9.—Major variables for surface metal/nonmetal mine fires, 1990–2001. (FE = portable fire extinguisher)

Tables 21–26 show the number of fires by ignition source, method of detection and suppression, equipment involved, location, and burning material by time period. Figure 9 shows the major variables related to fires for 1990–2001. Table 27 shows the number of fire injuries per number of fires causing injuries and total fires by year, ignition source, equipment involved, and location.

#### **Ignition Source**

Table 21 shows the number of fires and fire injuries by ignition source for each time period. The leading source was hydraulic fluid/fuel sprayed onto equipment hot surfaces (35 fires or 44%), followed by flame cutting/welding spark/ slag/flame (13 fires or 17%) and electrical short/arcing (8 fires or 10%). Other sources were heat source-flammable liquid/ vapors, flammable liquid/combustible material/refueling fuel on hot surfaces, overheated oil, hot material, and conveyor belt

friction. Three ignition sources were unknown. Twenty-two of the 35 equipment hydraulic/fuel fires became large fires because of continuous flow of fluids from the pumps due to engine shutoff failure, difficulty in activating available emergency systems at ground level, lack of an emergency line drainage system, or lack of effective and rapid local firefighting response capabilities. In at least five instances, the cab was suddenly engulfed in flames, probably due to the ignition of flammable vapors and mists that penetrated the cab. Of note is that the hydraulic fluid fires subsequently involved the fuel system.

During the first through fourth and the sixth periods, the largest number of fires were caused by hydraulic fluid/fuel sprayed onto equipment hot surfaces. During the fifth period, the largest number of fires were caused by flame cutting/welding spark/slag/flame.

#### **Method of Detection**

Table 22 shows the number of fires by method of detection for each time period. The most frequent methods were operators who saw the fires when they started as flames/flash fires, miners who saw smoke shortly after the fires had started, and welders who saw sparks. Other methods of detection were miners who saw smoke long after the fires had started. Three fires were undetected. During the first through fourth and the sixth periods, the largest number of fires were detected by operators as flames/flash fires. During the fifth period, the largest number of fires were detected by welders as sparks.

#### Suppression Method

Table 23 shows the number of fires by suppression method for each time period. The most common methods were portable fire extinguishers with foam, dry chemical powder, and water, followed by portable fire extinguishers alone and manual techniques with or without portable fire extinguishers. Other methods were water alone and machine fire suppression systems with dry chemical powder, foam, and water. Five of the 35 pieces of mobile equipment involved in the hydraulic fluid/ fuel fires had machine fire suppression systems. Dual activation (one activation) of machine fire suppression and engine shutoff systems succeeded in temporarily abating the fires; however, the flames reignited, fueled by the flow of pressurized fluids entrapped in the lines. On three other occasions (one of which resulted in a fatality), the fires raged out of control because of machine fire suppression system failure. In another instance the fire was detected late.

On at least five occasions, including one mobile equipment fire, fire brigades and fire departments fought the fires with foam, dry chemical powder, and water. However, eight fires destroyed or heavily damaged equipment (including seven pieces of mobile equipment) because of failure of firefighting methods, late fire detection, undetected fires, or fire size.

During the first and fifth periods, the largest number of fires were suppressed with portable fire extinguishers alone. During the second period, the largest number of fires were suppressed with portable fire extinguishers together with foam, dry chemical powder, and water and with portable fire extinguishers alone. During the third, fourth, and sixth periods, the largest number of fires were suppressed with portable fire extinguishers, foam, dry chemical powder, and water.

#### **Equipment Involved**

Table 24 shows the number of fires by equipment involved for each time period. The equipment most often involved was mobile equipment (trucks, dozers, loaders, shovels, drills, and scrapers), followed by oxyfuel torches (at times electrical arc welding equipment was used) and heaters. Other equipment included maintenance equipment, beltlines, generators, chutes, a sump, and facilities (considered equipment in this report). During the first through fourth and the sixth periods, the largest number of fires involved mobile equipment. During the fifth period, the largest number of fires involved oxyfuel torches.



#### Location

Table 25 shows the number of fires by location for each time period. The most common locations were mobile equipment working areas (mining, haulage, loading, drilling, and excavating areas). This was followed by flame cutting/welding areas (at pipeline, dump rope, crowd platform, and maintenance areas) and maintenance, storage, and refuse areas. Other fire locations included facilities and roofing areas, waste dump and sump areas, and generator housing, crusher, and fire training areas. During the first through fourth and the sixth periods, the largest number of fires occurred at mobile equipment working areas. During the fifth period, the largest number of fires occurred at maintenance, storage, and refuse areas.

#### **Burning Materials**

Table 26 shows the number of fires by burning material for each time period. The material most often involved was hydraulic fluid/fuel, followed by oxyfuel/clothing/grease and other materials (including rubber hoses, pipelines, grease, equipment mechanical components, dump rope cables, screen liner, and shaft material), flammable liquids, and combustible materials. Other burning materials involved electrical wires and cables, refuse, wood, tires and chute liner, equipment mechanical components, facilities and their content, and belt material. During the first through fourth and the sixth periods, the largest number of fires involved hydraulic fluid/fuel and oil. During the fifth period, the largest number of fires involved oxyfuel, flammable liquids, and combustible materials.

#### **Fire Injuries**

Table 27 shows the number of fire injuries per number of fires causing injuries and total fires by year, ignition source, equipment involved, and location for 1990–2001. Overall, there were 44 injuries and 2 fatalities caused by 45 fires. The greatest number of fire injuries occurred in 1991 (eight injuries caused by seven fires). The ignition sources that caused most of the fire injuries were hydraulic fluid/fuel sprayed onto equipment hot surfaces and flame cutting/welding spark/slag/flame. Other ignition sources causing injuries were flammable liquid/refueling fuel on hot surfaces, heat source-vapors/flammable liquid, electrical short/arcing, and oil on hot surfaces. The equipment, oxyfuel torches, and maintenance equipment, followed by heaters, electrical systems, and air compressors. The locations where the fire injuries occurred were mobile equipment working areas,

flame cutting/welding areas, maintenance and fire training areas, and generator housing.

Nevada and Minnesota each had a fire fatality [MSHA 1995e, 2000e]. These were caused by hydraulic fluid/fuel fires involving a truck and a dozer, respectively. The victims were severely burned while exiting the cab.

#### SURFACE SAND AND GRAVEL MINE FIRES

Table 28 and figure 10 show the number of fires and fire injuries for surface sand and gravel mines by state during 1990–2001. Table 28 also shows the injury risk rates, employees' working hours, and lost workdays. At surface sand and gravel mines, a total of 70 fires with 60 injuries occurred in 29 states during 1990–2001. Fifty-nine of the fires caused 60 injuries (none of the fires involved contractors). The yearly average was 5.8 fires and five injuries. The Ewhr value was 741 × 10<sup>6</sup> hr (Irr = 0.016), and the LWD value was 6,921. California had the most fires (nine fires and five injuries), followed by Michigan (six fires and six injuries) and Pennsylvania (five fires and five injuries). Of these states, Pennsylvania had the highest injury risk rate value (Irr = 0.052).

Table 29, partly illustrated in figure 11, shows the number of fires, fire injuries, risk rates, employees' working hours, and lost workdays by time period. The number of fires and fire injuries show an increase during the second period followed by a decrease during the fourth period followed by a small increase during the fifth period and a sharp decrease during the last period. Employees' working hours increased during most of the periods. The Irr values follow patterns similar to those shown by the injury values.




Figure 12.—Major variables for surface sand and gravel mine fires, 1990–2001. (FE = portable fire extinguisher)

Tables 30–35 show the number of fires by ignition source, method of detection and suppression, equipment involved, location, and burning material by time period. Figure 12 shows the major variables related to fires for 1990–2001. Table 36 shows the fire injuries per number of fires causing injuries and total fires by year, ignition source, equipment involved, and location.

#### Ignition Source

Table 30 shows the number of fires by ignition source for each time period. The leading source was flame cutting/welding spark/ slag/flame (29 fires or 41%), followed by heat source/explosion (15 fires or 21%) involving pressurized cans and flammable liquids and by hydraulic fluid/fuel sprayed onto equipment hot surfaces (14 fires or 20%). Other ignition sources were flammable liquid/gas/refueling fuel on hot surfaces/collision (in one instance, the fuel ignited upon equipment collision) and electrical short/ arcing/explosion (involving a pump). Two ignition sources were unknown. At least 5 of the 14 mobile equipment hydraulic fluid/ fuel fires became large fires because of the continuous flow of fluids from the pumps due to engine shutoff failure, difficulty in activating available emergency systems at ground level, lack of an emergency drainage system, or lack of effective and rapid local firefighting response capabilities. On two occasions, the cab was suddenly engulfed in flames, probably due to the ignition of flammable vapors and mists that penetrated the cab. Of note is that the hydraulic fluid fires subsequently involved the fuel system. During all of the periods, the largest number of fires were caused by flame cutting/welding spark/slag/flame.


#### **Method of Detection**

Table 31 shows the number of fires by method of detection for each time period. The most frequent methods were welders who saw sparks and operators who saw the fires when they started as flames/flash fires. Other methods of detection were miners who heard an explosion and operators who experienced an equipment power loss. Four fires were undetected.

During the first period, the largest number of fires were detected by welders as sparks. During the second and fifth periods, the largest number of fires were detected by operators and welders as flames/flash fires and sparks. During the third period, the largest number of fires were detected by welders as sparks. During the fourth period, the largest number of fires were detected by operators as flames/flash fires and by miners as smoke shortly or long after the fires had started. During the sixth period, the largest number of fires were detected by operators as flames/flash fires.

#### Suppression Method

Table 32 shows the number of fires by suppression method for each time period. The most frequent methods were manual techniques with or without portable fire extinguishers, portable

Figure 11.—Number of fires, fire injuries, risk rates, and employees' working hours for surface sand and gravel mines by time period, 1990–2001.

fire extinguishers with dry chemical powder, foam and water, and water alone. Portable fire extinguishers alone were also used to suppress the fires. None of the equipment involved in fires had machine fire suppression systems. On at least three occasions, including one mobile equipment fire, fire brigades and fire departments fought the fires with foam, dry chemical powder, and water. However, in four instances the fires destroyed or heavily damaged equipment (including two pieces of mobile equipment) because of failure of other firefighting methods, late fire detection, undetected fires, or fire size.

During the first, third, and sixth periods, the largest number of fires were suppressed manually with or without portable fire extinguishers. During the second and fourth periods, the largest number of fires were suppressed with portable fire extinguishers together with dry chemical powder, foam, and water. During the fifth period, the largest number of fires were extinguished manually with or without portable fire extinguishers and with portable fire extinguishers, dry chemical powder, foam, and water.

#### **Equipment Involved**

Table 33 shows the number of fires by equipment involved for each time period. The equipment most often involved was oxyfuel torches (at times electrical arc welding equipment was used), followed by mobile equipment (loaders, trucks, scrapers, dredges, backhoes, and buckets) and heaters/burners. Other equipment included maintenance equipment, generators and pumps, and facilities (considered equipment in this report). During all of the periods, the largest number of fires involved oxyfuel torches.

#### Location

Table 34 shows the number of fires by location for each time period. The most common locations were flame cutting/welding areas (at beltline, pipeline, chute, crusher, hopper, and compactor areas, washer plants, and maintenance areas), followed by maintenance areas and mobile equipment working areas (loading, haulage, mining, and dredging areas). Other fire locations included generator and pump housing, electrical control areas, facility areas, crusher and refuse areas, and beltline areas. During all of the periods, the largest number of fires occurred at flame cutting/welding areas.

#### **Burning Materials**

Table 35 shows the number of fires by burning material for each time period. The materials most often involved were oxyfuel/clothing/grease and other materials (including chute liner, washer plant, flammable liquids, equipment mechanical components, shaker deck, crusher and hopper, and belt material). This was followed by hydraulic fluid/fuel and by flammable liquids, gas, and refueling fuel. Other burning materials included refuse and rubber tires, electrical control, wires and cables, belt material and crusher, and facilities and their contents. During all of the periods, the largest number of fires involved oxyfuel/clothing/grease and other materials.

#### **Fire Injuries**

Table 36 shows the number of fire injuries per number of fires causing injuries and total fires by year, ignition source, equipment involved, and location during 1990–2001. Overall, there were 60 injuries caused by 59 fires. The greatest number of fire injuries occurred in 1998 (10 injuries caused by 9 fires). The ignition sources that caused most of the fire injuries were flame cutting/welding spark/slag/flame, heat source, and hydraulic fluid/fuel sprayed onto equipment hot surfaces. Other ignition sources were flammable liquid/refueling fuel on hot surfaces and electrical short/arcing. The equipment most often involved in fire injuries included oxyfuel torches, heaters, and mobile equipment, followed by maintenance equipment, electrical systems, pumps, and generators. The locations where the fire injuries occurred were flame cutting/welding areas, maintenance areas, mobile equipment working areas, and pump and generator housing.

#### SURFACE STONE MINE FIRES




Figure 13.—Number of fires and fire injuries for surface stone mines by state, 1990–2001.

Table 37 and figure 13 show the number of fires and fire injuries for surface stone mines by state during 1990–2001. Table 37 also shows the injury risk rates, employees' working hours, and lost workdays. In all, 96 fires occurred in 31 states and 1 fire occurred in Puerto Rico. Sixty-eight of the fires caused 67 injuries and 1 fatality (including 6 fires and 5 injuries involving contractors). The yearly average was eight fires and 5.6 injuries. The Ewhr value was  $689 \times 10^6$  hr (Irr = 0.02), and the LWD value was 7,399.

Indiana had the most fires (eight fires and four injuries), followed by Georgia (seven fires and seven injuries) and Pennsylvania (seven fires and five injuries). Of these states, Georgia had the highest injury risk rate value (Irr = 0.058).




Figure 14.—Number of fires, fire injuries, risk rates, and employees' working hours for surface stone mines by time period, 1990–2001.

Table 38, partly illustrated in figure 14, shows the number of fires, fire injuries, fire fatalities, risk rates, employees' working hours, and lost workdays by time period. The number of fires and fire injuries show an increase during the second period followed by a decrease during most of the remaining periods. Employees' working hours increased during most of the periods. The Irr values follow patterns similar to those shown by the injury values.




Figure 15.—Major variables for surface stone mine fires, 1990–2001. (FE = portable fire extinguisher)

Tables 39–44 show the number of fires by ignition source, method of detection and suppression, equipment involved, location, and burning material by time period. Figure 15 shows the major variables related to fires for 1990–2001. Table 45shows the number of fire injuries per number of fires causing injuries and total fires by year, ignition source, equipment involved, and location.

#### **Ignition Source**

Table 39 shows the number of fires and fire injuries by ignition source for each time period. The leading sources were flame cutting/welding spark/slag/flame (25 fires or 26%), heat source/explosion-flammable liquid (24 fires or 25%), and hy-

draulic fluid/fuel sprayed onto equipment hot surfaces (16 fires or 17%). At least 10 of the 16 mobile equipment hydraulic fluid/fuel fires became large fires because of the continuous flow of fluids from the pumps due to engine shutoff failure, difficulty in activating available emergency systems at the ground level, lack of an emergency line drainage system, or lack of effective and rapid local firefighting response capabilities. On two occasions, the cab was suddenly engulfed in flames, probably due to the ignition of flammable vapors and mists that penetrated the cab. Of note is that the hydraulic fluid fires subsequently involved the fuel system. Other ignition sources were electrical short/arcing, refueling fuel/flammable liquid on hot surfaces, explosion/ignition of hazardous material, chemical and explosives, hot material, engine malfunction/mechanical friction, and overheated oil. Nine ignition sources were unknown.

During the first, third, fourth, and fifth periods, the largest number of fires were caused by heat source/explosion-flammable liquid/gas. During the second period, the largest number of fires were caused by flame cutting/welding spark/slag/flame. During the sixth period, the largest number of fires were caused by hydraulic fluid/fuel sprayed onto equipment hot surfaces.

#### **Method of Detection**

Table 40 shows the number of fires by method of detection for each time period. The most frequent methods were operators who saw the fires when they started as flames/flash fires, welders who saw sparks, and miners who saw smoke shortly after the fires had started. Other methods of detection were miners who heard an explosion or touched a hot spot, miners who saw smoke long after the fires had started, and operators who saw a white mist. Eight fires were undetected.

During the first period, the largest number of fires were detected by welders as sparks and by miners who heard an explosion. During the second period, the largest number of fires were detected by welders as sparks. During the third period, the largest number of fires were detected by operators as flames/flash fires and by welders as sparks. During the fourth and fifth periods, the largest number of fires were detected by miners as smoke. During the sixth period, the largest number of fires were detected by operators as flames/flash fires.

#### **Suppression Method**

Table 41 shows the number of fires by suppression method for each time period. The most common methods were manual techniques with or without portable fire extinguishers or water alone, portable fire extinguishers with dry chemical powder, and foam and water. None of the equipment involved in fires had machine fire suppression systems. On at least six occasions, including one mobile equipment fire, fire brigades and fire departments fought the fires with portable fire extinguishers, foam, dry chemical powder, and water. However, 12 fires destroyed or heavily damaged equipment (including four pieces of mobile equipment) because of failure of firefighting methods, late fire detection, undetected fires, or fire size.

During the first and fifth periods, the largest number of fires were suppressed with water alone. During the second period, the largest number of fires were suppressed manually with or without portable fire extinguishers. During the third period, the largest number of fires were suppressed with portable fire extinguishers or water alone and manually with or without portable fire extinguishers. During the fourth period, the largest number of fires were extinguished with portable fire extinguishers alone or together with dry chemical powder, foam, and water. During the sixth period, the largest number of fires were extinguished with portable fire extinguishers, dry chemical powder, foam, and water.

#### Equipment Involved

Table 42 shows the number of fires by equipment involved for each time period. The equipment most often involved was mobile equipment (dozers, loaders, trucks, tankers, drills, and shovels), oxyfuel torches (at times electrical arc welding equipment was used), heaters and burners, and maintenance equipment. Other equipment included facilities (considered equipment in this report), chemical/flammable liquid/gas tanks, beltlines, electrical control systems, a hopper, a crusher, a preheat system, a generator, a product treatment pot, and an explosive device. During the first, third, and fifth periods, the largest number of fires involved heaters, burners, and maintenance equipment. During the second period, the largest number of fires involved oxyfuel torches. During the fourth and sixth periods, the largest number of fires involved mobile equipment.

#### Location

Table 43 shows the number of fires by location for each time period. The most common locations were flame cutting/welding areas, maintenance and refuse areas, and mobile equipment working areas (haulage, loading, mining, drilling, transportation, and crusher areas). Other fire locations included facility and garage areas, raw mills, preheat and storage silo areas, product treatment areas, beltline and hopper areas, and waste dump, pit, crusher, screen, and deck areas. Electrical control and power house areas, chemical and flammable liquid storage areas, and generator housing were also affected by the fires. During the first, third, and fifth periods, the largest number of fires occurred at maintenance and refuse areas. During the second period, the largest number of fires occurred at flame cutting/welding areas. During the fourth and sixth periods, the largest number of fires occurred at mobile equipment working areas.

#### **Burning Materials**

Table 44 shows the number of fires by burning material for each time period. The materials most often involved were oxyfuel/

clothing/grease and other materials (including screen shaft, crusher, hopper, stampler breaker materials, rubber hoses, gear boxes, bin feeder, hydraulic fluid, and chute liner), hazardous materials, chemicals, oil, refuse, detonated explosives, and hydraulic fluid/fuel. Other burning materials included flammable liquids and gas, facilities and their contents, electrical wires and cables, belts and hot materials, equipment mechanical components, and deck liner.

During the first and fifth periods, the largest number of fires involved hazardous material, chemicals, refuse, oil, and detonated explosives. During the second period, the largest number of fires involved oxyfuel/clothing/grease and other materials. During the third period, the largest number of fires involved oxyfuel and hazardous materials. During the fourth and sixth periods, the largest number of fires involved hydraulic fluid/fuel.

#### **Fire Injuries**

Table 45 shows the number of fire injuries per number of fires causing injuries and total fires by year, ignition source, equipment involved, and location for 1990–2001. Overall, there

were 67 injuries and 1 fatality caused by 68 fires. The greatest number of fire injuries occurred in 1993 (11 injuries and 1 fatality caused by 12 fires). The ignition sources that caused the greatest number of fire injuries were flame cutting/welding spark/slag/flame, heat source, and hydraulic fluid/fuel sprayed onto equipment hot surfaces. Other ignition sources were flammable liquid/refueling fuel on hot surfaces, electrical short/ arcing, overheated oil, hot material, and mechanical friction. The equipment involved in fire injuries included oxyfuel torches, heaters, mobile equipment, maintenance equipment, electrical systems, air compressors, beltline, and kiln. The locations where most of the fire injuries occurred were flame cutting/welding areas, maintenance and refuse areas, and mobile equipment working areas. Other fire locations were generator housing, beltlines, and kiln areas.

A fatality occurred in Tennessee [MSHA 1993e], which was caused by a hydraulic fluid fire involving a truck. The victim was severely burned in the cab, probably due to the sudden ignition of flammable vapors and mists that penetrated the cab.

## METAL/NONMETAL MILL FIRES

Table 46 and figure 16 show the number of fires and fire injuries for metal/nonmetal mills by state during 1990–2001. Table 46 also shows the injury risk rates, employees' working hours, and lost workdays. In all, 77 fires occurred in 26 states. Thirty-seven of the fires caused 41 injuries and 1 fatality (including 5 fires and 3 injuries involving contractors). The yearly average was 6.4 fires and 3.4 injuries. Fifty-four fires with 26 injuries and 1 fatality occurred at metal mills; 23 fires with 15 injuries occurred at nonmetal mills. The Ewhr value was  $845 \times 10^6$  hr (Irr = 0.01), and the LWD value was 6,681.

Minnesota had the most fires (16 fires and 5 injuries), followed by Arizona (9 fires and 3 injuries), Wyoming (8 fires and 3 injuries), Nevada (7 fires, 4 injuries, and 1 fatality), and Texas (4 fires and 7 injuries). Of these states, Texas had the highest injury risk rate value (Irr = 0.033).

Table 47, partly illustrated in figure 17, shows the number of fires, fire injuries, fire fatalities, risk rates, employees' working hours, and lost workdays by time period. The number of fires increased slightly during the second period, then decreased during the remaining periods. The number of fire injuries show a decrease during most of the periods (an increase is seen during the third period), accompanied by a decline in employees' working hours during most of the periods. The Irr values follow patterns similar to those shown by the injury values.

Tables 48–53 show the number of fires by ignition source, method of detection and suppression, equipment involved, location, and burning material by time period. Figure 18 shows the major variables related to fires for 1990–2001. Table 54 shows the number of fire injuries per number of fires causing injuries and total fires by year, ignition source, equipment involved, and location.

## **Ignition Source**

Table 48 shows the number of fires and injuries by ignition source for each time period. The leading sources were flame cutting/welding spark/slag/flame (29 fires or 38%), hot material (12 fires or 16%), and flammable liquid/oil/refueling fuel on hot surfaces/explosion (9 fires or 11%). Other ignition sources were electrical short/arcing, conveyor belt friction, overheated oil, surface vaporized oil on hot surface, chemical explosion/ ignition, hydraulic fluid/fuel sprayed onto equipment hot surfaces, and heat source. Two sources were unknown. At least one of the three mobile equipment hydraulic fluid/fuel fires became a large fire because of continuous flow of fluids from the pump due to engine shutoff failure. In this instance, the cab was suddenly engulfed in flames, probably due to the ignition of flammable vapors and mists that penetrated the cab.

During the first, third, fourth, and fifth periods, the largest number of fires were caused by flame cutting/welding spark/ slag/flame. During the second period, the largest number of fires were caused by flammable liquid/oil/refueling fuel on hot surfaces/explosion. During the sixth period, the largest number of fires were caused by flame cutting/welding spark/slag/flame, conveyor belt friction, and overheated oil.

#### Method of Detection

Table 49 shows the number of fires by method of detection for each time period. The most frequent methods were workers who saw smoke long after the fires had started, followed by welders who saw sparks and operators who saw the fires when they started as flames/flash fires. Other methods of detection were workers who saw smoke shortly after the fires had started, workers who heard an electric trip warning or an explosion, workers who saw a smoldering fire, and an operator who saw white smoke. Four fires were undetected.

During the first period, the largest number of fires were detected by workers as smoke long after the fires had started, by operators as flames/flash fires, and by welders as sparks. During the second, fourth, and fifth periods, the largest number of fires were detected by workers as smoke long after the fires had started. During the third period, the largest number of fires were detected by operators as flames/flash fires. During the sixth period, the largest number of fires were detected by workers as smoke.

## **Suppression Method**

Table 50 shows the number of fires by suppression method for each time period. The most common methods were water or portable fire extinguishers alone and manual techniques with or without portable fire extinguishers. None of the equipment involved in fires had machine fire suppression systems. Other suppression methods were portable fire extinguishers with foam, dry chemical powder, and water. On at least five occasions, including one mobile equipment fire, fire brigades and fire departments fought the fires with portable fire extinguishers together with foam, dry chemical, and water. However, six fires destroyed or heavily damaged equipment (including one piece of mobile equipment) because of failure of firefighting methods, late fire detection, undetected fires, or fire size.

During the first period, the largest number of fires were suppressed with water or portable fire extinguishers alone and manually with or without portable fire extinguishers. During the second period, the largest number of fires were suppressed with portable fire extinguishers alone. During the third through fifth periods, the largest number of fires were extinguished with water alone. During the sixth period, the largest number of fires were extinguished with water or portable fire extinguishers.

#### **Equipment Involved**

Table 51 shows the number of fires by equipment involved for each time period. The equipment most often involved was oxyfuel torches (at times electrical arc welding equipment was used). This was followed by dust collectors, air compressors, chutes, dryers, crushers, liquor and refueling pumps, and oil vaporizers. Other equipment included mobile equipment (trucks, dozers, loaders, shovels, and forklifts), beltlines, and electrical breakers, cathodes, and fixtures. Also involved in fires were facilities (considered equipment in this report), heaters, sample and chemical containers, a hydroprecipitator, kilns, product cooling systems, and maintenance equipment.

During the first, third, fourth, and fifth periods, the largest number of fires involved oxyfuel torches. During the second period, the largest number of fires involved oxyfuel torches, mobile equipment, dust collectors, air compressors, chutes, crushers, and dryers. During the sixth period, the largest number of fires involved oxyfuel torches and dust collectors.

#### Location

Table 52 shows the number of fires by location for each time period. The most common locations were flame cutting/welding areas, beltline areas, and maintenance areas. Other fire locations included dust collectors, air compressors, chutes, crushers, dryers, pelletizer building, baghouse, refinery, liquor pump areas, storage silos, product cooling areas, boiler rooms, power houses, and chemical storage areas. Mobile equipment working areas (haulage, loading, and mining areas), facility and elevator shaft, and a lab and shop were also affected by the fires. During the first through fifth periods, the largest number of fires occurred at flame cutting/welding areas. During the sixth period, the largest number of fires occurred at flame cutting/welding areas, dust collectors, and maintenance areas.

#### **Burning Materials**

Table 53 shows the number of fires by burning material for each time period. The materials most often involved were oxyfuel/clothing/grease and other materials (including liquor pumps, belt material, pipelines, dust collector and chute liners, flammable liquids, wood pallets, crusher and screen panel). This was followed by belt and hot materials, flammable liquids, refueling fuel, and vaporized oil. Other burning materials included electrical wires and cables, facilities and their contents, and oil, chemicals, refuse, and core samples. Dust collector and chute liners, pipeline and crusher materials, equipment mechanical components, and hydraulic fluid/fuel were also involved in the fires.

During the first, third, fourth, and fifth periods, the largest number of fires involved oxyfuel/clothing/grease and other materials. During the second period, the largest number of fires involved oxyfuel and flammable liquids, refueling fuel, and vaporized oil. During the sixth period, the largest number of fires involved oxyfuel, flammable liquids, and facilities and their content.

## **Fire Injuries**

Table 54 shows the number of fire injuries per number of fires causing injuries and total fires by year, ignition source, equipment involved, and location for 1990–2001. Overall, there were 41 injuries and 1 fatality caused by 37 fires.

The greatest number of fire injuries occurred in 1990 (eight injuries caused by eight fires) and 1994 (seven injuries and one

fatality caused by six fires). The ignition sources that caused the injuries were flame cutting/welding spark/slag/flame, flammable liquid/refueling fuel on hot surfaces/explosion, and hot material. Other ignition sources were chemical ignition, electrical short/ arcing, overheated oil, conveyor belt friction, heat source, and hydraulic fluid/fuel spraved onto equipment hot surfaces. The equipment involved in fire injuries included oxyfuel torches, maintenance equipment, refueling and liquor pumps, and product cooling systems. Other equipment included chemical containers, electrical systems, air compressors, mobile equipment, heaters, and beltline. The location where most of the fire injuries occurred were the flame cutting/welding areas, maintenance areas, pump housing, liquor pump and refinery areas, and product cooling area. Other fire locations were lab and storage areas, crusher and pelletizer building, beltline, maintenance areas, and mobile equipment working areas.

A fatality occurred in Nevada [MSHA 1994e]. The victim, equipped with firefighting gear and self-contained breathing apparatus, was fighting a refinery electrical fire. The victim was found unconscious on the floor.




Figure 16.—Number of fires and fire injuries for metal/nonmetal mills by state, 1990–2001.




Figure 17.—Number of fires, fire injuries, risk rates, and employees' working hours for metal/nonmetal mills by time period, 1990–2001.




Figure 18.—Major variables for metal/nonmetal mill fires, 1990–2001. (FE = portable fire extinguisher)

## **STONE MILL FIRES**

Table 55 and figure 19 show the number of fires and fire injuries for stone mills by state during 1990–2001. Table 55 also shows the injury risk rates, employees' working hours, and lost workdays. In all, 118 fires occurred in 33 states. Seventy-six of the fires caused 82 injuries (including 8 fires and 6 injuries involving contractors). The yearly average was 9.8 fires and 6.8 injuries. The Ewhr value was  $873 \times 10^6$  hr (Irr = 0.019), and the LWD value was 1,911. Missouri had the most fires (16 fires and 9 injuries), followed by Pennsylvania (15 fires and 14 injuries), Michigan (9 fires and 5 injuries), and Virginia (7 fires and 5 injuries). Of these states, Virginia had the highest injury risk rate value (Irr = 0.091).





Figure 20.—Number of fires, fire injuries, risk rates, and employees' working hours for stone mills by time period, 1990–2001.

Table 56, partly illustrated in figure 20, shows the number of fires, fire injuries, risk rates, employees' working hours, and lost workdays by time period. The number of fires and fire injuries decreased during most of the periods, with a sharp increase during the last period. The number of employees' working hours increased throughout the periods. The Irr values follow patterns similar to those shown by the injury values.

Tables 57–63 show the number of fires by ignition source, method of detection and suppression, equipment involved, location, and burning material by time period. Figure 21 shows the major variables related to fires for 1990–2001. Table 63 shows the fire injuries per number of fires causing injuries and total fires by year, ignition source, equipment involved, and location.

#### **Ignition Source**

Table 57 shows the number of fires and fire injuries by ignition source for each time period. The leading sources were flame cutting/welding spark/slag/flame (53 fires or 45%), hot material (24 fires or 20%), and electrical short/arcing (11 fires or 9%). Other ignition sources were refueling fuel/flammable liquid/gas on hot surfaces/collision, heat source, hydraulic fluid/fuel sprayed onto equipment hot surfaces, conveyor belt friction, and overheated oil. One ignition source was unknown. At least four of the five mobile equipment hydraulic fluid/fuel fires became large fires because of the continuous flow of fluids from the pumps due to engine shutoff failure, difficulty in activating available emergency systems at ground level, lack of an emergency line drainage system, or lack of effective and rapid local firefighting response capabilities. In at least one instance, the cab was suddenly engulfed in flames, probably due to the ignition of flammable vapors and mists that penetrated the cab. Of note is that the hydraulic fluid fires subsequently involved the fuel system.

During the first, second, and fourth periods, the largest number of fires were caused by flame cutting/welding spark/slag/flame. During the third and sixth periods, the largest number of fires were caused by hot material. During the fifth period, the largest number of fires were caused by hot material and electrical short/arcing.

## **Method of Detection**

Table 58 shows the number of fires by method of detection for each time period. The most frequent methods were welders who saw sparks, workers who saw smoke shortly and long after the fires had started, and operators who saw the fires when they started as flames/flash fires. Other methods of detection were workers who heard an explosion and workers who saw a glow or a smoldering fire. Six fires were undetected. The hot material fires were detected long after they had started due to lack of combustion smoke/gas detection systems.

During the first, second, and fourth periods, the largest number of fires were detected by welders as sparks. During the third and fifth periods, the largest number of fires were detected by workers as smoke long after the fires had started. During the sixth period, the largest number of fires were detected by operators as flames/flash fires.

## **Suppression Method**

Table 59 shows the number of fires by suppression method for each time period. The most common methods were manual techniques with or without portable fire extinguishers, followed by water or portable fire extinguishers alone. Other suppression methods were portable fire extinguishers with foam, dry chemical powder, and water. One piece of mobile equipment involved in a fire had a machine fire suppression system, whose activation together with the engine shutoff system succeeded in temporarily abating the fire.

In at least 11 instances, including 2 mobiles equipment fires, fire brigades and fire departments fought the fires with portable fire extinguishers together with foam, dry chemical powder, and water. However, seven fires destroyed or heavily damaged equipment (including one piece of mobile equipment) because of failure of firefighting methods, late fire detection, undetected fires, or fire size.

During the first, second, and fourth periods, the largest number of fires were suppressed manually with or without portable fire extinguishers. During the third period, the largest number of fires were suppressed manually with or without portable fire extinguishers or water alone. During the fifth period, the largest number of fires were extinguished with water alone. During the sixth period, the largest number of fires were extinguished with water alone and portable fire extinguishers with foam, dry chemical powder, and water.

## **Equipment Involved**

Table 60 shows the number of fires by equipment involved for each time period. The equipment most often involved were oxyfuel torches (at times electrical arc welding equipment was used), followed by kilns, preheat and cooling systems, and mobile equipment (loaders, trucks, drills, and locomotives). Other equipment included electrical systems, heaters, barrels, refueling pumps, beltlines, chutes, crushers, waste fuel tanks, dust collectors, and storage bins. Maintenance equipment and facilities (considered equipment in this report) were also involved in the fires.

During the first through fourth periods, the largest number of fires involved oxyfuel torches. During the fifth period, the largest number of fires involved electrical systems. During the sixth period, the largest number of fires involved oxyfuel torches, kilns, and preheat and cooling systems.

#### Location

Table 61 shows the number of fires by location for each time period. The most common locations were flame cutting/welding areas (at hopper, crusher, elevator shaft, chute and kiln areas, and maintenance areas). This was followed by kilns, hoppers, chutes, storage silo areas, mobile equipment working areas (shop and crusher areas, drilling, loading, haulage, transportation, and fuel preparation room), and beltline areas. Other fire locations included maintenance areas, pump and bagging stations, preheat and cooling areas, pit and bin areas, waste fuel areas, electrical control rooms, shops, and substation areas. Dust collector, crusher, chute, and facility areas were also affected by the fires.

During the first, second, and fourth periods, the largest number of fires occurred at flame cutting/welding areas. During the third period, the largest number of fires occurred at flame cutting/welding areas, kilns, chutes, hoppers, and storage silo areas. During the fifth period, the largest number of fires occurred at beltline areas. During the sixth period, the largest number of fires occurred at kiln areas.


## **Burning Materials**

Table 62 shows the number of fires by burning material for each time period. The materials most often involved were oxyfuels/ clothing/grease and other materials (including rubber hoses, pipelines, dust collector and chute liners, and shaft and kiln materials). This was followed by belt and kiln/clinker hot materials, flammable liquids/oil/refueling fuel, electrical wires/ cables/ transformers/ batteries, and rubber tires/refuse/waste fuel. Other materials involved in fires were hydraulic fluid/fuel, chute and dust collector liners and hoppers, and facilities and their content.

During the first, second, and fourth periods, the largest number of fires involved oxyfuel/clothing/grease and other materials. During the third period, the largest number of fires involved oxyfuel and belt and kiln/clinker hot materials. During the sixth period, the largest number of fires involved oxyfuel and flammable liquids, oil, and refueling fuel.

## **Fire Injuries**

Table 63 shows the number of fire injuries per number of fires causing injuries and total fires by year, ignition source,

equipment involved, and location for 1990-2001. Overall, there were 82 injuries caused by 76 fires. The greatest number of fire injuries occurred in 1990 (15 injuries caused by 15 fires). The ignition sources that caused most of the fire injuries were flame cutting/welding spark/slag/flame, hot material, and flammable liquid/refueling fuel on hot surfaces. Other ignition sources were heat source, hydraulic fluid/fuel sprayed onto equipment hot surfaces, mechanical friction, and electrical short/arcing. The equipment involved in fire injuries included oxyfuel torches,

kilns, beltlines, chutes, refueling pumps, and maintenance equipment. Other equipment included heaters, mobile equipment, maintenance equipment, kiln, and electrical systems. The locations where the fire injuries occurred were flame cutting/ welding areas, beltlines, kiln and chute areas, and maintenance areas, followed by mobile equipment working areas and transportation areas. Other fire locations were pump stations and beltline areas.

## SUMMARY OF MAJOR FIRE AND FIRE INJURY FINDINGS FOR ALL METAL/NONMETAL MINING CATEGORIES




Figure 22.—Number of fires, fire injuries, risk rates, and employees' working hours for all metal/nonmetal mining categories by time period, 1990–2001.

The major fire and fire injury findings for all metal/nonmetal mining categories for 1990–2001 are shown in tables 64–65. Table 66, partly illustrated in figure 22, shows the number of fires, fire injuries, fire fatalities, risk rates, employees' working hours, and lost workdays for all metal/nonmetal mining categories by time period.

For all metal/nonmetal operations (including stone and sand and gravel), a total of 518 fires occurred during 1990–2001; 296 of those fires caused 308 injuries and 4 fatalities (Ewhr =  $4,012 \times 10^6$  hr, Irr = 0.015, LWD = 36,204). Thirty fires and 26 injuries involved contractors. The greatest number of fires and fire injuries occurred at surface operations; the highest risk rate values were also calculated for surface operations. The number of fires increased during the first four 2-year time periods (1990–1991, 1992–1993, 1994–1995, and 1996–1997), then decreased during the last two periods (1998–1999 and 2000–2001). The number of injuries showed a decrease throughout the periods, accompanied by an increase in employees' working hours.

Twenty-five firefighting interventions by mine rescue teams in underground mines and at least 30 interventions at surface operations were required to combat these fires. However, 45 fires destroyed or heavily damaged facilities and equipment (including 19 pieces of mobile equipment) because of failure of firefighting methods, late fire detection, undetected fires, or fire size. Ninety-seven fires were detected late, and 30 fires were undetected.

The ignition sources that caused the greatest number of fires were flame cutting/welding spark/slag/flame (169 fires or 33% with 137 injuries), hydraulic fluid/fuel sprayed onto equipment hot surfaces (89 fires or 17% with 46 injuries and 3 fatalities), heat source/explosion and flammable liquids/ gas/refueling fuel on hot surfaces (98 fires or 19% with 73 injuries), electrical short/arcing (51 fires or 10% with 16 injuries), and spontaneous combustion/hot material (46 fires or 9% with 17 injuries).

The flame cutting/welding spark/slag/flame source caused fires usually involving welders' clothing or oxyfuel/grease and other materials (including chute and dust collector liners, flammable liquids, belt material, crusher, hopper and shaker deck materials, washer plants, equipment mechanical components, stampler breaker, hydraulic fluid, rubber tires and hoses, gear boxes, bin feeder, dump rope cables, screen liner and screen panel, kiln and shaft material, pipelines, liquor pumps, wood pallets, electrical junction boxes, handrails, grease, refuse, shop and wood). The spontaneous combustion/hot material and electrical fires were usually detected late due to lack of combustion gas/smoke detection systems. At least 55 of the 89 mobile equipment hydraulic fluid/fuel fires became large fires (requiring 12 mine rescue team interventions in underground mines and at least 6 interventions at surface operations) because of the continuous flow of fluid/fuel from the pumps due to engine shutoff failure, lack of an emergency hydraulic line drainage system, difficulty in activating available emergency systems at the ground level, or lack of effective and rapid local firefighting response capabilities. Ten pieces of mobile equipment involved in fires had machine fire suppression systems. Dual activations (two activations) of machine fire suppression and engine shutoff systems succeeded in temporarily abating the fires, which reignited, fueled by the flow of pressurized fluids entrapped in the lines. In at least 13 instances the cab was suddenly engulfed in flames, forcing the operators to make an unsafe exit, probably due to the ignition of flammable vapors and mists that penetrated the cab. Of note is that the hydraulic fluid fires subsequently involved the fuel system.

The major findings for each metal/nonmetal mining category are discussed below.

1. In underground metal/nonmetal and stone mines, 65 fires occurred; 6 of the fires caused 9 injuries (Ewhr =  $260 \times 10^6$  hr, Irr = 0.007, LWD = 83). The leading ignition sources were hydraulic fluid/fuel sprayed onto equipment hot surfaces

(16 fires or 25%), flame cutting/welding spark/slag/flame (13 fires or 20%), and electrical short/arcing (12 fires or 19%). The flame cutting/welding spark/slag/flame source caused fires involving oxyfuel/clothing/grease and other materials (including rubber tires and hoses, hydraulic fluid, shop, refuse, wood, chute liner, and shaft material). The electrical fires were usually detected long after the fires had started due to lack of combustion gas/smoke detection systems. Thirteen of the 16 mobile equipment hydraulic fluid/fuel fires became large fires (requiring 12 mine rescue team interventions) because of the continuous flow of fluids from the pumps due to engine shutoff failure, lack of an emergency hydraulic line drainage system, difficulty in activating available emergency systems at ground level, or lack of effective and rapid local firefighting response capabilities. In two instances during these fires, the cab was suddenly engulfed in flames, probably due to the ignition of flammable vapors and mists that penetrated the cab. Four pieces of equipment involved in fires had machine fire suppression systems. Dual activations (two activations) of machine fire suppression and engine shutoff systems succeeded in temporarily abating the fires; however, the flames reignited, fueled by the pressurized fluids entrapped in the lines.

Upon mine/section evacuation (required 30 times), mine rescue teams (required 25 times), often hindered by dense smoke in reaching the fire location, fought the fires (including 12 mobile equipment fires) with dry chemical powder, rock dust, and water; in one instance, foam was also used. However, five fires destroyed or heavily damaged equipment (including four pieces of mobile equipment) because of failure of firefighting methods, late fire detection, undetected fires, or fire size. Eighteen fires were detected late, and two were undetected.

The ignition sources that caused the underground fire injuries were hydraulic fluid/fuel sprayed onto equipment hot surfaces, flame cutting/welding spark/slag/flame, and overheated oil. The equipment involved in fire injuries included mobile equipment, oxyfuel torches, and air compressors. The locations where fire injuries occurred were mobile equipment working areas, flame cutting/welding areas, and mine face and panel section.

2. At surface of underground metal/nonmetal and stone mines, 12 fires occurred; 5 of the fires caused 5 injuries (Ewhr

=  $58 \times 10^6$  hr, Irr = 0.017, LWD = 75). The leading ignition source was flame cutting/welding spark/slag/flame (7 fires or 58%), followed by electrical short/arcing and heat source. The flame cutting/welding spark/slag/flame source caused fires involving oxyfuel/clothing/grease and other materials (including electrical junction boxes, handrails, grease, flammable liquids, rubber tires, and equipment mechanical components). In all, three fires destroyed or heavily damaged equipment. Two fires were detected late, and three fires were undetected. The ignition source that caused the fire injuries was flame cutting/welding spark/slag/flame.

3. At surface metal/nonmetal mines, 79 fires occurred; 45 of the fires caused 44 injuries and 2 fatalities (Ewhr =  $546 \times 10^6$  hr, Irr = 0.016, LWD = 13,134). The leading ignition source was hydraulic fluid/fuel sprayed onto equipment hot surfaces (35 fires or 44%), followed by flame cutting/welding spark/ slag/flame (13 fires or 17%) and electrical short/arcing (8 fires or 10%). The flame cutting/welding spark/slag/flame source caused fires involving oxyfuel/clothing/grease and other

materials (involving rubber hoses, grease, equipment mechanical components, dump rope cables, screen liner, and shaft materials). Twenty-two of the 35 mobile equipment hydraulic fluid/ fuel fires became large fires because of the continuous flow of fluid/fuel from the pumps due to engine shutoff failure, lack of an emergency line drainage system, difficulty in activating available emergency systems at ground level, or lack of effective and rapid local firefighting response capabilities. In at least five instances the cab was suddenly engulfed in flames, probably due to the ignition of flammable vapors and mists that penetrated the cabs. Five pieces of mobile equipment involved in fires had machine fire suppression systems. Dual activation (one activation) of machine fire suppression and engine shutoff systems succeeded in temporarily abating the fires; however, the flames reignited, fueled by the flow of fluids entrapped in the lines.

In at least five instances, including one mobile equipment fire, fire brigades and fire departments fought the fires with foam, dry chemical powder, and water. However, nine fires destroyed or heavily damaged equipment (including seven pieces of mobile equipment) because of failure of firefighting methods, late fire detection, undetected fires, or fire size. Eight fires were detected late, and three fires were undetected.

The ignition sources that caused most of the fire injuries were hydraulic fluid/fuel sprayed onto equipment hot surfaces, flame cutting/welding spark/slag/flame, and flammable liquid/refueling fuel/oil on hot surfaces. The equipment most often involved in fire injuries included mobile equipment, oxyfuel torches, and maintenance equipment. The locations where most of the fire injuries occurred were mobile equipment working areas, flame cutting/ welding areas, and maintenance areas.

4. At surface sand and gravel mines, 70 fires occurred; 59 of the fires caused 60 injuries (Ewhr =  $741 \times 10^6$  hr, Irr = 0.016, LWD = 6,921). The leading ignition sources were flame cutting/ welding spark/slag/flame (29 fires or 41%), heat source/explosion (15 fires or 21%), and hydraulic fluid/fuel sprayed onto equipment hot surfaces (14 fires or 20%). The flame cutting/welding spark/ slag/flame source caused fires involving oxyfuel/clothing/ grease and other materials (including chute liners, washer plant, crusher, hopper and shaker deck, flammable liquids, equipment mechanical components, and belt materials). Five of the 14 mobile equipment hydraulic fluid/fuel fires became large fires because of the continuous flow of fluid/fuel from the pumps due to engine shutoff failure, lack of an emergency line drainage system, difficulty in activating available emergency systems at ground level, or lack of effective and rapid local fire response capabilities. In two instances the cab was suddenly engulfed in flames, probably due to the ignition of flammable vapors and mists that penetrated the cab. None of the equipment involved in fires had machine fire suppression systems.

On at least three occasions, including one mobile equipment fire, fire brigades and fire departments fought the fires with foam, dry chemical powder, and water. However, four fires destroyed or heavily damaged equipment (including two pieces of mobile equipment) because of failure of firefighting methods, late fire detection, undetected fires, or fire size. Eight fires were detected late, and four fires were undetected. The ignition sources that caused most of the fire injuries were flame cutting/welding spark/slag/flame, heat source, and hydraulic fluid/fuel sprayed onto equipment hot surfaces. The equipment most often involved in fire injuries included oxyfuel torches, heaters, and mobile equipment. The locations where most of the fire injuries occurred were flame cutting/welding areas, maintenance areas, and mobile equipment working areas.

5. At surface stone mines, 97 fires occurred; 68 of the fires caused 67 injuries and 1 fatality (Ewhr =  $689 \times 10^6$  hr, Irr = 0.02, LWD = 7,399). The leading ignition sources were flame cutting/ welding spark/slag/flame (25 fires or 26%), heat source/explosion-flammable liquid/gas (24 fire or 25%), and hydraulic fluid/fuel sprayed onto equipment hot surfaces (16 fires or 17%). The flame cutting/welding spark/slag/flame source caused fires involving oxyfuel/clothing/grease and other materials (including screen panel and chute liner, crusher and hopper, stampler breaker, rubber hoses, gear boxes, bin feeder, hydraulic fluid, and shaft material). None of the mobile equipment involved in fires had machine fire suppression systems. Ten of the 16 mobile equipment hydraulic fluid/fuel fires became large fires because of the continuous flow of fluid/fuel from the pumps due to engine shutoff failure, lack of an emergency line drainage system, or lack of effective and rapid local firefighting response capabilities. In two instances the cab was suddenly engulfed in flames, probably due to the ignition of flammable vapors and mists that penetrated the cab.

In at least six instances, including one mobile equipment fire, fire brigades and fire departments fought the fires with foam, dry chemical powder, and water. However, 12 fires destroyed or heavily damaged equipment (including four pieces of mobile equipment) because of failure of firefighting methods, late fire detection, undetected fires, or fire size. Four fires were detected late; eight were undetected fires.

The ignition sources that caused most of the fire injuries were flame cutting/welding spark/slag/flame, heat source, and hydraulic fluid/fuel sprayed onto equipment hot surfaces. The equipment most often involved in fire injuries included oxyfuel torches, heaters, and mobile equipment. The locations where most of the fire injuries occurred were flame cutting/welding areas, maintenance areas, refuse and fire pot areas, and mobile equipment working areas.

6. At metal/nonmetal mills, 77 fires occurred; 37 of the fires caused 41 injuries and 1 fatality (Ewhr =  $845 \times 10^6$  hr, Irr = 0.01, LWD = 6,681). The leading ignition sources were flame cutting/ welding spark/slag/flame (29 fires or 38%), hot material (12 fires or 16%), and flammable liquid/refueling fuel/oil on hot surfaces (9 fires or 12%). The flame cutting/welding spark/ slag/ flame source caused fires involving oxyfuel/clothing/grease and other materials (including liquor pumps, belt material, pipelines, flammable liquids, dust collector and chute liners, wood pallets, crusher, and screen panel). The hot material fires and electrical fires were usually detected long after they had started due to lack of combustion gas/smoke detection systems. One of the three mobile equipment hydraulic fluid/fuel fires became a large pump fire because of the continuous flow of fluid from the pump due

to engine shutoff failure. In this instance the cab was suddenly engulfed in flames, probably due to the ignition of flammable vapors and mists that penetrated the cab.

In at least five instances, including one mobile equipment fire, fire brigades and fire department fought the fires with foam, dry chemical powder, and water. However, six fires destroyed or heavily damaged equipment (including one piece of mobile equipment) because of failure of firefighting methods, late fire detection, undetected fires, or fire size. Twenty-six fires were detected late, and four were undetected.

The ignition sources that caused most of the fire injuries were flame cutting/welding spark/slag/flame, flammable liquids/ refueling fuel on hot surfaces/explosion, and hot material. The equipment involved in fire injuries included oxyfuel torches, maintenance equipment, refueling and liquor pumps, and product cooling system. The locations where the fire injuries occurred were flame cutting/welding areas, maintenance areas, pump housing and liquor pump areas, and product cooling area.

7. At stone mills, 118 fires occurred; 76 of the fires caused 82 injuries (Ewhr =  $873 \times 10^6$  hr, Irr = 0.019, LWD = 1,911). The leading ignition sources were flame cutting/welding spark/slag/flame (53 fires or 45%), hot material (24 fires or 20%), and electrical short/arcing (11 fires or 9%).

The flame cutting/welding spark/slag/flame source caused fires involving oxyfuel/clothing/grease and other materials (including rubber hoses, pipelines, dust collector and chute liners, and shaft and kiln materials). Four of the five hydraulic fluid/fuel fires became large fires because of the continuous flow of fluids from the pumps due to engine shutoff failure, lack of an emergency line drainage system, difficulty in activating emergency systems at ground level, or lack of effective and rapid local firefighting response capabilities. In one instance the cab was suddenly engulfed in flames, probably due to the ignition of flammable vapors and mists that penetrated the cab. Of the six pieces of mobile equipment involved in fires, one had a machine fire suppression system, which, upon activation with the engine shutoff system, succeeded in temporarily abating the fire.

In at least 11 instances, including 2 mobile equipment fires, fire brigades and fire departments fought the fires with foam, dry chemical powder, and water. In two instances, emergency foam fire suppression systems were used. However, seven fires destroyed or heavily damaged equipment (including one piece of mobile equipment) because of failure of firefighting methods. Thirty-one fires were detected late, and six fires were undetected.

The ignition sources that caused most of the fire injuries were flame cutting/welding spark/slag/flame, hot material, and flammable liquid/gas/refueling fuel on hot surfaces. The equipment most often involved in fires included oxyfuel torches, kilns, beltlines, chute, preheat system, and maintenance equipment. Most of the fire injuries occurred at flame cutting/ welding areas, kiln, beltline and chute areas, preheat areas, and maintenance areas.

## CONCLUSIONS

During 1990–2001, a total of 518 fires occurred in all metal/ nonmetal mining categories; 296 of those fires caused 308 injuries and 4 fatalities. Surface operations had the most fires and the highest injury risk rate values. Forty-five fires destroyed or heavily damaged facilities and equipment (including 19 pieces of mobile equipment) because of failure of firefighting methods, late fire detection, undetected fires, or fire size.

In the future, many of these fires and injuries might be prevented or detected and extinguished at their earliest stage by improving current fire safety procedures, adopting existing/ improved fire detection and suppression technologies, and/or developing new technologies. Several strategies for reducing and/or preventing the number of fires and fire injuries follow.

1. Increase vigilance, improve safety procedures, and develop new technologies in order to prevent fires and injuries caused by flame cutting and welding operations.

2. Improve equipment hydraulic/fuel/electrical systems inspection programs; adopt fire-resistant hydraulic fluids and electrically powered motors for use in underground mines; develop new technologies (equipment/cab rapid fire detection/ prevention/suppression systems, emergency line drainage systems, and fire barriers); adopt an optimal ground level location for the activation of emergency systems; improve operator's fire preparedness training programs; and develop effective and rapid local firefighting response capabilities.

3. Adopt existing/improved systems for continuous and early detection of combustion gases and smoke along beltlines.

4. Adopt existing/improved technologies for monitoring equipment (beltlines) operational functions.

5. Increase vigilance and adopt improved safety procedures for handling flammable liquids and refueling fuel in the vicinity of heat sources.
