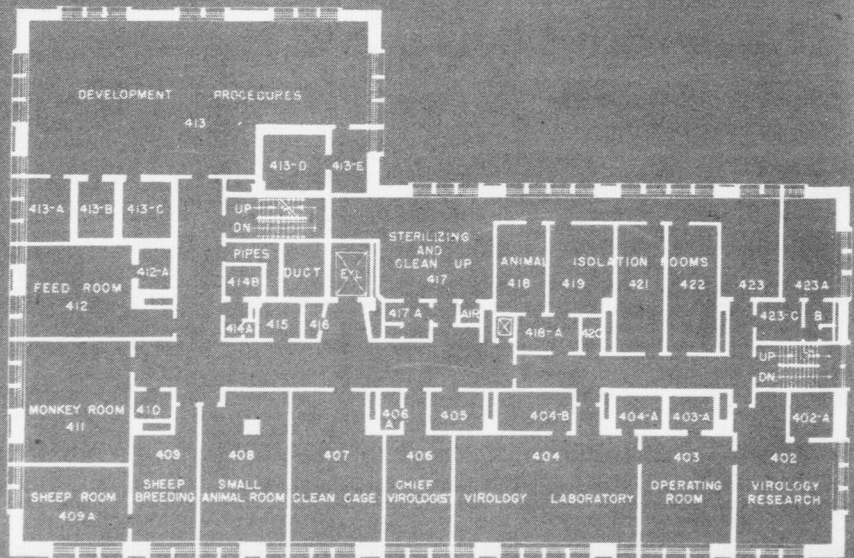


# Wisconsin State Laboratory of Hygiene

The new building for the Wisconsin State Laboratory of Hygiene, located on the campus of the University of Wisconsin at Madison, forms an integral part of the University Medical Center. All the various laboratories of the Wisconsin State Board of Health, which were formerly located in several campus buildings, are now housed under one roof. All laboratory services are departmentalized.

Dr. W. D. Stovall, past president of the Wisconsin State Medical Society, is director of the laboratory, with which he has been associated since 1913 and which was first established in 1903 when bacteriology was still a new-born science. The Wisconsin laboratory was one of the first laboratories in this country to provide clinical pathology services. The laboratory operates under a form of joint control by the Wisconsin State Board of Health and the University of Wisconsin.
