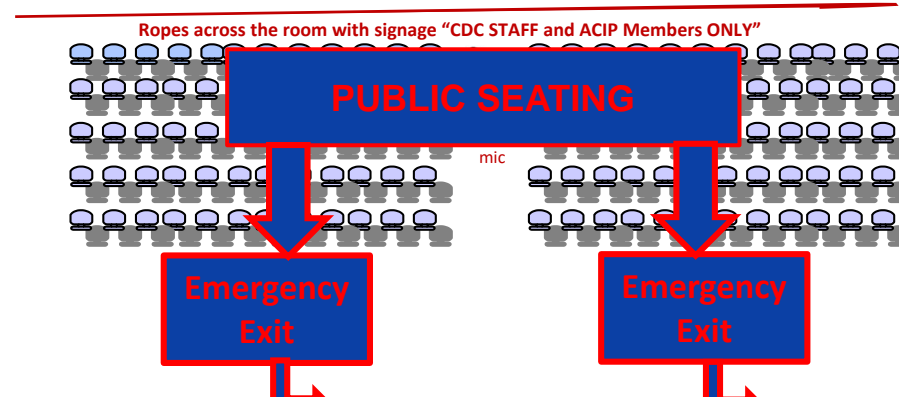
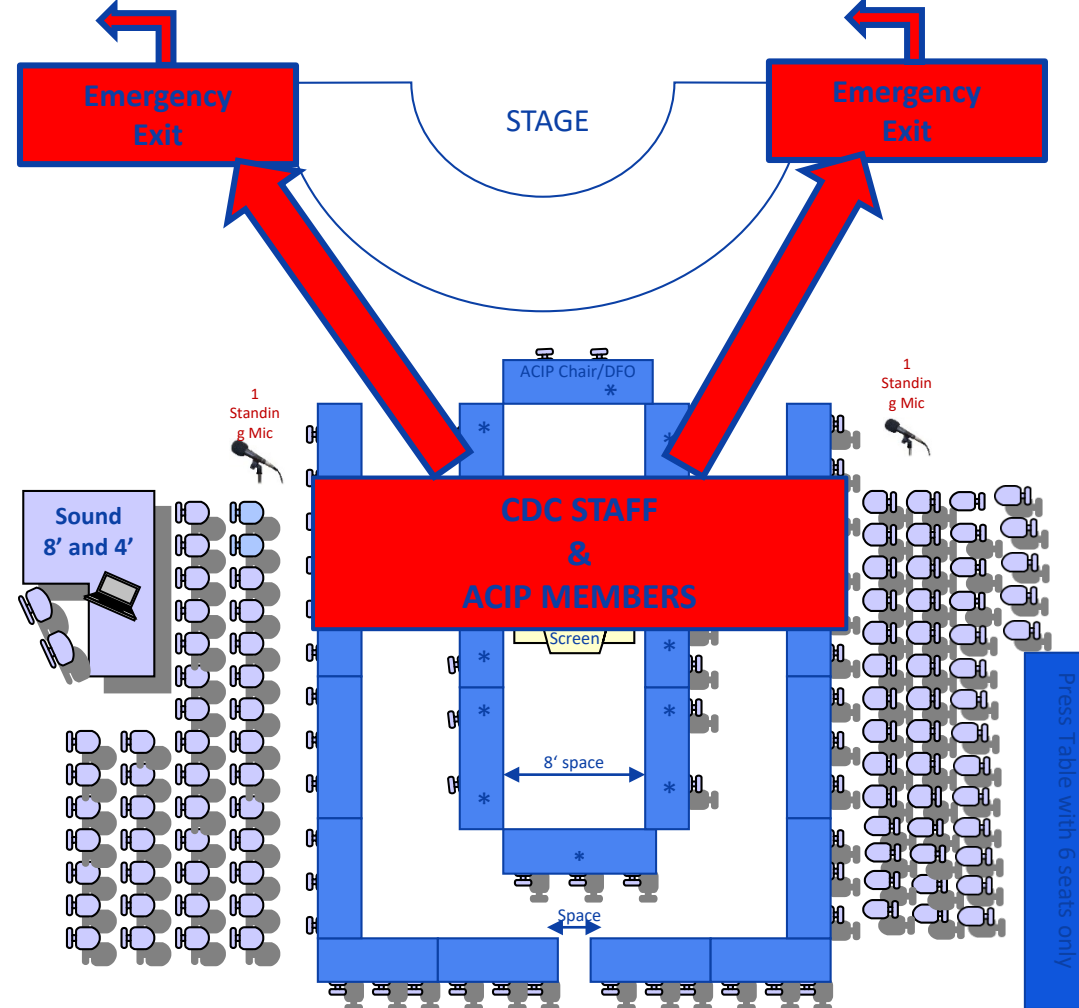
Meeting Materials

- Meeting minutes are posted on the ACIP website generally within 120 days of the meeting. Minutes from the February 2019 meeting will be posted shortly after this meeting.

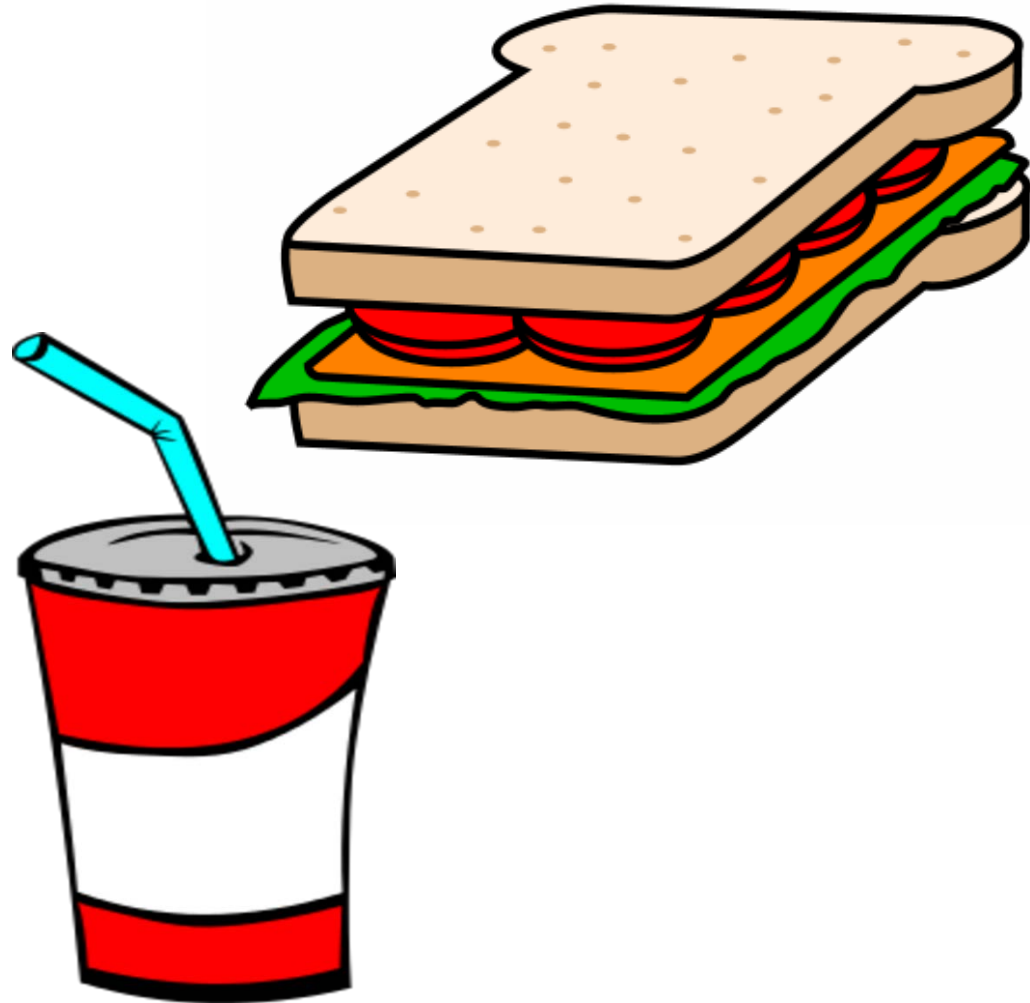
Safety Information

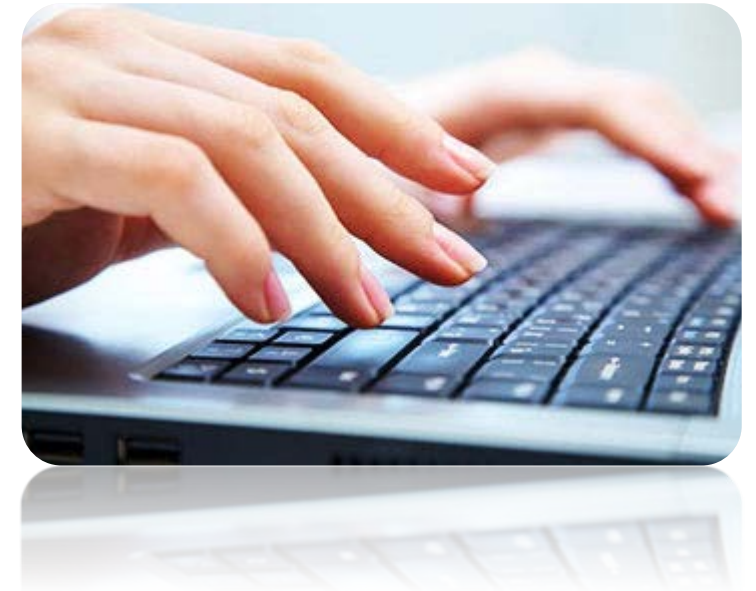
