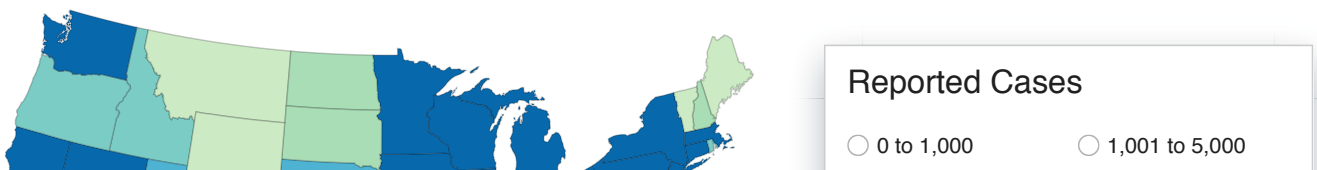

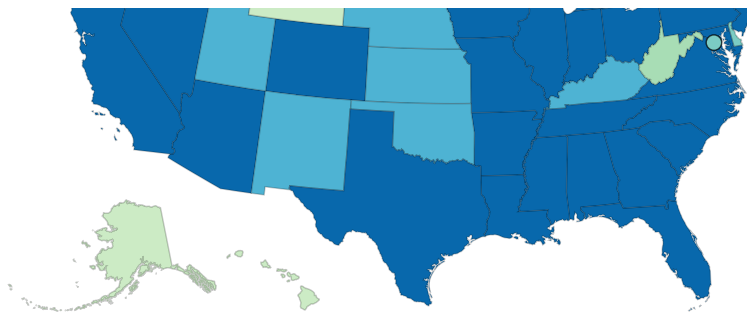

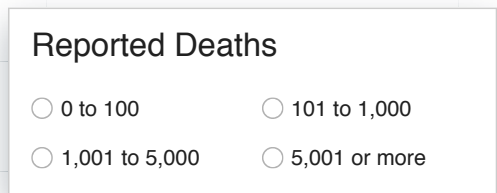

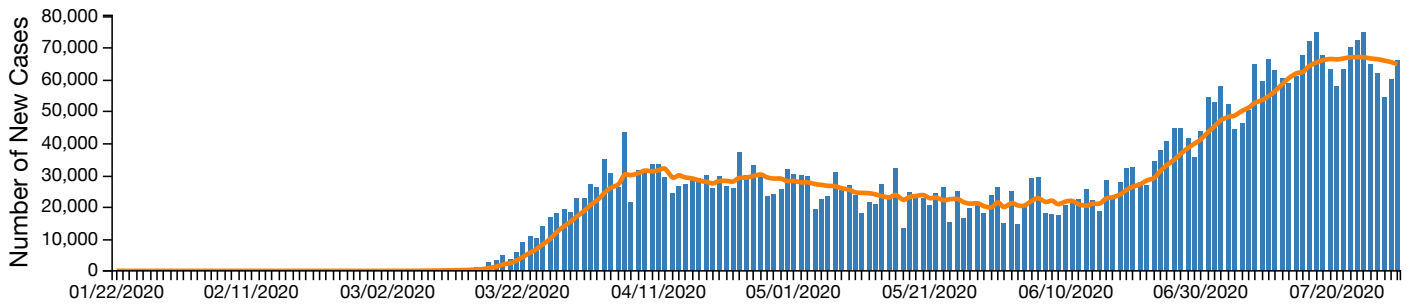

Cases & Deaths among Healthcare Personnel

Data were collected from 3,328,294 people, but healthcare personnel status was only available for 716,556 (21.5%) people. For the 116,721 cases of COVID-19 among healthcare personnel, death status was only available for 78,676 (67.4%).
