

Notice: Data for all diseases and conditions from Texas for 2019 and 2020 published in week 32 are incomplete, **except for the arboviral diseases, congenital syphilis, and tuberculosis**, due to a data processing issue at CDC.

Erratum: Data for *Haemophilus influenzae* in children < 5 years categorized as "non-b serotype" and "unknown serotype" (Table 1n) were updated on 02/26/2021 to correct the data associated with these two serotype categories. The original version of the tables incorrectly displayed data for "non-b serotype" in the "unknown serotype" column and incorrectly displayed data for "unknown serotype" in the "non-b serotype" column. The data are corrected now.

Max: Maximum — Maximum case count during the previous 52 weeks.

\* Case counts for reporting years 2019 and 2020 are provisional and subject to change. Cases are assigned to the reporting jurisdiction submitting the case to NNDSS, if the case's country of usual residence is the U.S., a U.S. territory, unknown, or null (i.e. country not reported); otherwise, the case is assigned to the 'Non-U.S. Residents' category. Country of usual residence is currently not reported by all jurisdictions or for all conditions. - These are **weekly** cases of selected infectious national notifiable diseases, from the National Notifiable Diseases Surveillance System (NNDSS). NNDSS data reported by the 50 states, New York City, the District of Columbia, and the U.S. territories are collated and published weekly as numbered tables. Cases reported by state health departments to CDC for weekly publication are subject to ongoing revision of information and delayed reporting. Therefore, numbers listed in later weeks may reflect changes made to these counts as additional information becomes available. Case counts in the tables are presented as *published* each week.
